If you do not live in Wisconsin but your driving privilege is suspended or revoked in Wisconsin:

- You must reinstate your Wisconsin driving privilege before you will be eligible for licensing in another state, and
- You are required to pay a [reinstatement fee](#) to reinstate your driving privilege in Wisconsin

Reinstate online

You may be able to use our online application to reinstate your driving privilege.

- If you are eligible for online reinstatement, you are required to pay the reinstatement fee using a credit or debit card

Reinstate by mail

- If you are not able to reinstate using the online application, you need to mail your reinstatement fee, payable by check or money order (do not send cash) to:

- Be sure to include your full name, date of birth, Social Security Number and current address
