Pest Abatement Order

(Wis. Stat. § 93.18, 94.76, 94.02, 94.76, Wis. Admin. Code ATCP § 21.03(2))

You (the person named below) are hereby notified that the Department of Agriculture, Trade and Consumer Protection has reason to believe you own or are in charge of premises where pests or pest-harboring materials have been found. Pursuant to sec. 94.02(1), Wis. Stats. and ATCP 21.03(2), you must treat, remove, or destroy infested or infected plants, host plants, or other pest-harboring materials that constitute a hazard to plant or animal life in this state. A pest abatement order under this section may require the destruction or removal of bees, bee pests, colonies or bee apparatus.

If you do not comply with this order, the Department may refer you to the circuit court under sec. 93.21(3), Wis. Stats. In addition, under sec. 94.02(2), Wis. Stats., the Department or a cooperating local unit of government may (1) treat your premises or (2) treat or destroy the infested or infected plants or other material and have the cost of this abatement added to your property taxes as a special assessment for services rendered.
