STATEMENT OF PURPOSE

As an aid in treatment of coccidiosis caused by Eimeria bovis and E. zuernii in calves.

ACTIVE DRUG INGREDIENT

Amprolium

5113.64 grams/ton 2556.82 milligrams/lb.

0.56 %

USE DIRECTIONS

Use 10 pounds of 2.5% Type B per ton of feed to produce a Type C medicated feed containing 0.0125% amprolium. Use 1,000 pounds of 2.5% Type B per ton to produce a Type C medicated feed containing 1.25% amprolium.

Feed the resulting Type C medicated feed in amounts according to the chart below to provide 454mg amprolium/100 pounds of bodyweight per day for 5 days. Use on a herd basis only; when one or more calves show signs of coccidiosis, it is likely the rest of the group has been exposed and all calves in the group should be treated.
