

PESTICIDES

During a typical Agricultural Chemical Cleanup Program (ACCP) investigation, the Department of Agriculture, Trade and Consumer Protection will require at least one round of soil and groundwater samples to be analyzed for the pesticides on the following list. In addition, samples should be taken for other pesticides which are of concern for the site.

Acetochlor
Alachlor
Atrazine*
Butylate
Chlorpyrifos
Cyanazine
Dimethenamid
EPTC
Metolachlor
Metribuzin
Pendimethalin
Prometon
Propazine
Simazine
Trifluralin

*Includes de-ethyl atrazine and de-isopropyl atrazine for groundwater samples.

FERTILIZERS

In addition to the pesticides listed above, if a site is likely to have handled fertilizer, at least one round of soil and groundwater samples should be analyzed for nitrate + nitrite and ammonia + ammonium. Report nitrate + nitrite as nitrogen, and report ammonia + ammonium as nitrogen. Our agency requires a potassium chloride extraction for nitrogen in soils.

CERTIFIED LABORATORIES

The following labs have been certified by the Wisconsin Department of Natural Resources (DNR) to analyze the compounds specified on the analyte list. The labs have indicated they are willing to perform the analyses previously listed.
