This page is intended to provide Wisconsin residents with information regarding Federal Motor Carrier Safety Administration (FMCSA) regulatory updates that may affect current and future Commercial Driver's License (CDL) operators and Commercial driving organizations in Wisconsin.

Entry Level Driver Training (ELDT)

FMCSA Rule, 49 CFR 380, requires the following applicants to have successfully completed Entry-Level Driver Training (including theory and behind-the-wheel (BTW) instruction) at a training provider/training entity listed on the Agency's Training Provider Registry (TPR).

New drivers

- Adding Passenger Endorsement ("P")
- Class Upgrades (Class B to Class A)
- Adding School Bus Endorsement ("S")
- Adding Hazardous Materials Endorsement ("H")

Drivers who hold a valid Class A or Class B CDL, or a Passenger (P), School Bus (S), or Hazardous Materials (H) endorsement, issued before February 7, 2022, will not be required to comply with this subpart pertaining to their CDL or endorsement.

Individuals who obtain a CLP before February 7, 2022, are not required to comply with this subpart if they obtain a CDL before the CLP or renewed CLP expires.

ELDT Compliance Date

Wisconsin DOT has received official notice that Federal Regulation 49 CFR 380, which contains Entry Level Driver Training (ELDT) Requirements, has extended its compliance date from February 7th, 2020 to February 7th, 2022.

In conformity with the extension of the compliance date, Wisconsin DOT will also not require Entry Level Driver Training requirements to be implemented prior to February 7th, 2022.

Drug and Alcohol Clearinghouse (DACH)

The Federal Motor Carrier Administration (FMCSA) established the Commercial Driver's License (CDL) Drug and Alcohol Clearinghouse (Clearinghouse). This new database contains information pertaining to violations of the U.S. Department of Transportation (DOT) controlled substances (drug) and alcohol testing program for holders of CDLs.

The Clearinghouse rule requires FMCSA-regulated employers, medical review officers (MROs), substance abuse professionals (SAPs), consortia/third party administrators (C/TPAs), and other service agents to report to the Clearinghouse information related to violations of the drug and alcohol regulations in 49 Code of Federal Regulations, Parts 40 and 382 by current and prospective employees.

The Clearinghouse final rule requires the following:

- Employers must query the Clearinghouse for current and prospective employees' drug and alcohol violations before permitting those employees to operate a commercial motor vehicle (CMV) on public roads.
- Employers must annually query the Clearinghouse for each driver they currently employ.
