

## NOTICE OF PUBLIC HEARING

### PI 34 EDUCATOR LICENSES

**NOTICE IS HEREBY GIVEN** that pursuant to s. 115.28 (7) (a) and (c), Stats.; and interpreting s. 115.28 (7) (a) and (c), Stats., the Department of Public Instruction will hold a public hearing as required under s. 227.24 (4), Stats., to consider the promulgation of an emergency rule amending PI 34 relating to changes to PI 34 as a result of 2019 Wisconsin Act 44.

This emergency rule seeks to implement provisions under Clearinghouse Rule 20-005, which is pending at the filing of this rule. The emergency rule makes changes to ch. PI 34 to conform the rule to changes in statute as a result of 2019 Wisconsin Act 44, including rules around what constitutes satisfactory completion of a course of study that a special education teacher may complete as an alternative to the Foundations of Reading Test (FORT), as necessitated by the coronavirus disease (“COVID-19”) emergency.

The Department will hold the public hearing at the time shown below via teleconference due to the restrictions adopted during the COVID-19 emergency declaration established for Dane County. The hearing will be held as follows:
