Guidance Document Title: Warning Notice of Reinspection for Grade A Milk Producers

Updated Notice of Reinspection Procedure - Plain Language Explanation:

In the past, a notice of reinspection was issued if an inspection report noted double debits or found 6 or more non-key violations. The agency's data show that most of the reinspections stemming from the findings of 6 or more violations did not reflect a significant risk to the milk. It is well known that milk producers experience increased stress with the reinspection process. Under the new criteria, non-key violations will not trigger a notice of reinspection unless one or more of the violations are a repeat violation from a previous inspection, i.e. becomes a "double debit", or a combination of violations that create a **substantial risk** of milk adulteration (ATCP 65.01 (35) (c)). This combination of violations is known to be a less frequent trigger for a notice of reinspection. In most situations, the new criteria will give producers more time (3 to 12 months) to correct non-key violations.

Warning Notice of Reinspection for Grade A Milk Producers

Documents Required:

- 1. Milk Producer Farm Inspection (F-fd-011)
- 2. Notice of Reinspection (F-fd-077)

Background Information:

This document is used to provide a Grade A milk producer with the legally required prenotification that farm conditions are not in substantial compliance with ATCP 65, Subchapter II, Wisconsin Administrative Code.

A Warning Notice of Reinspection shall be issued whenever any of the following occurs, ATCP 65.920(5)4):

- A repeat violation (double debit) of any farm standard as determined on 2 consecutive routine inspections of a dairy farm.
- Any key violation as defined in section ATCP 65.01(35) Wis. Adm. Code, if the violation or combination of key violations creates a substantial risk of milk adulteration as determined by the sanitarian.
 - a) Key violations include:
 - 1. Unclean milk contact surfaces of equipment or utensils (46).
 - 2. Filthy conditions in a milking barn or parlor, such as several days' accumulation of manure in gutters or other areas (10).
 - 3. Filthy conditions in a cowyard that could reasonably be expected to result in milking animals having very dirty flanks, udders, and teats (12,70).
 - 4. Filthy conditions in a milkhouse (31, 32).
 - 5. Water supply, water pressure, or water heating facilities not in compliance withthis chapter (29, 30).
 - 6. No access to a toilet facility on the farm premises, or to a handwashing facility in the milkhouse (34, 63).
 - 7. Violation of well construction or potability of water supply, including anycross connection between potable and non-potable water sources (38, 39, 40).
 - 8. Lack of an approved sanitizer in the milkhouse or adjacent storage areas that could be used to meet the sanitizing requirements under s. ATCP 65.12 (5) (47).
 - 9. Visibly dirty udders and teats on milking animals being milked (54).
 - 10. Milk not cooled in compliance with s. ATCP 65.18 (4) (65).
 - 11. Rodent activity in the milkhouse (72).
 - 12. Dead animals in the milking barn or cowyard (75).

- 13. Violations of standards related to the design, construction or installation of equipment or utensils, if the violation creates a substantial risk of adulteration (41, 44, 45).
- 14. Two or more initial violations of dairy farm standards under subch. II that combine to create a substantial risk of milk adulteration.

Administering the Warning Notice:

- 1. Select only the violations that caused the Notice of Reinspection.
- 2. The correction deadline is established based on a reasonable timeframe to correct the required violation(s).
- 3. The correction deadline date shall be not less than 3 days nor more than 65 days after the warning notice is issued.
 - a) Correction deadlines in excess of 30 days are contrary to Pasteurized Milk Ordinance (PMO) guidance and are subject to enforcement deductions on the subsequent milk sanitation rating.
- 4. Check Notice of Reinspection and indicate reinspection date in applicable boxes on the top of the Milk Producer Farm Inspection (F-fd-011).
- 5. Place completed Milk Producer Farm Inspection report and copy of Notice of Reinspection in inspection report bag and set in a conspicuous location in the milkhouse if producer is not present.
- 6. The completed Milk Producer Farm Inspection report shall be emailed to the dairy plant/field rep prior to saving the inspection form by selecting the email tab.
 - a) If situation warrants, leave farm to complete inspection form and Notice of Reinspection. Mail to farm no later than the following day and immediately notifyyour supervisor.
- 7. Reinspection shall be conducted <u>within</u> 7 days <u>after</u> the correction deadline date to determine if the violations on the Notice of Reinspection have been corrected.

Note: Reinspections should not be conducted if the producers Grade A permit is suspended due to somatic cell count (SCC) or standard plate count (SPC). The reinspection shall be conducted within 7 days of notice of reinstatement from the Eau Claire Office. If reinstatement is requested beyond the original correction deadline the reinspection will be routine.

Reinspection Procedure:

- 1. Find the Milk Producer Farm Inspection form under the tab "Select farm Non-Routine Inspections" and check reinspection box on top of milk producer farm inspection.
- 2. If violations listed on Notice of Reinspection are found corrected at time of reinspection, indicate such on milk producer inspection sheet.
 - a. The reinspection should focus <u>only</u> on the items which caused the Notice of Reinspection; however, if a violation that would cause an imminent danger to public health is discovered a summary suspension of the license must take place.
 - b. Carry over non-key violations from the last routine inspection (violations whichdid not cause the reinspection) and/or any newly noted non-key violations on the inspection. If you have any questions contact your supervisor.
- 3. If violations listed on Notice of Reinspection are not corrected at time of reinspection, refer to Notice of Suspension Procedures for further information.
