**SPS 152.01 Certificate of registration renewal.** A registrant who desires to renew a certificate of registration shall submit to the department an application form for renewal that is signed by the registrant under penalty of perjury and contains current information on all matters required in an original application form for registration under s. SPS 151.02 and pay the fee specified in s. SPS 152.05.

**SPS 152.02 Proration of renewal fee.** For the first renewal after a certificate of registration is issued, the department shall prorate the renewal fee based on the length of time between issuance and renewal at the rate of 1/24 of the renewal fee for each completed month that the registration is held prior to the month of the date of renewal.

**SPS 152.03** Waiver of renewal application requirements. A registrant who has submitted an application form for renewal of registration or licensure in another state, in lieu of submitting an application form for renewal as required under s. SPS 152.01, may file a copy of the application form for renewal and a valid certificate of registration or licensure from the other state. The department shall accept the application form for renewal in this state if the

application form submitted to the other state satisfies all of the following:

(1) The application form was submitted in the other state within the 6 months preceding the filing in this state and the applicant certifies that the information contained in the application for renewal is current.

(2) The application form contains information substantially similar to or more comprehensive than that required in an application for renewal submitted in this state. As used herein, "substantially similar" means the application for renewal in the other state contains the information required by s. SPS 150.02 (1) to (3) and (6) to (12).

(3) The application form was signed by the applicant under penalty of perjury.

**SPS 152.04 Refusal to renew a certificate of registration.** The department may refuse to renew a certificate of registration for conduct violating ch. SPS 153 or 154 or that would have justified denial of a certificate of registration under s. SPS 151.05.
