**Initial Regulatory Flexibility Analysis:** The economic impact will be on drivers who are currently grandfathered from needing a medical card and drive a commercial motor vehicle (CMV) in intrastate commerce. Intrastate CMVs that do not meet exemptions outlined in the proposed rule will be required to have an Electronic Logging Device (ELD) installed. Small businesses, as defined under s. 227.114, Stats., will be impacted by this proposed rule. The proposed rule will benefit small business by providing drivers who are more experienced and medically certified. If a CMV driver is not experienced or medically certified, they are at a greater risk to be in a crash. If a crash occurs, it can cost a carrier by increased insurance costs and be at risk to be sued if a CMV driver is at fault. If a motor carrier is using drivers who are not medically certified, they will need to recruit and train new drivers. This recruiting and
