

**PUBLIC NOTICE**  
**Department of Health Services**  
***Crisis Intervention Services***

The State of Wisconsin reimburses providers for services provided to Medical Assistance recipients under the authority of Title XIX of the Social Security Act and ss. 49.43 to 49.47, Wisconsin Statutes. This program, administered by the State's Department of Health Services (the Department), is called Medical Assistance (MA) or Medicaid. In addition, Wisconsin has expanded this program to create the BadgerCare Plus programs under the authority of Title XIX and Title XXI of the Social Security Act and s. 49.471 of the Wisconsin Statutes. Federal statutes and regulations require that a state plan be developed that provides the methods and standards for reimbursement of covered services. A plan that describes the reimbursement system for the services (methods and standards for reimbursement) is in effect.

**Change in Covered Services and Payment Methods**

The Department is making the following changes: Within the Crisis Intervention benefit, Wisconsin Medicaid will begin differentiating the services available along the crisis continuum. These services include local crisis intervention line, crisis response, enhanced mobile crisis, crisis linkage & follow-up, and crisis stabilization. In addition, Wisconsin will be adding new allowable practitioners and reimbursing Medicaid-enrolled crisis programs for each team member who renders services as part of a mobile crisis teaming response.

The change will be effective January 1, 2023. The change to Medicaid, BadgerCare, and BadgerCare Plus is projected to result in increased annual expenditures of \$931,904.07 all funds (AF), composed of \$823,600.91 federal match (FED) and \$108,303.16 state funds/general purpose revenue (GPR).
