

**NOTICE OF PRELIMINARY PUBLIC HEARING AND COMMENT PERIOD  
AND SOLICITATION OF COMMENTS ON ECONOMIC IMPACT ANALYSIS**

**NOTICE IS HEREBY GIVEN** the Department of Public Instruction will hold a public hearing as required under s. 227.16, Stats., to consider the promulgation of administrative rules under:  
SS-104-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to Cooperating teachers and school-based supervisors.

SS-105-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to educator preparation program background checks for admission.

SS-106-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to substitute teaching.

SS-107-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to eligibility for 5-year, educational interpreter license.

SS-108-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to school settings for practicum experiences.

SS-111-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to designating the Wisconsin Challenge Academy as an educational entity.

SS-112-23 on proposed permanent administrative rules to amend Chapter PI 34, relating to reading requirements for the educator preparation program approval process.

Any comment received will also be considered for the development of the economic impact analysis required for rulemaking under s. 227.137 (3), Stats. The hearing will be held via conference call only in the manner as follows:
