The program provides partial reimbursement to states to facilitate the timely placement of children whose special needs or circumstances would otherwise make it difficult to place them with adoptive families. 42 USC 673 (a) (3) provides that the amount of an adoption assistance payment shall be determined through agreement between the adopting parents and the state agency, which shall take into account the circumstances of the adopting parents and the needs of the child being adopted and may be adjusted periodically with the concurrence of the adopting parents.
