**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY BILL 210**

August 12, 2019 – Offered by Representative BROOKS.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 1: before that line insert:

3 “**SECTION 1m.** 299.85 (1) (fm) of the statutes is created to read:

4 299.85 (1) (fm) “Small business stationary source” has the meaning given in  
5 s. 285.79 (1).”.

6 **2.** Page 2, line 2: delete that line and substitute:

7 “**SECTION 2m.** 299.85 (2) (bm) of the statutes is amended to read:

8 299.85 (2) (bm) The notice under par. (b) includes a statement regulated entity  
9 submits a statement, signed by an official of the regulated entity who is responsible  
10 for environmental compliance, that acknowledges that sub. (7) (a) does not apply to  
11 violations discovered by the regulated entity before the beginning of the  
12 environmental compliance audit.”.

1           **3.** Page 2, line 17: delete the material beginning with “The regulated” and  
2 ending with “(b)” on line 19 and substitute “The regulated entity shall complete the  
3 environmental compliance audit, including the final written report of findings,  
4 within 365 days after ~~providing the notice~~ submitting the statement under sub. (2)  
5 ~~(b) (bm)~~.”.

6           **4.** Page 3, line 1: delete the material beginning with “180” and ending with  
7 “within” on line 2 and substitute “60 days of submitting the report or, if the entity is  
8 a small business stationary source, within 180 days of submitting the report or  
9 within”.

10           **5.** Page 3, line 6: delete the material beginning with “180” and ending with  
11 “modification,” on line 8 and substitute “60 days to correct the violations or, if the  
12 entity is a small business stationary source, more than 180 days or more than 360  
13 days if the correction involves a pollution prevention modification,”.

14           **6.** Page 3, line 14: delete the material beginning with “180” and ending with  
15 “modification,” on line 16 and substitute “60 days to correct the violations or, if the  
16 entity is a small business stationary source, more than 180 days or more than 360  
17 days if the correction involves a pollution prevention modification,”.

18           **7.** Page 3, line 20: delete “180 days, or” and substitute “60 days or, if the entity  
19 is a small business stationary source, at least 180 days or”.

20           **8.** Page 4, line 12: delete “180 days, or” and substitute “60 days or, if the entity  
21 is a small business stationary source, within 180 days or”.

22           **9.** Page 4, line 18: delete the material beginning with “source,” and ending  
23 with “285.79 (1),” on line 19 and substitute “source”.

1           **10.** Page 4, line 22: delete the material beginning with “180” and ending with  
2           “longer” on line 23 and substitute “60 days or, if the entity is a small business  
3           stationary source, longer than 180 days or longer”.
