**ASSEMBLY SUBSTITUTE AMENDMENT 1,
TO ASSEMBLY BILL 575**

February 12, 2020 - Offered by Representative VANDERMEER.

1 **AN ACT** *to repeal* 15.407 (2), 50.01 (4p), 252.01 (5), 448.01 (6), 448.03 (1) (b),
2 448.03 (3) (e), 448.04 (1) (f), 448.05 (5), 448.20, 448.21, 448.40 (2) (f) and 450.01

5 providing an exemption from emergency rule procedures, granting
6 rule-making authority, and providing a penalty.

Analysis by the Legislative Reference Bureau

This substitute amendment differs from 2019 Senate Bill 515 in the following respects:

1. The substitute amendment creates the Physician Assistant Affiliated Credentialing Board attached to the Medical Examining Board, instead of creating the Physician Assistant Examining Board. As with other affiliated credentialing boards attached to the Medical Examining Board, the Physician Assistant Affiliated Credentialing Board must submit any proposed permanent administrative rules to the Medical Examining Board, consider any comments from the Medical Examining Board, and include in its final rules submitted to the legislature any comments on the proposed rule submitted by the Medical Examining Board.

2. The substitute amendment adds additional requirements and stipulations for written collaborative agreements between physician assistants and physicians.

3. The substitute amendment includes an express prohibition against the Physician Assistant Affiliated Credentialing Board promulgating any rules that would permit a broader scope of practice than that which may be exercised in accordance with the other provisions in the bill and requires the Physician Assistant Affiliated Credentialing Board to revise a proposed permanent rule that the Medical Examining Board determines would do so.

4. The substitute amendment requires that a physician assistant working with a podiatrist practice under the supervision and direction of the podiatrist, as under current law, instead of under the provisions in the bill. The substitute amendment retains authority for the Podiatry Affiliated Credentialing Board to establish practice standards for physician assistants practicing under podiatrists and requirements for podiatrists supervising physician assistants and retains a limitation that a physician assistant acting under the supervision and direction of a podiatrist be limited to providing nonsurgical patient services.

5. The substitute amendment deletes references to “physician associates” and “associate physicians” for purposes of a provision restricting the use of titles.

 11 or departure from complete health or the proper condition of the human body or any
 12 of its parts.

14 **(4)** “Podiatrist” has the meaning given in s. 448.60 (3).

15 **(5)** “Podiatry” has the meaning given in s. 448.60 (4).

16 **(6)** “Practice of medicine and surgery” has the meaning given in s. 448.01 (9).

17 **448.972 License required; exceptions.** **(1)** Except as provided in subs. (2)
 18 and (3), no person may represent himself or herself as a “PA” or “physician assistant,”
 19 use or assume the title “PA” or “physician assistant,” or append to the person’s name
 20 the words or letters “physician assistant,” “PA,” “PA-C,” or any other titles, letters,
 21 or designation that represents or may tend to represent the person as a physician
 22 assistant, unless he or she is licensed by the board under this subchapter.

23 **(2)** Subsection (1) does not apply with respect to any of the following:

24 (a) An individual employed and duly credentialed as a physician assistant or
 25 physician associate by the federal government while performing duties incident to

1 that employment, unless a license under this subchapter is required by the federal
2 government.

3 (b) A person who satisfies the requirement under s. 448.974 (1) (a) 3. but who
4 is not licensed under this subchapter. This paragraph does not allow such a person
5 to practice medicine and surgery in violation of s. 448.03 (1) (a) or to practice podiatry
6 in violation of s. 448.61.

7 (3) A student who is enrolled in an accredited physician assistant educational
8 program may use the title “physician assistant student,” “PA student,” or “PA-S.”

9 **448.9725 Expedited partner therapy. (1)** In this section:

10 (b) “Antimicrobial drug” has the meaning given in s. 448.035 (1) (b).

11 (c) “Expedited partner therapy” has the meaning given in s. 448.035 (1) (c).

12 (2) Notwithstanding the requirements of s. 448.9785, a physician assistant
13 may provide expedited partner therapy if a patient is diagnosed as infected with a
14 chlamydial infection, gonorrhea, or trichomoniasis and the patient has had sexual
15 contact with a sexual partner during which the chlamydial infection, gonorrhea, or
16 trichomoniasis may have been transmitted to or from the sexual partner. The
17 physician assistant shall attempt to obtain the name of the patient’s sexual partner.
18 A prescription order for an antimicrobial drug prepared under this subsection shall
19 include the name and address of the patient’s sexual partner, if known. If the
20 physician assistant is unable to obtain the name of the patient’s sexual partner, the
21 prescription order shall include, in ordinary, bold-faced capital letters, the words,
22 “expedited partner therapy” or the letters “EPT.”

23 (3) The physician assistant shall provide the patient with a copy of the
24 information sheet prepared by the department of health services under s. 46.03 (44)

1 and shall request that the patient give the information sheet to the person with
2 whom the patient had sexual contact.

3 (4) (a) Except as provided in par. (b), a physician assistant is immune from civil
4 liability for injury to or the death of a person who takes any antimicrobial drug if the
5 antimicrobial drug is prescribed, dispensed, or furnished under this section and if
6 expedited partner therapy is provided as specified under this section.

7 (b) The immunity under par. (a) does not extend to the donation, distribution,
8 furnishing, or dispensing of an antimicrobial drug by a physician assistant whose act
9 or omission involves reckless, wanton, or intentional misconduct.

10 **448.9727 Prescriptions for and delivery of opioid antagonists. (1)** In
11 this section:

12 (a) “Administer” has the meaning given in s. 450.01 (1).

13 (b) “Deliver” has the meaning given in s. 450.01 (5).

14 (c) “Dispense” has the meaning given in s. 450.01 (7).

15 (d) “Opioid antagonist” has the meaning given in s. 450.01 (13v).

16 (e) “Opioid-related drug overdose” has the meaning given in s. 256.40 (1) (d).

17 (f) “Standing order” has the meaning given in s. 450.01 (21p).

18 (2) (a) A physician assistant may do any of the following:

19 1. Prescribe an opioid antagonist to a person in a position to assist an individual
20 at risk of undergoing an opioid-related drug overdose and may deliver the opioid
21 antagonist to that person. A prescription order under this subdivision need not
22 specify the name and address of the individual to whom the opioid antagonist will
23 be administered, but shall instead specify the name of the person to whom the opioid
24 antagonist is prescribed.

1 2. Issue a standing order to one or more persons authorizing the dispensing of
2 an opioid antagonist.

3 (b) A physician assistant who prescribes or delivers an opioid antagonist under
4 par. (a) 1. shall ensure that the person to whom the opioid antagonist is prescribed
5 has or has the capacity to provide the knowledge and training necessary to safely
6 administer the opioid antagonist to an individual undergoing an opioid-related
7 overdose and that the person demonstrates the capacity to ensure that any
8 individual to whom the person further delivers the opioid antagonist has or receives
9 that knowledge and training.

10 **(3)** A physician assistant who, acting in good faith, prescribes or delivers an
11 opioid antagonist in accordance with sub. (2) or who, acting in good faith, otherwise
12 lawfully prescribes or dispenses an opioid antagonist shall be immune from criminal
13 or civil liability and may not be subject to professional discipline under s. 448.978 for
14 any outcomes resulting from prescribing, delivering, or dispensing the opioid
15 antagonist.

16 **448.973 Powers and duties of board.** (1) (a) The board shall promulgate
17 rules implementing s. 448.9785.

18 (b) The board shall promulgate rules establishing continuing education
19 requirements for physician assistants.

20 (c) The board may promulgate other rules to carry out the purposes of this
21 subchapter, including any of the following:

22 1. Rules defining what constitutes unprofessional conduct for physician
23 assistants for purposes of s. 448.978 (2) (d).

24 2. Rules under s. 448.977 (2).

1 **(2)** The board shall include in the register the board maintains under s. 440.035
2 (1m) (d) the names of all persons whose licenses issued under this subchapter were
3 suspended or revoked within the past 2 years. The register shall be available for
4 purchase at cost.

5 **448.974 License; renewal. (1)** (a) Except as provided in par. (b), the board
6 shall grant an initial license to practice as a physician assistant to any applicant who
7 is found qualified by three-fourths of the members of the board and satisfies all of
8 the following requirements, as determined by the board:

9 1. The applicant submits an application on a form provided by the department
10 and pays the initial credential fee determined by the department under s. 440.03 (9)
11 (a).

12 2. The applicant is at least 18 years of age.

13 3. The applicant provides evidence of one of the following:

14 a. That the applicant has successfully completed an educational program for
15 physician assistants or physician associates that is accredited by the Accreditation
16 Review Commission on Education for the Physician Assistant or its successor or,
17 prior to 2001, by the Committee on Allied Health Education and Accreditation or the
18 Commission on Accreditation of Allied Health Education Programs.

19 b. If the applicant does not satisfy subd. 3. a., that the applicant, prior to
20 January 1, 1986, successfully passed the Physician Assistant National Certifying
21 Examination administered by the National Commission on Certification of
22 Physician Assistants.

23 4. The applicant passes the National Commission on Certification of Physician
24 Assistants examination or an equivalent national examination adopted by the board.

1 5. The applicant provides a listing with all employers, practice settings,
2 internships, residencies, fellowships, and other employment for the past 7 years.

3 6. Subject to ss. 111.321, 111.322, and 111.335, the applicant does not have an
4 arrest or conviction record.

5 (b) Paragraph (a) 3. does not apply to an applicant if the applicant provides
6 evidence that he or she is licensed as a physician assistant or physician associate in
7 another state, the District of Columbia, Puerto Rico, the United States Virgin
8 Islands, or any territory or insular possession subject to the jurisdiction of the United
9 States and the board determines that the requirements for obtaining the license in
10 that state or territory are substantially equivalent to the requirements under par.
11 (a).

12 **(2)** (a) The renewal date for a license issued under this subchapter is specified
13 under s. 440.08 (2) (a), and the renewal fees for such licenses are determined by the
14 department under s. 440.03 (9) (a). Renewal of a license is subject to par. (b).

15 (b) An applicant for the renewal of a license under this subchapter shall submit
16 with his or her application for renewal proof of having satisfied the continuing
17 education requirements imposed by the board under s. 448.973 (1) (b). This
18 paragraph does not apply to an applicant for renewal of a license that expires on the
19 first renewal date after the date on which the board initially granted the license.

20 **(3)** Notwithstanding sub. (1), an individual who, on the effective date of this
21 subsection ... [LRB inserts date], was licensed by the medical examining board as
22 a physician assistant under subch. II of ch. 448, 2017 stats., shall be considered to
23 have been licensed under sub. (1) for purposes of this subchapter.

24 **448.975 Practice and employment.** (1) (a) Subject to the limitations and
25 requirements under sub. (2); the physician assistant's experience, education, and

1 training; and any rules promulgated under sub. (5), a physician assistant may do any
2 of the following:

3 1. Examine into the fact, condition, or cause of human health or disease, or
4 treat, operate, prescribe, or advise for the same, by any means or instrumentality.

5 2. Apply principles or techniques of medical sciences in the diagnosis or
6 prevention of any of the conditions described in subd. 1. and in s. 448.971 (2).

7 3. Penetrate, pierce, or sever the tissues of a human being.

8 4. Offer, undertake, attempt, or hold oneself out in any manner as able to do
9 any of the acts described in this paragraph.

10 (b) 1. Subject to subd. 2. and any rules promulgated by the board and consistent
11 with his or her experience, education, and training, a physician assistant may order,
12 prescribe, procure, dispense, and administer prescription drugs, medical devices,
13 services, and supplies.

14 2. A physician assistant practicing under the supervision and direction of a
15 podiatrist under sub. (2) (a) 2m. may issue a prescription order for a drug or device
16 in accordance with guidelines established by the supervising podiatrist and the
17 physician assistant and with rules promulgated by the board. If any conflict exists
18 between the guidelines and the rules, the rules shall control.

19 (c) A physician assistant may practice in ambulatory care, acute care,
20 long-term care, home care, or other settings as a primary, specialty, or surgical care
21 provider who may serve as a patient's primary care provider or specialty care
22 provider.

23 **(2)** (a) 1. Except as provided in subds. 2m. and 3. and sub. (5) (a) 1. a. or b., a
24 physician assistant who provides care to patients shall maintain and provide to the
25 board upon request one of the following:

1 a. Evidence that, pursuant to the physician assistant’s employment, there is
2 a physician who is primarily responsible for the overall direction and management
3 of the physician assistant’s professional activities and for assuring that the services
4 provided by the physician assistant are medically appropriate. In this subd. 1. a.,
5 “employment” includes an arrangement between the physician assistant and a 3rd
6 party in which the 3rd party receives payment for services provided by the physician
7 assistant.

8 b. A written collaborative agreement with a physician that, subject to subd.
9 1m., describes the physician assistant’s individual scope of practice, that includes a
10 protocol for identifying an alternative collaborating physician for situations in which
11 the collaborating physician or the physician’s designee is not available for
12 consultation, and that includes other information as required by the board.

13 1m. All of the following apply to a written collaborative agreement between a
14 physician and physician assistant under subd. 1. b.:

15 a. The agreement may be terminated by either party by providing written
16 notice at least 30 days prior to the date of termination, or as otherwise agreed to by
17 the physician and physician assistant.

18 b. The agreement shall specify that the collaborating physician shall remain
19 reasonably available to the physician assistant through the use of
20 telecommunications or other electronic means within a medically appropriate time
21 frame and that the collaborating physician may designate an alternate collaborator
22 during periods of unavailability.

23 c. The agreement shall specify an arrangement for physician consultation with
24 the patient within a medically appropriate time frame for consultation, if requested
25 by the patient or the physician assistant.

1 d. The agreement shall be signed by the physician assistant and the
2 collaborating physician.

3 2. Subdivision 1. does not require the physical presence of a physician at the
4 time and place a physician assistant renders a service.

5 2m. A physician assistant may practice under the supervision and direction of
6 a podiatrist. A physician assistant who is practicing under the supervision and
7 direction of a podiatrist shall be limited to providing nonsurgical patient services.
8 Subdivision 1. does not apply to a physician assistant who is practicing under the
9 supervision and direction of a podiatrist.

10 3. Subdivision 1. does not apply with respect to a physician assistant who is
11 employed by the federal government as a civilian or member of the uniformed
12 services while performing duties incident to that employment or service.

13 (b) A physician assistant shall limit his or her practice to the scope of his or her
14 experience, education, and training.

15 (c) No physician assistant may provide medical care, except routine screening
16 and emergency care, in any of the following:

17 1. The practice of dentistry or dental hygiene within the meaning of ch. 447.

18 2. The practice of optometry within the meaning of ch. 449.

19 3. The practice of chiropractic within the meaning of ch. 446.

20 4. The practice of acupuncture within the meaning of ch. 451.

21 5. The practice of podiatry, except when the physician assistant is acting under
22 the supervision and direction of a podiatrist, subject to par. (a) 2m. and the rules
23 promulgated under s. 448.695 (4).

24 **(3)** (a) It shall be the obligation of a physician assistant to ensure all of the
25 following:

1 1. That the scope of the practice of a physician assistant is identified and is
2 appropriate with respect to his or her experience, education, and training.

3 2. For purposes of sub. (2) (a) 1. b., that the relationship with and access to a
4 collaborating physician by the physician assistant is defined.

5 3. That the requirements and standards of licensure under this subchapter are
6 complied with.

7 4. That consultation with or referral to other licensed health care providers
8 with a scope of practice appropriate for a patient's care needs occurs when the
9 patient's care needs exceed the physician assistant's experience, education, or
10 training. A physician assistant shall ensure that he or she has awareness of options
11 for the management of situations that are beyond the physician assistant's expertise.

12 (b) A physician assistant is individually and independently responsible for the
13 quality of the care he or she renders.

14 (4) A physician assistant may delegate a care task or order to another clinically
15 trained health care worker if the physician assistant is competent to perform the
16 delegated task or order and has reasonable evidence that the clinically trained
17 health care worker is minimally competent to perform the task or issue the order
18 under the circumstances.

19 (5) (a) 1. The board shall, subject to subd. 2. and s. 448.695 (4), promulgate any
20 rules necessary to implement this section, including rules to do any of the following:

21 a. Allow for temporary practice, specifically defined and actively monitored by
22 the board, in the event of an interruption of a collaborative relationship under sub.
23 (2) (a) 1. b.

24 b. Allow a physician assistant, in the absence of an employment or collaborative
25 relationship under sub. (2) (a) 1., to provide medical care at the scene of an

1 emergency, during a declared state of emergency or other disaster, or when
2 volunteering at sporting events or at camps.

3 2. Rules promulgated by the board may not permit a broader scope of practice
4 than that which may be exercised in accordance with subs. (1) and (2).
5 Notwithstanding s. 15.085 (5) (b) 2., if the Medical Examining Board reasonably
6 determines that a rule submitted to it by the Physician Assistant Affiliated
7 Credentialing Board under s. 15.085 (5) (b) 1. permits a broader scope of practice
8 than that which may be exercised in accordance with subs. (1) and (2), then the
9 Physician Assistant Examining Board shall, prior to submitting the proposed rule
10 to the legislative council staff under s. 227.15 (1), revise the proposed rule so that it
11 does not exceed or permit a broader scope of practice than that which may be
12 exercised in accordance with subs. (1) and (2).

13 (b) The board shall develop and recommend to the podiatry affiliated
14 credentialing board practice standards for physician assistants practicing under
15 podiatrists under sub. (2) (a) 2m.

16 (6) The practice permissions provided in this section are permissions granted
17 by the state authorizing the licensed practice of physician assistants. Nothing in this
18 section prohibits an employer, hospital, health plan, or other similar entity
19 employing or with a relationship with a licensed physician assistant from
20 establishing additional requirements for a licensed physician assistant as a
21 condition of employment or relationship.

22 **448.976 Civil liability.** No physician assistant shall be liable for any civil
23 damages for either of the following:

24 (1) Reporting in good faith to the department of transportation under s. 146.82
25 (3) a patient's name and other information relevant to a physical or mental condition

1 of the patient that in the physician assistant's judgment impairs the patient's ability
2 to exercise reasonable and ordinary control over a motor vehicle.

3 (2) In good faith, not reporting to the department of transportation under s.
4 146.82 (3) a patient's name and other information relevant to a physical or mental
5 condition of the patient that in the physician assistant's judgment does not impair
6 the patient's ability to exercise reasonable and ordinary control over a motor vehicle.

7 **448.977 Malpractice liability insurance.** (1) Except as provided in subs.
8 (2) and (3), no physician assistant may practice as authorized under s. 448.975 unless
9 he or she has in effect malpractice liability insurance coverage evidenced by one of
10 the following:

11 (a) Personal liability coverage in the amounts specified for health care
12 providers under s. 655.23 (4).

13 (b) Coverage under a group liability policy providing individual coverage for the
14 physician assistant in the amounts under s. 655.23 (4).

15 (2) The board may promulgate rules requiring a practicing physician assistant
16 to have in effect malpractice liability insurance coverage in amounts greater than
17 those specified in sub. (1) (a) or (b) or (4). If the board promulgates rules under this
18 subsection, no physician assistant may practice as authorized under s. 448.975
19 unless he or she has in effect malpractice liability insurance coverage as required
20 under those rules, except as provided in sub. (3).

21 (3) A physician assistant who is a state, county, or municipal employee, or
22 federal employee or contractor covered under the federal tort claims act, as amended,
23 and who is acting within the scope of his or her employment or contractual duties is
24 not required to maintain in effect malpractice insurance coverage.

1 (4) Except as provided in subs. (2) and (3), a physician assistant may comply
2 with sub. (1) if the physician assistant's employer has in effect malpractice liability
3 insurance that is at least the minimum amount specified under s. 655.23 (4) and that
4 provides coverage for claims against the physician assistant.

5 **448.978 Professional discipline.** (1) Subject to the rules promulgated under
6 s. 440.03 (1), the board may conduct investigations and hearings to determine
7 whether a person has violated this subchapter or a rule promulgated under this
8 subchapter.

9 (2) Subject to the rules promulgated under s. 440.03 (1), if a person who applies
10 for or holds a license issued under s. 448.974 does any of the following, the board may
11 reprimand the person or deny, limit, suspend, or revoke the person's license:

12 (a) Makes a material misstatement in an application for a license or an
13 application for renewal of a license under s. 448.974.

14 (b) Violates any law of this state or federal law that substantially relates to the
15 practice of a physician assistant, violates this subchapter, or violates a rule
16 promulgated under this subchapter.

17 (c) Advertises, practices, or attempts to practice under another person's name.

18 (d) Engages in unprofessional conduct. In this paragraph, "unprofessional
19 conduct" does not include any of the following:

20 1. Providing expedited partner therapy as described in s. 448.9725.

21 2. Prescribing or delivering an opioid antagonist in accordance with s. 448.9727

22 (2).

23 (e) Subject to ss. 111.321, 111.322, and 111.335, is arrested for or convicted of
24 a felony.

1 (f) Subject to ss. 111.321, 111.322, and 111.34, practices as a physician assistant
2 while his or her ability is impaired by alcohol or other drugs.

3 (g) Engages in fraud or deceit in obtaining or using his or her license.

4 (h) Is adjudicated mentally incompetent by a court.

5 (i) Demonstrates gross negligence, incompetence, or misconduct in practice.

6 (j) Knowingly, recklessly, or negligently divulges a privileged communication
7 or other confidential patient health care information except as required or permitted
8 by state or federal law.

9 (k) Fails to cooperate with the board, or fails to timely respond to a request for
10 information by the board, in connection with an investigation under this section.

11 (L) Prescribes, sells, administers, distributes, orders, or provides a controlled
12 substance for a purpose other than a medical purpose.

13 (m) Demonstrates a lack of physical or mental ability to safely practice as a
14 physician assistant.

15 (n) Engages in any practice that is outside the scope of his or her experience,
16 education, or training.

17 (o) Is disciplined or has been disciplined by another state or jurisdiction based
18 upon acts or conduct similar to acts or conduct prohibited under pars. (a) to (n).

19 **448.9785 Informed consent.** Any physician assistant who treats a patient
20 shall inform the patient about the availability of reasonable alternate medical modes
21 of treatment and about the benefits and risks of these treatments. The reasonable
22 physician assistant standard is the standard for informing a patient under this
23 section. The reasonable physician assistant standard requires disclosure only of
24 information that a reasonable physician assistant in the same or a similar medical
25 specialty would know and disclose under the circumstances. The physician

1 assistant's duty to inform the patient under this section does not require disclosure
2 of any of the following:

3 (1) Detailed technical information that in all probability a patient would not
4 understand.

5 (2) Risks apparent or known to the patient.

6 (3) Extremely remote possibilities that might falsely or detrimentally alarm
7 the patient.

8 (4) Information in emergencies where failure to provide treatment would be
9 more harmful to the patient than treatment.

10 (5) Information in cases where the patient is incapable of consenting.

11 (6) Information about alternate medical modes of treatment for any condition
12 the physician assistant has not included in his or her diagnosis at the time the
13 physician informs the patient.

14 **448.979 Penalties.** Any person who violates this subchapter is subject to a
15 fine not to exceed \$10,000 or imprisonment not to exceed 9 months, or both.

16 **448.9793 Injunction.** If it appears upon complaint to the board by any person
17 or if it is known to the board that any person is violating this subchapter, or rules
18 adopted by the board under this subchapter, the board or the attorney general may
19 investigate and may, in addition to any other remedies, bring action in the name and
20 on behalf of the state against any such person to enjoin such person from such
21 violation. The attorney general shall represent the board in all proceedings.

22 **448.9795 Duty to report. (1)** A physician assistant who has reason to believe
23 any of the following about another physician assistant shall promptly submit a
24 written report to the board that includes facts relating to the conduct of the other
25 physician assistant:

1 (a) The other physician assistant is engaging or has engaged in acts that
2 constitute a pattern of unprofessional conduct.

3 (b) The other physician assistant is engaging or has engaged in an act that
4 creates an immediate or continuing danger to one or more patients or to the public.

5 (c) The other physician assistant is or may be medically incompetent.

6 (d) The other physician assistant is or may be mentally or physically unable
7 safely to engage in the practice of a physician assistant.

8 **(2)** No physician assistant who reports to the board under sub. (1) may be held
9 civilly or criminally liable or be found guilty of unprofessional conduct for reporting
10 in good faith.

25 drug product or device prescribed, directions for the use of the drug product or device,

1 the symptom or purpose for which the drug is being prescribed if required under sub.
