- 6 **5.** Page 2, line 9: delete “Student apprenticeship” and substitute
7 “Apprenticeship”.
- 8 **6.** Page 2, line 11: delete “*for tribal college students*”.
- 9 **7.** Page 2, line 12: delete “to tribal college students”.
- 10 **8.** Page 2, line 18: delete “*Student apprenticeship*” and substitute
11 “*Apprenticeship*”.

10 grants on and after January 1 to students as provided in subd. 1. and also to any other
11 individual who has undertaken an apprenticeship program.

12 (am) Grants may be awarded under this subsection only to pay for the grant
13 recipients’ actual materials expenses, such”.

- 14 recipients’ actual materials expenses, such as the”.
