## SENATE AMENDMENT 1, TO SENATE BILL 772

February 11, 2020 - Offered by Senator Hansen.

1 At the locations indicated,	amend the bill as follows:

- 2 **1.** Page 4, line 7: after "receives" insert "or has received".
- 2. Page 4, line 11: after "services" insert "or the first day of the 7th month beginning after the effective date of this subsection .... [LRB inserts date], whichever is later".
  - **3.** Page 4, line 25: delete the material beginning with "or any other" and ending with "toxic compound" on page 5, line 1.
- **4.** Page 5, line 5: delete "or any other toxic compound".
- 9 **5.** Page 5, line 21: delete "standards for any known" and substitute "standards, for".
- 11 **6.** Page 5, line 22: after "substances" insert "for which the department has received a recommended groundwater enforcement standard from the department

- of health services or that has been identified by the federal Environmental Protection Agency as having an inhalation effect,".
  - **7.** Page 6, line 15: after that line insert:
  - "(a) "Municipality" means a city, town, village, county, county utility district, town sanitary district, public inland lake protection and rehabilitation district, sewerage district, or metropolitan sewage district.".
    - **8.** Page 6, line 16: delete "(a)" and substitute "(b)".
- 8 **9.** Page 6, line 17: delete lines 17 to 21.
- 9 **10.** Page 6, line 23: delete the material beginning with "that are not" and ending with "par. (b)" on line 24.
- 11. Page 6, line 25: delete the material beginning with "Except as provided" and ending with "eligible activity." on page 7, line 2.
  - **12.** Page 7, line 3: delete the material beginning with "that is a responsible" and ending with "applies:" on line 4 and substitute "only if the municipality proposes to conduct an eligible activity under sub. (3) in response to any of the following:".
- 16 **13.** Page 7, line 5: delete the material beginning with "discharge of PFAS" and ending with "from the" on line 6.
- 18 **14.** Page 7, line 8: delete "prior to August 1, 2020" and substitute "in accordance with state and federal law".
- 20 **15.** Page 7, line 11: delete the material beginning with "discharge of PFAS" and ending with "from the" on line 12.
  - **16.** Page 7, line 12: delete "or making any other discharge".
- 23 **17.** Page 7, line 13: delete "or discharge".

- **18.** Page 7, line 14: delete the material beginning with "and was done" and ending with "[LRB inserts date]" on line 15.
  - **19.** Page 7, line 15: after that line insert:
  - "3. Any other municipal operations for which the municipality wishes to sample for PFAS, if the operations were done in accordance with state and federal law and, if applicable, with a pollution discharge elimination system permit issued under ch. 283.
    - 4. The discharge of PFAS or the presence of environmental pollution caused by PFAS, if the discharge or pollution is suspected to have impacted or is known to be impacting a municipal or private water supply and if the person that caused the discharge or pollution is unknown or is unwilling or unable to take the necessary response actions.".
    - **20.** Page 7, line 18: delete the material beginning with "environmental pollution" and ending with "discharge" on line 19 and substitute "impacts to the air, land, or water".
    - **21.** Page 7, line 24: delete "contain PFAS" and substitute "have caused the discharge of PFAS or environmental pollution from PFAS".
- 22. Page 8, line 3: after "environmental pollution" insert ", including by treating or disposing of contaminated groundwater, sediment, biosolids, soil, and other affected media".
- 23. Page 8, line 10: delete "The department may, if it" and substitute "(a) In this section:".
- **24.** Page 8, line 10: after that line insert:

- "1. "Municipality" means a city, town, village, county, county utility district, town sanitary district, public inland lake protection and rehabilitation district, sewerage district, or metropolitan sewage district.
  - 2. "PFAS" means a perfluoroalkyl or polyfluoroalkyl substance.".
- **25.** Page 8, line 11: delete "is necessary to protect human health or the environment" and substitute "is in the financial best interests of the state".
- **26.** Page 8, line 11: before "determines doing so" insert "(b) At sites or facilities where the department has directed a responsible party, in writing, to take action under ch. 292, the department may, if it".
- **27.** Page 8, line 12: delete the material beginning with "controls" and ending with "substance" on line 13 and substitute "controls PFAS or who causes the discharge of PFAS or environmental pollution from PFAS".
- **28.** Page 8, line 14: delete "for conducting emergency response actions," and substitute "to ensure that the necessary".
- **29.** Page 8, line 15: delete the material beginning with "to address contamination" and ending with "substances" on line 17 and substitute "at the site or facility can be conducted. This requirement applies only if the department estimates that these costs would exceed \$1,000,000.".
- **30.** Page 9, line 2: after "state." insert "This section also does not apply to a person who owns an agricultural site at which biosolids received from a municipality are spread on land, if the application is done in accordance with a pollution discharge elimination system permit issued under ch. 283 and only while the site remains under agricultural use.".
  - **31.** Page 9, line 4: delete "all known".

**32.** Page 9, line 6: after "per year." insert "Reporting to the department shall be limited to perfluoroalkyl and polyfluoroalkyl substances for which the department has received a recommended groundwater enforcement standard from the department of health services or that has been identified by the federal Environmental Protection Agency as having an inhalation effect".
