**ASSEMBLY SUBSTITUTE AMENDMENT 2,  
TO ASSEMBLY BILL 564**

September 28, 2021 - Offered by Representatives VINING, CONSIDINE, MOORE  
OMOKUNDE, HESSELBEIN, EMERSON, OHNSTAD, SUBECK, MCGUIRE, HEBL,  
SHELTON, STUBBS, SNODGRASS, BILLINGS, ANDERSON, CABRERA, BALDEH and  
NEUBAUER.

1 **AN ACT to amend** 115.437 (2) (a) of the statutes; **relating to:** funding for special  
2 education, pupil mental health, per pupil aid, school-based mental health  
3 services grants, the University of Wisconsin System, and the technical college  
4 system and making an appropriation.

***The people of the state of Wisconsin, represented in senate and assembly, do  
enact as follows:***

5 **SECTION 1.** 115.437 (2) (a) of the statutes is amended to read:  
6 115.437 (2) (a) Except as provided in par. (b), annually on the 4th Monday of  
7 March, the department shall pay to each school district an amount equal to the  
8 average of the number of pupils enrolled in the school district in the current and 2  
9 preceding school years multiplied by \$75 in the 2013-14 school year, by \$150 in the  
10 2014-15 and 2015-16 school years, by \$250 in the 2016-17 school year, by \$450 in  
11 the 2017-18 school year, by \$654 in the 2018-19 school year, by ~~\$679~~ and ~~\$63~~ \$742

1 in the 2019-20 and 2020-21 school years, and by \$888 in each school year thereafter.

2 The department shall make the payments from the appropriation under s. 20.255 (2)  
3 (aq).

4 **SECTION 2. Fiscal changes.**

5 (1) SPECIAL EDUCATION AID. In the schedule under s. 20.005 (3) for the  
6 appropriation to the department of public instruction under s. 20.255 (2) (b), the  
7 dollar amount for fiscal year 2021-22 is increased by \$100,000,000 to increase  
8 funding for aids for special education under s. 115.88 and the dollar amount for fiscal  
9 year 2022-23 is increased by \$100,000,000 to increase funding for aids for special  
10 education under s. 115.88.

11 (2) AIDS FOR SCHOOL MENTAL HEALTH PROGRAMS. In the schedule under s. 20.005  
12 (3) for the appropriation to the department of public instruction under s. 20.255 (2)  
13 (da), the dollar amount for fiscal year 2021-22 is increased by \$30,000,000 for the  
14 purposes for which the appropriation is made. In the schedule under s. 20.005 (3)  
15 for the appropriation to the department of public instruction under s. 20.255 (2) (da),  
16 the dollar amount for fiscal year 2022-23 is increased by \$30,000,000 for the  
17 purposes for which the appropriation is made.

18 (3) SCHOOL-BASED MENTAL HEALTH SERVICES GRANTS. In the schedule under s.  
19 20.005 (3) for the appropriation to the department of public instruction under s.  
20 20.255 (2) (dt), the dollar amount for fiscal year 2021-22 is increased by \$5,000,000  
21 for the purposes for which the appropriation is made. In the schedule under s. 20.005  
22 (3) for the appropriation to the department of public instruction under s. 20.255 (2)  
23 (dt), the dollar amount for fiscal year 2022-23 is increased by \$5,000,000 for the  
24 purposes for which the appropriation is made.
