4 proportion of the number of juveniles statewide who are placed in a juvenile  
5 correctional facility or a secured residential care center for children and youth during  
6 the most recent 3-year period for which that information is available.

7 (c) Of the amounts specified in par. (a), the department shall allocate  
8 \$1,053,200 for the last 6 months of ~~2021~~ 2023, \$2,106,500 for ~~2022~~ 2024, and  
9 \$1,053,300 for the first 6 months of ~~2023~~ 2025 to counties based on each of the factors  
10 specified in par. (b) 1. to 3. weighted equally, except that no county may receive an  
11 allocation under this paragraph that is less than 93 percent nor more than 115  
12 percent of the amount that the county would have received under this paragraph if  
13 the allocation had been distributed only on the basis of the factor specified in par. (b)  
14 3.

15 (e) For emergencies related to community youth and family aids under this  
16 section, amounts not to exceed \$125,000 for the last 6 months of ~~2021~~ 2023, \$250,000  
17 for ~~2022~~ 2024, and \$125,000 for the first 6 months of ~~2023~~ 2025. A county is eligible  
18 for payments under this paragraph only if it has a population of not more than  
19 45,000.

20 (h) For counties that are purchasing community supervision services under s.  
21 938.533 (2), \$1,062,400 in the last 6 months of ~~2021~~ 2023, \$2,124,800 in ~~2022~~ 2024,  
22 and \$1,062,400 in the first 6 months of ~~2023~~ 2025 for the provision of community  
23 supervision services for juveniles from that county. In distributing funds to counties  
24 under this paragraph, the department shall distribute to each county the full amount  
25 of the charges for the services purchased by that county, except that if the amounts

1 available under this paragraph are insufficient to distribute that full amount, the  
2 department shall distribute those available amounts to each county that purchases  
3 community supervision services based on the ratio that the charges to that county  
4 for those services bear to the total charges to all counties that purchase those  
5 services.

6 (8) ALCOHOL AND OTHER DRUG ABUSE TREATMENT. From the amount of the  
7 allocations specified in sub. (7) (a), the department shall allocate \$666,700 in the last  
8 6 months of ~~2021~~ 2023, \$1,333,400 in ~~2022~~ 2024, and \$666,700 in the first 6 months  
9 of ~~2023~~ 2025 for alcohol and other drug abuse treatment programs.”.

1 amounts, to the extent practicable, shall be used to determine the statewide county  
2 average cost-sharing percentage in the particular calendar year.

3 (c) For the purpose of calculating and distributing aids under sub. (2), the  
4 amounts for aids to municipalities are ~~\$383,503,200 in calendar years 2020 and~~  
5 ~~\$391,173,300 in calendar year 2022, and \$398,996,800 in calendar year 2023.~~  
6 In calendar year 2024, the amounts for aids to municipalities are \$406,976,700. In  
7 calendar year 2025 and thereafter, the amounts for aids to municipalities are  
8 \$415,116,200. These amounts, to the extent practicable, shall be used to determine  
9 the statewide municipal average cost-sharing percentage in the particular calendar  
10 year.

13 From the appropriation under s. 20.395 (2) (ft), the department shall allocate  
14 \$5,127,000 in fiscal years 2014-15 to 2016-17 and \$5,393,400 in fiscal year  
15 2017-2018 ~~and each fiscal year thereafter,~~ to fund county trunk highway  
16 improvements with eligible costs totaling more than \$250,000. In fiscal year 2023-24  
17 the department shall allocate \$5,615,600 to fund county trunk highway  
18 improvements with such eligible costs. In fiscal year 2024-25 and each fiscal year  
19 thereafter, the department shall allocate \$5,840,200 to fund county trunk highway  
20 improvements with such eligible costs. The funding of improvements under this  
21 subsection is in addition to the allocation of funds for entitlements under sub. (3).

22 **(3m)** TOWN ROAD IMPROVEMENTS — DISCRETIONARY GRANTS. From the
