22 by the system, but does not include an uninterruptible power source that is
23 designed primarily for computers. The exemption under this subdivision does not

1 apply to tangible personal property designed for any use other than for a solar
2 power system or wind energy system described in this subdivision.

3 2. The sales price from the sale of and the storage, use, or other consumption
4 of a waste energy system that produces usable electrical or heat energy directly
5 from gas generated from anaerobic digestion of animal manure and other
6 agricultural waste if the system is capable of continuously producing at least 200
7 watts of alternating current or 600 British thermal units. A system described
8 under this subdivision includes tangible personal property sold with the system
9 that is used primarily to store or facilitate the storage of the electrical or heat
10 energy produced by the system, but does not include an uninterruptible power
11 source that is designed primarily for computers. The exemption under this
12 subdivision does not apply to tangible personal property designed for any use other
13 than for a waste energy system described in this subdivision.

(a) The fee is in addition to fees that the seller charges for other distinct and identifiable products sold to the same buyer, the fee is separately set forth on the invoice given by the seller to the buyer, and the seller does not require the buyer to pay the fee if the buyer chooses not to receive the additional distinct and identifiable product for which the fee applies.

(b) The seller charges a single amount for multiple distinct and identifiable products and offers the buyer the option of paying a lower amount if the buyer chooses not to receive one or more of the distinct and identifiable products. For purposes of this paragraph, the separate and optional fee is the single amount the seller charges for the multiple distinct and identifiable products less the reduced

1 amount the seller charges to the buyer because the buyer chooses not to receive one
2 or more of the products.

3 **SECTION 22.** 77.52 (2) (a) 20. of the statutes is amended to read:

4 77.52 (2) (a) 20. The sale of landscaping and lawn maintenance services
5 including landscape planning and counseling, lawn and garden services such as
6 planting, mowing, spraying and fertilizing, and shrub and tree services. For
7 purposes of this subdivision, landscaping and lawn maintenance services do not
8 include planning and counseling services for the restoration, reclamation, or
9 revitalization of prairie, savanna, or wetlands to improve biodiversity, the quality of
10 land, soils, or water, or other ecosystem functions if the planning and counseling

139.75 (12) “Tobacco products” means cigars; little cigars; pipe tobacco; cheroots; stogies; periques; granulated, plug cut, crimp cut, ready-rubbed and other smoking tobacco; snuff, including moist snuff; snuff flour; cavendish; plug and twist tobacco; fine cut and other chewing tobaccos; shorts; refuse scraps, clippings, cuttings and sweepings of tobacco and other kinds and forms of tobacco prepared in

1 such manner as to be suitable for chewing or smoking in a pipe or otherwise, or both
2 for chewing and smoking; but “tobacco products” does not include cigarettes, as
3 defined under s. 139.30 (1m).

5 139.76 (1) Except as provided in ~~sub.~~ subs. (1p) and (1t), an excise tax is
6 imposed upon the sale, offering or exposing for sale, possession with intent to sell or
7 removal for consumption or sale or other disposition for any purpose of tobacco
8 products by any person engaged as a distributor of them at the rate, for tobacco
9 products, not including moist snuff, ~~vapor products~~, cigars, little cigars, and pipe
10 tobacco, of 71 percent of the manufacturer’s established list price to distributors
11 without diminution by volume or other discounts on domestic products and, for
12 moist snuff, at the rate of 100 percent of the manufacturer’s established list price to
13 distributors without diminution by volume or other discounts on domestic products.
14 On tobacco products imported from another country, not including moist snuff,
15 ~~vapor products~~, cigars, little cigars, and pipe tobacco, the rate of tax is 71 percent of
16 the amount obtained by adding the manufacturer’s list price to the federal tax,
17 duties and transportation costs to the United States. On moist snuff imported from
18 another country, the rate of the tax is 100 percent of the amount obtained by adding
19 the manufacturer’s list price to the federal tax, duties, and transportation costs to
20 the United States. Except as provided in sub. (1p), the tax attaches at the time the
21 tobacco products are received by the distributor in this state. The tax shall be
22 passed on to the ultimate consumer of the tobacco products. All tobacco products
23 received in this state for sale or distribution within this state, except tobacco
24 products actually sold as provided in sub. (2), shall be subject to such tax.

1 **SECTION 29.** 139.76 (1p) of the statutes is amended to read:

2 **139.76 (1p)** An excise tax is imposed upon the sale, offering or exposing for
3 sale, possession with intent to sell, or removal for consumption or sale or other
4 disposition for any purpose of cigars, not including little cigars, and pipe tobacco by
5 any person engaged as a distributor or remote retail seller of them at the rate of 71
6 percent of the actual cost to the distributor or remote retail seller. The tax imposed
