**SENATE AMENDMENT 24,
TO SENATE SUBSTITUTE AMENDMENT 2,
TO SENATE BILL 45**

July 2, 2025 - Offered by Senators HESSELBEIN, SMITH, SPREITZER, DRAKE, L. JOHNSON, ROYS, CARPENTER, DASSLER-ALFHEIM, HABUSH SINYKIN, KEYESKI, LARSON, PFAFF, RATCLIFF and WALL.

1 At the locations indicated, amend the substitute amendment as follows:

2 **1.** At the appropriate places, insert all of the following:

3 **“SECTION 9232. Fiscal changes; Natural Resources.**

4 (1) STATE PARKS OPERATION FUNDING. In the schedule under s. 20.005 (3) for
5 the appropriation to the department of natural resources under s. 20.370 (1) (eq),
6 the dollar amount for fiscal year 2025-26 is increased by \$1,785,000 and the dollar
7 amount for fiscal year 2026-27 is increased by \$2,180,000 for operational costs in
8 state parks, southern forests, and recreation areas.

9 (2) STATE FOREST, PARK, AND RIVERWAY ROADS; SEG. In the schedule under s.
10 20.005 (3) for the appropriation to the department of natural resources under s.

20.370 (7) (mr), the dollar amount for fiscal year 2025-26 is increased by \$4,109,500 and the dollar amount for fiscal year 2026-27 is increased by \$4,109,500.

(3) STATE FOREST, PARK, AND RIVERWAY ROADS; GPR. In the schedule under s. 20.005 (3) for the appropriation to the department of natural resources under s. 20.370 (7) (mc), the dollar amount for fiscal year 2025-26 is increased by \$1,147,400 and the dollar amount for fiscal year 2026-27 is increased by \$1,147,400.

(4) DNR-OWNED PROPERTY DEVELOPMENT. In the schedule under s. 20.005 (3) for the appropriation to the department of natural resources under s. 20.370 (7) (ht), the dollar amount for fiscal year 2025-26 is increased by \$1,660,600 and the dollar amount for fiscal year 2026-27 is increased by \$1,660,600.

(5) STATE PARKS AND TRAILS DEVELOPMENT AND MAINTENANCE. In the schedule under s. 20.005 (3) for the appropriation to the department of natural resources under s. 20.370 (7) (hu), the dollar amount for fiscal year 2025-26 is increased by \$239,000 and the dollar amount for fiscal year 2026-27 is increased by \$239,000.

(6) FACILITIES DEVELOPMENT AND MAINTENANCE. In the schedule under s. 20.005 (3) for the appropriation to the department of natural resources under s. 20.370 (7) (ha), the dollar amount for fiscal year 2025-26 is increased by \$228,200 and the dollar amount for fiscal year 2026-27 is increased by \$228,200.

(7) DNR PROPERTY ACQUISITION AND DEVELOPMENT. In the schedule under s. 20.005 (3) for the appropriation to the department of natural resources under s. 20.370 (5) (hq), the dollar amount for fiscal year 2025-26 is increased by \$434,600 and the dollar amount for fiscal year 2026-27 is increased by \$434,600.

(8) STATE PARKS TECHNOLOGY UPGRADES. In the schedule under s. 20.005 (3)

1 for the appropriation to the department of natural resources under s. 20.370 (1)
2 (eq), the dollar amount for fiscal year 2025-26 is increased by \$861,900 and the
3 dollar amount for fiscal year 2026-27 is increased by \$506,900 for operation of
4 electronic sales kiosks and the purchase of associated equipment and for broadband
5 upgrades at state parks, forests, and department-owned shooting ranges.

6 (9) STATE PARKS EQUIPMENT. In the schedule under s. 20.005 (3) for the
7 appropriation to the department of natural resources under s. 20.370 (1) (eq), the
8 dollar amount for fiscal year 2025-26 is increased by \$729,100 and the dollar
9 amount for fiscal year 2026-27 is increased by \$432,200 for equipment for the state
10 parks system.

11 (10) OPEN THE OUTDOORS. In the schedule under s. 20.005 (3) for the
12 appropriation to the department of natural resources under s. 20.370 (1) (eq), the
13 dollar amount for fiscal year 2025-26 is increased by \$473,100 and the dollar
14 amount for fiscal year 2026-27 is increased by \$473,100 for adaptive equipment for
15 the state parks system to expand outdoor recreation opportunities for individuals
16 with disabilities.

17 (11) VEHICLE ADMISSION STICKERS. In the schedule under s. 20.005 (3) for the
18 appropriation to the department of natural resources under s. 20.370 (1) (eq), the
19 dollar amount for fiscal year 2025-26 is increased by \$223,100 and the dollar
20 amount for fiscal year 2026-27 is increased by \$223,100 for staffing and printing
21 costs related to converting state parks and forests annual vehicle admission sticker
22 validity from a calendar-year basis to a 12-month time period.

23 (12) MEDICAL TRAINING AND SUPPLIES. In the schedule under s. 20.005 (3) for
24 the appropriation to the department of natural resources under s. 20.370 (1) (eq),

1 the dollar amount for fiscal year 2025-26 is increased by \$267,000 and the dollar
2 amount for fiscal year 2026-27 is increased by \$35,000 for medical training and
3 supplies for staff of the state parks system.”.
