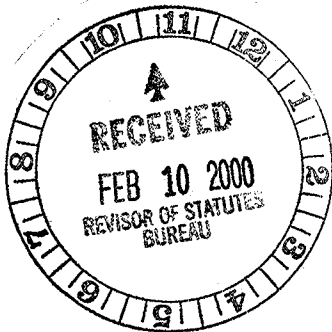

**Order of the
Wisconsin Higher Educational Aids Board
Amending and Creating Rules**

To amend HEA 11.03(3) and create HEA 11.03(5) relating to the Minority Teacher Loan Program.

Analysis Prepared by the Higher Educational Aids Board

STATUTORY AUTHORITY: s. 39.28(1) and s. 227.11(2), Stats.

STATUTES INTERPRETED: s. 39.40, Stats.

The 1989 Wisc. Act 31 created s. 39.40, Stats., which provides for loans to minority students enrolled in programs of study leading to licensure as a teacher. The Wisconsin Higher Educational Aids Board (HEAB) administers this loan program under s. 39.40 and under ch. HEA 11. This rulemaking order expands program eligibility to allow students who were eligible to participate under this program in the past, when it was administered by a different system, to continue to be eligible to participate in the future.

TEXT OF RULE

Under the authority vested in the state of Wisconsin, higher educational aids board, by s. 39.28(1) and s. 227.11(2), Stats., the higher educational aids board hereby amends and creates these rules interpreting s. 39.40, Stats., relating to the Minority Teacher Loan Program.

Section 1. HEA 11.03(3) is amended to read:


HEA 11.03(3). The borrower shall be enrolled ~~full time~~ at least half time in an eligible institution in the junior or senior year of a bachelor degree program majoring in education.

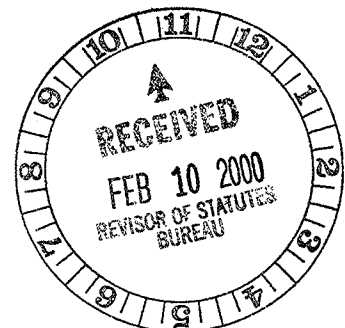
Section 2. HEA 11.03(5) is created to read:

HEA 11.03(5). The borrower shall not be required to show financial need.

Effective Date. This rule shall take effect on the first day of the month following publication in the Wisconsin Administrative Register as provided in s. 227.22(2), Stats.

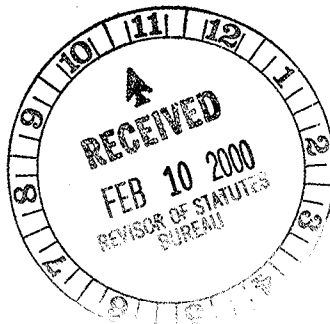
