NR 352.01 Applicability; purpose. c1d APPLICABIL-ITY. This chapter applies to all nonfederal wetlands as defined in s. 281.36 c1d ccd, Stats.

Note: Section 281.36 c1d ccd was repealed by 2011 Wis. Act 118.

c2d PURPOSE. This chapter is adopted under ss. 281.36 c1md and c2md, Stats., to designate the wetland delineation manual procedures to be used to delineate nonfederal wetlands. The manual to be used is the 1987 edition of the U.S. army corps of engineers wetland delineation manual and any document that the U.S. army corps of engineers issues interpreting the manual.

Note: 2011 Wis. Act 118 repealed s. 281.36 c1md, Stats., and renumbered s. 281.36 c3d to be s. 281.36 c2md, Stats., and amended it to apply to all cfederal and non federald wetlands.
