#### NATIONAL EMISSION STANDARDS FOR HAZARDOUS AIR POLLUTANTS FOR INDUSTRIAL, COMMERCIAL AND INSTITUTIONAL BOILERS AND PROCESS HEATERS

NR 462.01 What this chapter covers. c1d WHAT IS THE PURPOSE OF THIS CHAPTER? This chapter establishes national emission limits and work practice standards for hazardous air pollutants cHAPd emitted from industrial, commercial and institutional boilers and process heaters. This chapter also establishes requirements to demonstrate initial and continuous compliance with the emission limits and work practice standards.

**Note:** This subchapter is based on the federal regulations contained in 40 CFR part 63 Subpart DDDDD, as created September 13, 2004 and amended on December 28, 2005.

**c2d** AM I SUBJECT TO THIS CHAPTER? You are subject to this chapter if you own or operate an industrial, commercial or institutional boiler or process heater as defined in s. NR 462.02 that is located at, or is part of, a major source of HAP as defined in s. NR 460.02 c24d or 40 CFR 63.761 except as specified in sub. c4d.

**c3d** What is the affected source of this chapter? cad This chapter applies to new, reconstructed, or existing affected sources as described in subds. 1. and 2.

- 1. The affected source of this chapter is the collection of all existing industrial, commercial and institutional boilers and process heaters, as defined in s. NR 462.02, within a subcategory located at a major source.
- 2. The affected source of this chapter is each new or reconstructed industrial, commercial or institutional boiler or process heater, as defined in s. NR 462.02, located at a major source.
- cbd A boiler or process heater is new if you commence construction of the boiler or process heater after January 13, 2003, and you meet the applicability criteria at the time you commence construction.

ccd A boiler or process heater is reconstructed if you meet the reconstruction criteria as defined in s. NR 460.02 c32d, you commence reconstruction after January 13, 2003, and you meet the applicability criteria at the time you commence reconstruction.

cdd A boiler or process heater is existing if it is not new or reconstructed.

**c4d** ARE ANY BOILERS OR PROCESS HEATERS NOT SUBJECT TO THIS CHAPTER? The types of boilers and process heaters listed in pars. cad to cod are not subject to this chapter.

cad A municipal waste combustor covered by 40 CFR part 60, subpart AAAA, BBBB, Cb or Eb.

cbd A hospital{medical{infectious waste incinerator covered by 40 CFR part 60, subpart Ce or Ec.

ccd An electric utility steam generating unit that is a fossil fuel-fired combustion unit of more than 25 megawatts that serves a generator that produces electricity for sale. A fossil fuel-fired unit that cogenerates steam and electricity, and supplies more than one-third of its potential electric output capacity, and more than 25 megawatts electrical output, to any utility power distribu-

tion system for sale is considered an electric utility steam generating unit.

cdd A boiler or process heater required to have a permit under section 3005 of the Solid Waste Disposal Act or covered by 40 CFR part 63, subpart EEE, such as a hazardous waste boiler.

ced A commercial and industrial solid waste incineration unit covered by 40 CFR part 60, subpart CCCC or subpart DDDD.

cfd A recovery boiler or furnace covered by 40 CFR part 63, subpart MM.

cgd A boiler or process heater that is used specifically for research and development. This does not include units that only provide heat or steam to a process at a research and development facility.

chd A water heater as defined in s. NR 462.02 c51d.

cid A refining kettle covered by 40 CFR part 63, subpart X.

cjd An ethylene cracking furnace covered by 40 CFR part 63, subpart YY.

ckd Blast furnace stoves as described in the EPA document entitled XNational Emission Standards for Hazardous Air Pollutants for Integrated Iron and Steel Plants--Background Information for Proposed Standards, Y EPA-453 {R-01-005, incorporated by reference in s. NR 484.06 c4d cdd.

cLd Any boiler and process heater specifically listed as an affected source in another standard under 40 CFR part 63 or chs. NR 462 to 469.

cmd Any boiler and process heater specifically listed as an affected source in another standard established under section 129 of the Act.

cnd Temporary boilers as defined in s. NR 462.02 c47d.

cod Blast furnace gas fuel-fired boilers and process heaters as defined in s. NR 462.02 c4d.

**c5d** WHEN DO I HAVE TO COMPLY WITH THIS CHAPTER? cad If you have a new or reconstructed boiler or process heater, you shall comply with this chapter by November 12, 2004 or upon startup of your boiler or process heater, whichever is later.

cbd If you have an existing boiler or process heater, you shall comply with this chapter no later than September 13, 2007.

ccd If you have an area source that increases its emissions or its potential to emit such that it becomes a major source of HAP, subds. 1. and 2. apply to you.

- 1. Any new or reconstructed boiler or process heater at the existing facility shall be in compliance with this chapter upon startup.
- Any existing boiler or process heater at the existing facility shall be in compliance with this chapter within 3 years after the facility becomes a major source.
  - cdd You shall meet the notification requirements in s. NR

462.07 c1d according to the schedule in s. NR 462.07 c1d and in ch. NR 460. Some of the notifications shall be submitted before you are required to comply with the emission limits and work practice standards in this chapter.

- NR 462.015 Implementation and enforcement; compliance. c1d The department may not implement or enforce the provisions of this chapter unless the department revises this chapter in response to EPA[s final rule-making on revisions to the provisions of 40 CFR part 63, Subpart DDDDD, on which this chapter is based, in response to the U.S. Court of Appeals[decision of June 6, 2007 which became effective on July 30, 2007 vacating 40 CFR part 63, Subpart DDDDD.
- **c2d** Notwithstanding s. NR 462.01 c5d, no owner or operator, otherwise subject to this chapter under s. NR 462.01, is required to comply with any of the provisions of this chapter until the department revises this chapter in accordance with sub. c1d. **History:** Emerg. cr. eff. 9-13-07; CR 07-088: cr. Register May 2008 No. 629, eff.
- NR 462.02 What definitions apply to this chapter? For terms not defined in this section, the definitions contained in chs. NR 400 and 460 apply to the terms in this chapter, with definitions in ch. NR 460 taking precedence over definitions in ch. NR 400. If this section defines a term which is also defined in ch. NR 400 or 460, the definition in this section applies in this chapter. In this chapter:
- **c1d** XAnnual capacity factorY means the ratio between the actual heat input to a boiler or process heater from the fuels burned during a calendar year and the potential heat input to the boiler or process heater had it been operated for 8,760 hours during a year at the maximum steady state design heat input capacity.
- **c2d** XBag leak detection systemY means an instrument that is capable of monitoring particulate matter loadings in the exhaust of a fabric filter, i.e., baghouse, in order to detect bag failures. A bag leak detection system includes an instrument that operates on electrodynamic, triboelectric, light scattering, light transmittance or other principle to monitor relative particulate matter loadings.
- **c3d** XBiomass fuelY means unadulterated wood as defined in sub. c49d; wood residue and wood products, such as trees, tree stumps, tree limbs, bark, lumber, sawdust, sander dust, chips, scraps, slabs, millings and shavings; animal litter; vegetative agricultural and silvicultural materials, such as logging residues, nut and grain hulls and chaff, bagasse, orchard prunings, corn stalks, coffee bean hulls and grounds.
- **c4d** XBlast furnace gas fuel-fired boiler or process heaterY means an industrial, commercial or institutional boiler or process heater that receives 90% or more of its total heat input, based on an annual average, from blast furnace gas.
- **c5d** XBoilerY means an enclosed device using controlled flame combustion and having the primary purpose of recovering thermal energy in the form of steam or hot water. Waste heat boilers are excluded from this definition.
- **c6d** XCoalY means all solid fuels classifiable as anthracite, bituminous, subbituminous or lignite by the American Society for Testing and Materials in ASTM D388-99e1, XStandard Classification of Coals by RankY, incorporated by reference in s. NR 484.10 c7d, coal refuse and petroleum coke. This definition includes synthetic fuels derived from coal for the purpose of creating useful heat, including solvent-refined coal, coal-oil mixtures and coal-water mixtures. Coal derived gases are excluded from this definition.
  - **c7d** XCoal refuseY means any by-product of coal mining or

- coal cleaning operations with an ash content greater than 50% by weight and a heating value less than 13,900 kilojoules per kilogram c6,000 Btu per poundd on a dry basis.
- **c8d** XCommercial or institutional boilerY means a boiler used in commercial establishments or institutional establishments, such as medical centers, research centers, institutions of higher education, hotels and laundries, to provide one or more of the following: electricity, steam or hot water.
- **c9d** XConstruction and demolition materialY means waste building materials that result from the construction or demolition operations on houses and commercial and industrial buildings.
- **c10d** cad XDeviationY means any instance in which an affected source subject to this chapter, or an owner or operator of an affected source, fails to meet one of the following:
- Any requirement or obligation established by this chapter, including any emission limit, operating limit or work practice standard.
- 2. Any term or condition that is adopted to implement an applicable requirement in this chapter and that is included in the operating permit for any affected source required to obtain such a permit.
- Any emission limit, operating limit or work practice standard in this chapter during startup, shutdown or malfunction regardless of whether or not the failure is permitted by this chapter.
- cbd A deviation is not always a violation. The determination of whether a deviation constitutes a violation of the standard is up to the discretion of the department.
- **c11d** XDistillate oilY means fuel oils, including recycled oils, that comply with the specifications for fuel oil numbers 1 and 2, as defined by the American Society for Testing and Materials in ASTM D396-02a, XStandard Specification for Fuel OilsY, incorporated by reference in s. NR 484.10 c8d.
- **c12d** XDry control systemY means any emission control system that does not use water or any other liquid as part of the control process, such as a fabric filter control system.
- **c13d** XDry scrubberY means an add-on air pollution control system that injects dry alkaline sorbent cdry injectiond or sprays an alkaline sorbent cspray dryerd to react with and neutralize acid gas in the exhaust stream forming a dry powder material. Sorbent injection systems in fluidized bed boilers and process heaters are included in this definition.
- **c14d** XElectric utility steam generating unitY means a fossil fuel-fired combustion unit of more than 25 megawatts that serves a generator that produces electricity for sale. A fossil fuel-fired unit that cogenerates steam and electricity and supplies more than one-third of its potential electric output capacity and more than 25 megawatts electrical output to any utility power distribution system for sale is considered an electric utility steam generating unit.
- **c15d** XElectrostatic precipitatorY means an add-on air pollution control device used to capture particulate matter by charging the particles using an electrostatic field, collecting the particles using a grounded collecting surface and transporting the particles into a hopper.
- **c16d** XFabric filterY means an add-on air pollution control device used to capture particulate matter by filtering gas streams through filter media, also known as a baghouse.
- **c17d** XFederally enforceableY means all limitations and conditions that are enforceable by the EPA administrator, including the requirements of 40 CFR parts 60 and 61, requirements within any applicable state implementation plan and any permit requirements established under 40 CFR 52.21 or under 40 CFR 51.18 and 40 CFR 51.24.

- **c18d** XFiretube boilerY means a boiler in which hot gases of combustion pass through the tubes and water contacts the outside surfaces of the tubes.
- **c19d** XFossil fuelY means natural gas, petroleum, coal and any form of solid, liquid or gaseous fuel derived from those materials.
- **c20d** XFuel typeY means each category of fuels that share a common name or classification. Examples include bituminous coal, subbituminous coal, lignite, anthracite, biomass, construction and demolition material, salt water laden wood, creosote treated wood, tires and residual oil. Individual fuel types received from different suppliers are not considered new fuel types except for construction and demolition material.
- **c21d** XGaseous fuelY includes natural gas, process gas, landfill gas, coal derived gas, refinery gas and biogas. Blast furnace gas is exempted from this definition.
- **c22d** XHeat inputY means heat derived from combustion of fuel in a boiler or process heater and does not include the heat input from preheated combustion air, recirculated flue gases or exhaust gases from other sources such as gas turbines, internal combustion engines, kilns and other similar sources.
- **c23d** XIndustrial boilerY means a boiler used in manufacturing, processing, mining and refining or any other industry to provide one or more of the following: electricity, steam or hot water.
- **c24d** XLarge gaseous fuel subcategoryY includes any water tube boiler or process heater that burns gaseous fuels not combined with any solid fuels, burns liquid fuel only during periods of gas curtailment or gas supply emergencies, has a rated capacity of greater than 10 mmBtu per hour heat input and has an annual capacity factor of greater than 10%.
- **c25d** XLarge liquid fuel subcategoryY includes any water tube boiler or process heater that does not burn any solid fuel and burns any liquid fuel either alone or in combination with gaseous fuels, has a rated capacity of greater than 10 mmBtu per hour heat input and has an annual capacity factor of greater than 10%. Large gaseous fuel boilers and process heaters that burn liquid fuel during periods of gas curtailment or gas supply emergencies are not included in this definition.
- **c26d** XLarge solid fuel subcategoryY includes any water tube boiler or process heater that burns any amount of solid fuel either alone or in combination with liquid or gaseous fuels, has a rated capacity of greater than 10 mmBtu per hour heat input and has an annual capacity factor of greater than 10%.
- **c27d** XLimited use gaseous fuel subcategory Y includes any water tube boiler or process heater that burns gaseous fuels not combined with any liquid or solid fuels, burns liquid fuel only during periods of gas curtailment or gas supply emergencies, has a rated capacity of greater than 10 mmBtu per hour heat input and has a federally enforceable annual average capacity factor of equal to or less than 10%.
- **c28d** XLimited use liquid fuel subcategoryY includes any water tube boiler or process heater that does not burn any solid fuel and burns any liquid fuel either alone or in combination with gaseous fuels, has a rated capacity of greater than 10 mmBtu per hour heat input and has a federally enforceable annual average capacity factor of equal to or less than 10%. Limited use gaseous fuel boilers and process heaters that burn liquid fuel during periods of gas curtailment or gas supply emergencies are not included in this definition.
- **c29d** XLimited use solid fuel subcategory Y includes any water tube boiler or process heater that burns any amount of solid fuel either alone or in combination with liquid or gaseous fuels, has a rated capacity of greater than 10 mmBtu per hour heat input

- and has a federally enforceable annual average capacity factor of equal to or less than 10%.
- **c30d** XLiquid fossil fuelY means petroleum, distillate oil, residual oil and any form of liquid fuel derived from these fuels.
- **c31d** XLiquid fuelY includes distillate oil, residual oil, waste oil and process liquids.
- **c32d** XMinimum pressure dropY means 90% of the lowest test-run average pressure drop measured according to Table 7 of this chapter during the most recent performance test demonstrating compliance with the applicable emission limit.
- **c33d** XMinimum scrubber effluent pHY means 90% of the lowest test-run average effluent pH measured at the outlet of the wet scrubber according to Table 7 of this chapter during the most recent performance test demonstrating compliance with the applicable hydrogen chloride emission limit.
- **c34d** XMinimum scrubber flow rateY means 90% of the lowest test-run average flow rate measured according to Table 7 of this chapter during the most recent performance test demonstrating compliance with the applicable emission limit.
- **c35d** XMinimum sorbent injection rateY means 90% of the lowest test-run average sorbent or activated carbon flow rate measured according to Table 7 of this chapter during the most recent performance test demonstrating compliance with the applicable emission limits.
- **c36d** XMinimum voltageY, Xminimum secondary currentY or Xminimum total power inputY means 90% of the lowest testrun average voltage or secondary current or total power input to the electrostatic precipitator measured according to Table 7 of this chapter during the most recent performance test demonstrating compliance with the applicable emission limits.
  - **c37d** XNatural gasY means one of the following:
- cad A naturally occurring mixture of hydrocarbon and nonhydrocarbon gases found in geologic formations beneath the earth[s surface, of which the principal constituent is methane.
- cbd Liquid petroleum gas, as defined by the American Society for Testing and Materials in ASTM D1835-03a, XStandard Specification for Liquid Petroleum GasesY, incorporated by reference in s. NR 484.10 c26md.
- **c38d** XOpacityY means the degree to which emissions reduce the transmission of light and obscure the view of an object in the background.
- **c39d** XParticulate matterY means any finely divided solid or liquid material, other than uncombined water, as measured by the test methods specified under this chapter, or an alternative method.
- **c40d** XPeriod of natural gas curtailmentY or Xsupply interruptionY means a period of time during which the supply of natural gas to an affected facility is halted for reasons beyond the control of the facility. An increase in the cost or unit price of natural gas does not constitute a period of natural gas curtailment or supply interruption.
- **c41d** XProcess heaterY means an enclosed device using controlled flame that is not a boiler, and the unit[s primary purpose is to transfer heat indirectly to a process material or to a heat transfer material for use in a process unit, instead of generating steam. Process heaters are devices in which the combustion gases do not directly come into contact with process materials. Process heaters do not include units used for comfort heat or space heat, food preparation for on-site consumption or autoclaves.
- **c42d** XResidual oilY means crude oil and all fuel oil numbers 4, 5 and 6, as defined by the American Society for Testing and Materials in ASTM D396-02a, XStandard Specifications for Fuel OilsY, incorporated by reference in s. NR 484.10 c8d.

**c43d** XSmall gaseous fuel subcategoryY includes any fire tube boiler that burns gaseous fuels not combined with any solid fuels and burns liquid fuel only during periods of gas curtailment or gas supply emergencies, and any boiler or process heater that burns gaseous fuels not combined with any solid fuels, burns liquid fuel only during periods of gas curtailment or gas supply emergencies and has a rated capacity of less than or equal to 10 mmBtu per hour heat input.

**c44d** XSmall liquid fuel subcategoryY includes any fire tube boiler that does not burn any solid fuel and burns any liquid fuel either alone or in combination with gaseous fuels, and any boiler or process heater that does not burn any solid fuel and burns any liquid fuel either alone or in combination with gaseous fuels and has a rated capacity of less than or equal to 10 mmBtu per hour heat input. Small gaseous fuel boilers and process heaters that burn liquid fuel during periods of gas curtailment or gas supply emergencies are not included in this definition.

**c45d** XSmall solid fuel subcategory Y includes any fire tube boiler that burns any amount of solid fuel either alone or in combination with liquid or gaseous fuels, and any other boiler or process heater that burns any amount of solid fuel either alone or in combination with liquid or gaseous fuels and has a rated capacity of less than or equal to 10 mmBtu per hour heat input.

**c46d** XSolid fuelY includes coal, wood, biomass, tires, plastics and other non-fossil solid materials.

**c47d** XTemporary boilerY means any gaseous or liquid fuel boiler that is designed to, and is capable of, being carried or moved from one location to another. A temporary boiler that remains at a location for more than 180 consecutive days is no longer considered to be a temporary boiler. Any temporary boiler that replaces a temporary boiler at a location and is intended to perform the same or similar function will be included in calculating the consecutive time period.

**c48d** XTotal selected metalsY or XTSMY means the combination of the following metallic HAP: arsenic, beryllium, cadmium, chromium, lead, manganese, nickel and selenium.

**c49d** XUnadulterated woodY means wood or wood products that have not been painted, pigment-stained, or pressure treated with compounds such as chromated copper arsenate, pentachlorophenol and creosote. Plywood, particle board, oriented strand board, and other types of wood products bound by glues and resins are included in this definition.

**c50d** XWaste heat boilerY means a device that recovers normally unused energy and converts it to usable heat. Waste heat boilers incorporating duct or supplemental burners that are designed to supply 50% or more of the total rated heat input capacity of the waste heat boiler are not considered waste heat boilers, but are considered boilers. Waste heat boilers are also referred to as heat recovery steam generators.

**c51d** XWater heaterY means a closed vessel with a capacity of no more than 120 U.S. gallons in which water is heated by combustion of gaseous or liquid fuel and is withdrawn for use external to the vessel at pressures not exceeding 160 psig, including the apparatus by which the heat is generated and all controls and devices necessary to prevent water temperatures from exceeding 210vF c99vCd.

**c52d** XWater tube boilerY means a boiler in which water passes through the tubes and hot gases of combustion pass over the outside surfaces of the tubes.

**c53d** XWet scrubberY means any add-on air pollution control device that mixes an aqueous stream or slurry with the exhaust gases from a boiler or process heater to control emissions of

particulate matter or to absorb and neutralize acid gases, such as hydrogen chloride, or both.

**c54d** XWork practice standardY means any design, equipment, work practice or operational standard, or combination thereof, that is promulgated pursuant to section 112chd of the Act

NR 462.03 Emission limits and work practice standards. c1d What are the Subcategories of Boilers and PROCESS HEATERS? The subcategories of boilers and process heaters are large solid fuel, limited use solid fuel, small solid fuel, large liquid fuel, limited use liquid fuel, small liquid fuel, large gaseous fuel, limited use gaseous fuel and small gaseous fuel. Each subcategory is defined in s. NR 462.02.

**c2d** WHAT EMISSION LIMITS, WORK PRACTICE STANDARDS AND OPERATING LIMITS MUST I MEET? cad You shall meet the requirements in subds. 1. and 2.

- 1. You shall meet each emission limit and work practice standard in Table 1 of this chapter that applies to your boiler or process heater, except as provided under s. NR 462.04 c3d.
- 2. You shall meet each operating limit in Tables 2 to 4 of this chapter that applies to your boiler or process heater. If you use a control device or combination of control devices not covered in Tables 2 to 4, or you wish to establish and monitor an alternative operating limit and alternative monitoring parameters, you shall apply to the administrator for approval of alternative monitoring under 40 CFR 63.8cfd.

**Note:** The authority to approve alternative monitoring is retained by the administrator and is not delegated to the department.

cbd As provided in 40 CFR 63.6cgd, EPA may approve use of an alternative to the work practice standards in this section.

NR 462.04 General compliance requirements. c1d WHAT ARE MY GENERAL REQUIREMENTS FOR COMPLYING WITH THIS CHAPTER? cad You shall be in compliance with the emission limits, including operating limits, and the work practice standards in this chapter at all times, except during periods of startup, shutdown and malfunction.

cbd You shall always operate and maintain your affected source, including air pollution control and monitoring equipment, according to the provisions in s. NR 460.05 c4d cad 1.

ccd You may demonstrate compliance with any applicable emission limit using fuel analysis if the emission rate calculated according to s. NR 462.05 c7d cdd is less than the applicable emission limit. Otherwise, you shall demonstrate compliance using performance testing.

cdd If you demonstrate compliance with any applicable emission limit through performance testing, you shall develop a site-specific monitoring plan according to the requirements in subds. 1. to 4. This requirement also applies to you if you petition the EPA administrator for alternative monitoring parameters under 40 CFR 63 8cfd.

**Note:** The authority to approve alternative monitoring parameters is retained by the administrator and is not delegated to the department.

- 1. For each continuous monitoring system cCMSd required in this subsection, you shall develop and submit to the department for approval a site-specific monitoring plan that addresses subd. 1. a. to c. You shall submit this site-specific monitoring plan at least 60 days before your initial performance evaluation of your CMS. The plan shall include all of the following:
- a. Installation of the CMS sampling probe or other interface at a measurement location relative to each affected process unit such that the measurement is representative of control of the ex-

haust emissions, such as on or downstream of the last control device.

- b. Performance and equipment specifications for the sample interface, the pollutant concentration or parametric signal analyzer and the data collection and reduction systems.
- Performance evaluation procedures and acceptance criteria, such as calibrations.
- In your site-specific monitoring plan you shall also address subd. 2. a. to c.
- a. Ongoing operation and maintenance procedures in accordance with the general requirements of s. NR 460.07 c3d cad, ccd and cdd 2.
- b. Ongoing data quality assurance procedures in accordance with the general requirements of s. NR 460.07 c4d.
- c. Ongoing recordkeeping and reporting procedures in accordance with the general requirements of s. NR 460.09 c3d cad and c5d cad and cbd 1.
- 3. You shall conduct a performance evaluation of each CMS in accordance with your site-specific monitoring plan.
- 4. You shall operate and maintain the CMS in continuous operation according to the site-specific monitoring plan.

ced If you have an applicable emission limit or work practice standard, you shall develop and implement a written startup, shutdown and malfunction plan cSSMPd according to the provisions in s. NR 460.05 c4d ccd.

- **c2d** Do any boilers or process heaters have limited requirements? cad New or reconstructed boilers and process heaters in the large liquid fuel subcategory or the limited use liquid fuel subcategory that burn only fossil fuels and other gases and do not burn any residual oil are subject to the emission limits and applicable work practice standards in Table 1 of this chapter. You are not required to conduct a performance test to demonstrate compliance with the emission limits. You are not required to set and maintain operating limits to demonstrate continuous compliance with the emission limits. However, you shall meet the requirements in subds. 1. and 2. and meet the CO work practice standard in Table 1 of this chapter.
- 1. To demonstrate initial compliance, you shall include a signed statement in the notification of compliance status report required in s. NR 462.07 c1d ced that indicates you burn only liquid fossil fuels other than residual oils, either alone or in combination with gaseous fuels.
- 2. To demonstrate continuous compliance with the applicable emission limits, you shall also keep records that demonstrate that you burn only liquid fossil fuels other than residual oils, either alone or in combination with gaseous fuels. You shall also include a signed statement in each semiannual compliance report required in s. NR 462.07 c2d that indicates you burned only liquid fossil fuels other than residual oils, either alone or in combination with gaseous fuels, during the reporting period.

cbd The affected boilers and process heaters listed in subds. 1. to 3. are subject to only the initial notification requirements in s. NR 460.08 c2d. They are not subject to the emission limits, work practice standards, performance testing, monitoring, SSM plans, site-specific monitoring plans, recordkeeping and reporting requirements of this chapter or any other requirements in ch. NR 460.

- 1. Existing large and limited use gaseous fuel units.
- 2. Existing large and limited use liquid fuel units.
- 3. New or reconstructed small liquid fuel units that burn only gaseous fuels or distillate oil. New or reconstructed small liquid fuel boilers and process heaters that commence burning any other type of liquid fuel shall comply with all applicable requirements

of this chapter and ch. NR 460 upon commencing the burning of the other type of liquid fuel.

ccd The affected boilers and process heaters listed in subds. 1. to 4. are not subject to the initial notification requirements in s. NR 460.08 c2d and are not subject to any requirements in this chapter or in ch. NR 460. They are not subject to the emission limits, work practice standards, performance testing, monitoring, SSM plans, site-specific monitoring plans, recordkeeping and reporting requirements of this chapter or any other requirements in ch. NR 460.

- 1. Existing small solid fuel boilers and process heaters.
- 2. Existing small liquid fuel boilers and process heaters.
- 3. Existing small gaseous fuel boilers and process heaters.
- 4. New or reconstructed small gaseous fuel units.

**c3d** What are the Health-Based compliance alternatives for the Hydrogen Chloride and total selected metals Standards? cad As an alternative to the requirement to demonstrate compliance with the HCl emission limit in Table 1 of this chapter, you may demonstrate eligibility for the health-based compliance alternative for HCl emissions under the procedures prescribed in 40 CFR part 63, subpart DDDDD, Appendix A, incorporated by reference in s. NR 484.04 c24md.

cbd As an alternative to the requirement to demonstrate compliance with the TSM emission limit in Table 1 of this chapter based on the sum of emissions for the 8 selected metals, you may demonstrate eligibility for the health-based alternative for manganese emissions under the procedures prescribed in 40 CFR part 63, subpart DDDDD, Appendix A, incorporated by reference in s. NR 484.04 c24md and comply with the TSM emission standards in Table 1 based on the sum of emissions for 7 selected metals, by excluding manganese emissions from the summation of TSM emissions.

**c4d** WHAT PARTS OF THE GENERAL PROVISIONS APPLY TO ME? Appendix DDDDD of ch. NR 460 shows which parts of the general provisions in ch. NR 460 apply to you.

NR 462.05 Testing, fuel analyses and initial compliance requirements. c1d What are My Initial Compliance Requirements. c1d What are My Initial Compliance Requirements and Deadlines? cad For affected sources that elect to demonstrate compliance with any of the emission limits of this chapter through performance testing, your initial compliance requirements include conducting performance tests according to sub. c3d and Table 5 of this chapter, conducting a fuel analysis for each type of fuel burned in your boiler or process heater according to sub. c4d and Table 6 of this chapter, establishing operating limits according to sub. c7d and Table 7 of this chapter, and conducting CMS performance evaluations according to sub. c6d.

cbd For affected sources that elect to demonstrate compliance with the emission limits for HCl, mercury or TSM through fuel analysis, your initial compliance requirement is to conduct a fuel analysis for each type of fuel burned in your boiler or process heater according to sub. c4d and Table 6 of this chapter and establish operating limits according to sub. c7d and Table 8 of this chapter.

ccd For affected sources that have an applicable work practice standard, your initial compliance requirements depend on the subcategory and rated capacity of your boiler or process heater. If your boiler or process heater is in any of the limited use subcategories or has a heat input capacity less than 100 mmBtu per hour, your initial compliance demonstration is conducting a performance test for carbon monoxide according to Table 5 of this chapter. If your boiler or process heater is in any of the large sub-

categories and has a heat input capacity of 100 mmBtu per hour or greater, your initial compliance demonstration is conducting a performance evaluation of your continuous emission monitoring system for carbon monoxide according to sub. c6d cad.

cdd For existing affected sources, you shall demonstrate initial compliance no later than 180 days after the compliance date that is specified for your source in s. NR 462.01 c5d and according to the applicable provisions in s. NR 460.06 c1d cbd as cited in Appendix DDDDD in ch. NR 460.

ced If your new or reconstructed affected source commenced construction or reconstruction between January 13, 2003 and November 12, 2004, you shall demonstrate initial compliance with either the proposed emission limits and work practice standards or the promulgated emission limits and work practice standards no later than 180 days after November 12, 2004 or within 180 days after startup of the source, whichever is later, according to s. NR 460.06 c1d cbd.

cfd If your new or reconstructed affected source commenced construction or reconstruction between January 13, 2003 and November 12, 2004, and you chose to comply with the proposed emission limits and work practice standards when demonstrating initial compliance, you shall conduct a second compliance demonstration for the promulgated emission limits and work practice standards within 3 years after November 12, 2004 or within 3 years after startup of the affected source, whichever is later

cgd If your new or reconstructed affected source commences construction or reconstruction after November 12, 2004, you shall demonstrate initial compliance with the promulgated emission limits and work practice standards no later than 180 days after startup of the source.

**c2d** WHEN MUST I CONDUCT SUBSEQUENT PERFORMANCE TESTS OR FUEL ANALYSES? cad You shall conduct all applicable performance tests according to sub. c3d on an annual basis, unless you follow the requirements listed in pars. cbd to cdd. Annual performance tests shall be completed between 10 and 12 months after the previous performance test, unless you follow the requirements listed in pars. cbd to cdd.

cbd You may conduct performance tests less often for a given pollutant if your performance tests for the pollutant - particulate matter, HCl, mercury or TSM - for at least 3 consecutive years show that you comply with the emission limit. In this case, you do not have to conduct a performance test for that pollutant for the next 2 years. You shall conduct a performance test during the third year and no more than 36 months after the previous performance test.

ccd If your boiler or process heater continues to meet the emission limit for particulate matter, HCl, mercury or TSM, you may choose to conduct performance tests for these pollutants every third year, but each performance test shall be conducted no more than 36 months after the previous performance test.

cdd If a performance test shows noncompliance with an emission limit for particulate matter, HCl, mercury or TSM, you shall conduct annual performance tests for that pollutant until all performance tests over a consecutive 3-year period show compliance.

ced If you have an applicable work practice standard for carbon monoxide and your boiler or process heater is in any of the limited use subcategories or has a heat input capacity less than 100 mmBtu per hour, you shall conduct annual performance tests for carbon monoxide according to sub. c3d. Each annual performance test shall be conducted between 10 and 12 months after the previous performance test.

cfd You shall conduct a fuel analysis according to sub. c4d for

each type of fuel burned no later than 5 years after the previous fuel analysis for each fuel type. If you burn a new type of fuel, you shall conduct a fuel analysis before burning the new type of fuel in your boiler or process heater. You shall still meet all applicable continuous compliance requirements in s. NR 462.06 c2d.

cgd You shall report the results of performance tests and fuel analyses to the department within 60 days after the completion of the performance tests or fuel analyses. This report shall also verify that the operating limits for your affected source have not changed or provide documentation of revised operating parameters established according to sub. c7d and Table 7 of this chapter, as applicable. The reports for all subsequent performance tests and fuel analyses shall include all applicable information required in s. NR 462.07 c2d.

**c3d** What Performance tests and Procedures Must I Use? cad You shall conduct all performance tests according to s. NR 460.06 c2d, c3d, c5d and c7d. You shall also develop a site-specific test plan according to the requirements in s. NR 460.06 c2d if you elect to demonstrate compliance through performance testing.

cbd You shall conduct each performance test according to the requirements in Table 5 of this chapter.

ccd New or reconstructed boilers or process heaters in one of the liquid fuel subcategories that burn only fossil fuels and other gases and do not burn any residual oil shall demonstrate compliance according to s. NR 462.04 c2d cad.

cdd You shall conduct each performance test under the specific conditions listed in Tables 5 and 7 of this chapter. You shall conduct performance tests at the maximum normal operating load while burning the type of fuel or mixture of fuels that have the highest content of chlorine, mercury and total selected metals, and you shall demonstrate initial compliance and establish your operating limits based on these tests. These requirements may result in the need to conduct more than one performance test.

ced You may not conduct performance tests during periods of startup, shutdown or malfunction.

cfd You shall conduct 3 separate test runs for each performance test required in this subsection, as specified in s. NR 460.06 c4d ccd. Each test run shall last at least one hour.

cgd To determine compliance with the emission limits, you shall use the F-factor methodology and equations in sections 12.2 and 12.3 of EPA Method 19 of Appendix A to 40 CFR part 60, incorporated by reference in s. NR 484.04 c13d, to convert the measured particulate matter concentrations, the measured HCl concentrations, the measured TSM concentrations and the measured mercury concentrations that result from the initial performance test to pounds per million Btu heat input emission rates.

**c4d** What fuel analyses and procedures must I use? cad You shall conduct fuel analyses according to the procedures in pars. cbd to ced and Table 6 of this chapter, as applicable.

cbd You shall develop and submit a site-specific fuel analysis plan to the department for review and approval according to the procedures and requirements in subds. 1. and 2.

- 1. You shall submit the fuel analysis plan no later than 60 days before the date that you intend to demonstrate compliance.
- 2. You shall include the information contained in subd. 2. a. to f. in your fuel analysis plan.
- a. The identification of all fuel types anticipated to be burned in each boiler or process heater.
- b. For each fuel type, notification of whether you or a fuel supplier will be conducting the fuel analysis.
- c. For each fuel type, a detailed description of the sample location and specific procedures to be used for collecting and pre-

paring the composite samples if your procedures are different from those in par. ccd or cdd. Where possible, samples should be collected at a location that most accurately represent the fuel type. Samples shall be collected at a point prior to mixing with other dissimilar fuel types.

- d. For each fuel type, the analytical methods, with the expected minimum detection levels, to be used for the measurement of selected total metals, chlorine or mercury.
- e. If you request to use an alternative analytical method other than those required by Table 6 of this chapter, a detailed description of the methods and procedures that will be used.
- f. If you will be using fuel analysis from a fuel supplier in lieu of site-specific sampling and analysis, assurance that the fuel supplier will use the analytical methods required by Table 6 of this chapter.

ccd At a minimum, you shall obtain 3 composite fuel samples for each fuel type according to the procedures in subd. 1. or 2.

- 1. If sampling from a belt or screw feeder, collect fuel samples according to subd. 1. a. and b.
- a. Stop the belt and withdraw a 6-inch wide sample from the full cross-section of the stopped belt to obtain a minimum 2 pounds of sample. Collect all the material, including fine and coarse material, in the full cross-section. Transfer the sample to a clean plastic bag.
- b. Each composite sample shall consist of a minimum of 3 samples collected at approximately equal intervals during the testing period.
- 2. If sampling from a fuel pile or truck, collect fuel samples according to subd. 2. a. to c.
- a. For each composite sample, select a minimum of 5 sampling locations uniformly spaced over the surface of the pile.
- b. At each sampling site, dig into the pile to a depth of 18 inches. Insert a clean flat square shovel into the hole and withdraw a sample, making sure that large pieces do not fall off during sampling.
- c. Transfer all samples to a clean plastic bag for further processing.
- cdd Prepare each composite sample according to the procedures in subds. 1. to 7.
- Thoroughly mix and pour the entire composite sample over a clean plastic sheet.
- 2. Break sample pieces larger than 3 inches into smaller sizes.
- 3. Make a pie shape with the entire composite sample and subdivide it into 4 equal parts.
  - 4. Separate one of the quarter samples as the first subset.
- 5. If this subset is too large for grinding, repeat the procedure in subd. 3. with the quarter sample and obtain a one-quarter subset from this sample.
  - 6. Grind the sample in a mill.
- 7. Use the procedure in subd. 3. to obtain a one-quarter subsample for analysis. If the quarter sample is too large, subdivide it further using the same procedure.
- ced Determine the concentration of pollutants cmercury, chlorine, and total selected metalsd in the fuel in units of pounds per million Btu of each composite sample for each fuel type according to the procedures in Table 6 of this chapter.
- **c5d** CAN I USE EMISSION AVERAGING TO COMPLY WITH THIS CHAPTER? cad As an alternative to meeting the requirements of s. NR 462.03 c2d, if you have more than one existing large solid fuel boiler located at your facility, you may demonstrate compli-

ance by emission averaging according to the procedures in this subsection.

cbd For each existing large solid fuel boiler in the averaging group, the emission rate achieved during the initial compliance test for the HAP being averaged may not exceed the emission level that was being achieved on November 12, 2004, or the control technology employed during the initial compliance test may not be less effective for the HAP being averaged than the control technology employed on November 12, 2004.

ccd You may average particulate matter or TSM, HCl and mercury emissions from existing large solid fuel boilers to demonstrate compliance with the limits in Table 1 of this chapter if you satisfy the requirements in pars. cdd, ced and cfd.

cdd The weighted average emissions from the existing large solid fuel boilers participating in the emissions averaging option shall be in compliance with the limits in Table 1 of this chapter at all times following the compliance date specified in s. NR 462.01 c5d.

- 1. You shall submit the implementation plan no later than 180 days before the date that the facility intends to demonstrate compliance using the emission averaging option.
- 2. You shall include the information required in subd. 2. a. to g. in your implementation plan for all emission sources included in an emission averaging group.
- a. The identification of all existing large solid fuel boilers in the averaging group, including for each boiler either the applicable HAP emission level or the installed control technology.
- b. The process parameter, either heat input or steam generated, that will be monitored for each averaging group of large solid fuel boilers.
- c. The specific control technology or pollution prevention measure to be used for each emission source in the averaging group and the date of its installation or application. If the pollution prevention measure reduces or eliminates emissions from multiple sources, the owner or operator shall identify each source.
- d. The test plan for the measurement of particulate matter or TSM, HCl or mercury emissions in accordance with the requirements in sub. c3d.
- e. The operating parameters to be monitored for each control system or device and a description of how the operating limits will be determined.
- f. If you request to monitor one or more alternative operating parameters pursuant to sub. c6d, a description of the parameter or parameters to be monitored, an explanation of the criteria used to select the parameter or parameters and a description of the methods and procedures that will be used to demonstrate that the parameter indicates proper operation of the control device. You shall also include the frequency and content of monitoring, reporting and recordkeeping requirements and a demonstration, to the satisfaction of the department, that the proposed monitoring frequency is sufficient to represent control device operating conditions.
- g. A demonstration that compliance with each of the applicable emission limits will be achieved under representative operating conditions.
- 3. Upon receipt, the department shall review and approve or disapprove the plan according to both of the following criteria:
- a. Whether the content of the plan includes all of the information specified in subd. 2.
- b. Whether the plan presents sufficient information to determine that compliance will be achieved and maintained.
- 4. The department may not approve an emission averaging implementation plan containing any of the following provisions:
- Any averaging between emissions of differing pollutants or between differing sources.
- b. The inclusion of any emission source other than an existing large solid fuel boiler.

**c6d** WHAT ARE MY MONITORING, INSTALLATION, OPERATION AND MAINTENANCE REQUIREMENTS? cad If you have an applicable work practice standard for carbon monoxide and your boiler or process heater is in any of the large subcategories and has a heat input capacity of 100 mmBtu per hour or greater, you shall install, operate and maintain a continuous emission monitoring system cCEMSd for carbon monoxide according to the procedures in subds. 1. to 6. by the compliance date specified in s. NR 462.01 c5d.

1. Each CEMS shall be installed, operated and maintained according to Performance Specification cPSd 4A of 40 CFR part

- 60, Appendix B, incorporated by reference in s. NR 484.04 c21d, and according to the site-specific monitoring plan developed according to s. NR 462.04 c1d cdd.
- 2. You shall conduct a performance evaluation of each CEMS according to the requirements in s. NR 460.07 and according to PS 4A of 40 CFR part 60, Appendix B, incorporated by reference in s. NR 484.04 c21d.
- 3. Each CEMS shall complete a minimum of one cycle of operation, which includes sampling, analyzing and data recording, for each successive 15-minute period.
- 4. The CEMS data shall be reduced as specified in s. NR 460.07 c7d cbd.
- 5. You shall calculate and record a 30-day rolling average emission rate on a daily basis. A new 30-day rolling average emission rate is calculated as the average of all of the hourly CO emission data for the preceding 30 operating days.
- 6. For purposes of calculating data averages, you may not use data recorded during periods of monitoring malfunctions, associated repairs, out-of-control periods, required quality assurance or control activities or when your boiler or process heater is operating at less than 50% of its rated capacity. You shall use all the data collected during all other periods in assessing compliance. Any period for which the monitoring system is out of control and data are not available for required calculations constitutes a deviation from the monitoring requirements.
- cbd If you have an applicable opacity operating limit, you shall install, operate, certify and maintain each continuous opacity monitoring system cCOMSd according to the procedures in subds. 1. to 7. by the compliance date specified in s. NR 462.01 c5d.
- 1. Each COMS shall be installed, operated and maintained according to PS 1 of 40 CFR part 60, Appendix B, incorporated by reference in s. NR 484.04 c21d.
- 2. You shall conduct a performance evaluation of each COMS according to the requirements in s. NR 460.07 and according to PS 1 of 40 CFR part 60, Appendix B, incorporated by reference in s. NR 484.04 c21d.
- 3. As specified in s. NR 460.07 c3d cdd 1., each COMS shall complete a minimum of one cycle of sampling and analyzing for each successive 10-second period and one cycle of data recording for each successive 6-minute period.
- The COMS data shall be reduced as specified in s. NR 460.07 c7d cbd.
- 5. You shall include in your site-specific monitoring plan procedures and acceptance criteria for operating and maintaining each COMS according to the requirements in s. NR 460.07 c4d. At a minimum, the monitoring plan shall include a daily calibration drift assessment, a quarterly performance audit and an annual zero alignment audit of each COMS.
- 6. You shall operate and maintain each COMS according to the requirements in the monitoring plan and the requirements of s. NR 460.07 c5d. Identify periods the COMS is out of control, including any periods that the COMS fails to pass a daily calibration drift assessment, a quarterly performance audit or an annual zero alignment audit.
- 7. You shall determine and record all the 6-minute averages, and one-hour block averages, as applicable, collected for periods during which the COMS is not out of control.
- ccd If you have an operating limit that requires the use of a CMS, you shall install, operate and maintain each continuous parameter monitoring system cCPMSd according to the procedures in subds. 1. to 5. by the compliance date specified in s. NR 462.01 c5d.

- 1. The CPMS shall complete a minimum of one cycle of operation for each successive 15-minute period. You shall have a minimum of 4 successive cycles of operation to have a valid hour of data.
- 2. Except for monitoring malfunctions, associated repairs and required quality assurance or control activities, including, as applicable, calibration checks and required zero and span adjustments, you shall conduct all monitoring in continuous operation at all times that the unit is operating. A monitoring malfunction is any sudden, infrequent, not reasonably preventable failure of the monitoring to provide valid data. Monitoring failures that are caused in part by poor maintenance or careless operation are not malfunctions.
- 3. For purposes of calculating data averages, you may not use data recorded during monitoring malfunctions, associated repairs, out of control periods or required quality assurance or control activities. You shall use all the data collected during all other periods in assessing compliance. Any period for which the monitoring system is out-of-control and data are not available for required calculations constitutes a deviation from the monitoring requirements.
- 4. Determine the 3-hour block average of all recorded readings, except as provided in subd. 3.

cbd Except for monitor malfunctions, associated repairs and required quality assurance or control activities, including, as applicable, calibration checks and required zero and span adjustments, you shall monitor continuously, or collect data at all required intervals, at all times that the affected source is operating.

ccd You may not use data recorded during monitoring malfunctions, associated repairs or required quality assurance or control activities in data averages and calculations used to report emission or operating levels. You shall use all the data collected during all other periods in assessing the operation of the control device and associated control system. Boilers and process heaters that have an applicable carbon monoxide work practice standard and are required to install and operate a CEMS may not use data recorded during periods when the boiler or process heater is operating at less than 50% of its rated capacity.

**c2d** HOW DO I DEMONSTRATE CONTINUOUS COMPLIANCE WITH THE EMISSION LIMITS AND WORK PRACTICE STANDARDS? cad You shall demonstrate continuous compliance with each

cbd As specified in s. NR 460.08 c2d cbd, if you start up your affected source before November 12, 2004, you shall submit an initial notification not later than 120 days after November 12, 2004. The initial notification shall include the information required in subds. 1. and 2., as applicable.

- 1. If your affected source has an annual capacity factor of greater than 10%, your initial notification shall include the information required by s. NR 460.08 c2d cbd.
- 2. If your affected source has a federally enforceable permit that limits the annual capacity factor to less than or equal to 10% such that the unit is in one of the limited use subcategories, as defined in s. NR 462.02 c27d to c29d, your initial notification shall include the information required by s. NR 460.08 c2d cbd, and a signed statement indicating that your affected source has a federally enforceable permit that limits the annual capacity factor to less than or equal to 10%.

cdd If you are required to conduct a performance test, you shall submit a notification of intent to conduct a performance test at least 30 days before the performance test is scheduled to begin.

- ced If you are required to conduct an initial compliance demonstration as specified in s. NR 462.05 c7d cad, you shall submit a notification of compliance status according to s. NR 460.08 c8d cbd 2. For each initial compliance demonstration, you shall submit the notification of compliance status, including all performance test results and fuel analyses, before the close of business on the 60th day following the completion of the performance test and other initial compliance demonstrations according to s. NR 460.09 c4d cbd. The notification of compliance status report shall contain all the information specified in subds. 1. to 9., as applicable.
- 1. A description of the affected source, including identification of which subcategory the source is in, the capacity of the source, a description of the add-on controls used on the source, a description of the fuels burned and justification for the fuels burned during the performance test.
- 2. A summary of the results of all performance tests, fuel analyses and calculations conducted to demonstrate initial compliance, including all established operating limits.
- 3. Identification of whether you are complying with the particulate matter emission limit or the alternative total selected metals emission limit.
- 4. Identification of whether you plan to demonstrate compliance with each applicable emission limit through performance testing or fuel analysis.
- 5. Identification of whether you plan to demonstrate compliance by emissions averaging.
- A signed certification that you have met all applicable emission limits and work practice standards.
- 7. A summary of carbon monoxide emissions monitoring data and the maximum carbon monoxide emission levels recorded during the performance test to show that you have met any applicable work practice standard in Table 1 of this chapter.
- 8. If your new or reconstructed boiler or process heater is in one of the liquid fuel subcategories and burns only liquid fossil fuels other than residual oil either alone or in combination with gaseous fuels, you shall submit a signed statement certifying this in your notification of compliance status report.
- If you had a deviation from any emission limit or work practice standard, you shall also submit a description of the devi-

ation, the duration of the deviation and the corrective action taken in the notification of compliance status report.

**c2d** WHAT REPORTS MUST I SUBMIT AND WHEN? cad You shall submit each report in Table 9 of this chapter that applies to you.

cbd Unless the department has approved a different schedule for submission of reports under s. NR 460.09 c1d, you shall submit each report by the date in Table 9 of this chapter and according to the requirements in subds. 1. to 5.

- 1. The first compliance report shall cover the period beginning on the compliance date that is specified for your affected source in s. NR 462.01 c5d and ending on June 30 or December 31, whichever date is the first date that occurs at least 180 days after the compliance date specified for your source in s. NR 462.01 c5d.
- 2. The first compliance report shall be postmarked or delivered no later than July 31 or January 31, whichever date is the first date following the end of the first calendar half after the compliance date that is specified for your source in s. NR 462.01 c5d.
- 3. Each subsequent compliance report shall cover the semiannual reporting period from January 1 through June 30 or the semiannual reporting period from July 1 through December 31.
- 4. Each subsequent compliance report shall be postmarked or delivered no later than July 31 or January 31, whichever date is the first date following the end of the semiannual reporting period.
- 5. For each affected source that is subject to permitting regulations pursuant to ch. ccd The compliance report shall contain the information required in subds. 1. to 11.

- 1. Company name and address.
- 2. A statement by a responsible official with that official[s name, title and signature, certifying the truth, accuracy and completeness of the content of the report.
- 3. Date of the report and beginning and ending dates of the reporting period.
- 4. The total fuel use by each affected source subject to an emission limit for each calendar month within the semiannual reporting period, including a description of the fuel and the total amount of fuel used with units of measure.
- 5. A summary of the results of the annual performance tests and documentation of any operating limits that were reestablished during this test, if applicable.
- 6. A signed statement indicating that you burned no new types of fuel. Or, if you did burn a new type of fuel, you shall do all of the following:
- a. For sources that demonstrate compliance through performance testing, submit the calculation of chlorine input, using Equation 5 of s. NR 462.05 c7d, that demonstrates that your source is still within its maximum chlorine input level established during the previous performance testing. For boilers or process heaters that demonstrate compliance through fuel analysis, submit the calculation of HCl emission rate, using Equation 9 of s. NR 462.05 c7d, that demonstrates that your source is still meeting the emission limit for HCl emissions.
- b. For sources that demonstrate compliance through performance testing, submit the calculation of TSM input, using Equa-

tion 6 of s. NR 462.05 c7d, that demonstrates that your source is still within its maximum TSM input level established during the previous performance testing. For boilers or process heaters that demonstrate compliance through fuel analysis, submit the calculation of TSM emission rate using Equation 10 of s. NR 462.05 c7d that demonstrates that your source is still meeting the emission limit for TSM emissions.

- c. For sources that demonstrate compliance through performance testing, submit the calculation of mercury input, using Equation 7 of s. NR 462.05 c7d, that demonstrates that your source is still within its maximum mercury input level established during the previous performance testing. For boilers or process heaters that demonstrate compliance through fuel analysis, submit the calculation of mercury emission rate using Equation 11 of s. If there are no deviations from any emission limits or operating limits in this chapter that apply to you, and there are no deviations from the requirements for work practice standards in this chapter, a statement that there were no deviations from the emission limits, operating limits or work practice standards during the reporting period.
- 11. If there were no periods during which the continuous monitoring systems cCMSd, including CEMS, COMS and CPMS, were out of control as specified in s. NR 460.07 c3d cgd, a statement that there were no periods during which the CMS were out of control during the reporting period.
- cdd For each deviation from an emission limit or operating limit in this chapter and for each deviation from the requirements for work practice standards in this chapter that occurs at an affected source where you are not using a CMS to comply with that emission limit, operating limit or work practice standard, the compliance report shall contain the information in par. ccd 1. to 10. and the information in subds. 1. to 4. This includes periods of startup, shutdown and malfunction.
- 1. The total operating time of each affected source during the reporting period.
- A description of the deviation and which emission limit, operating limit or work practice standard from which you deviated.
- 3. Information on the number, duration and cause of deviations, including unknown cause, as applicable, and the corrective action taken.
- 4. A copy of the test report if the annual performance test showed a deviation from the emission limit for particulate matter or the alternative TSM limit, a deviation from the HCl emission limit or a deviation from the mercury emission limit.
  - ced For each deviation from an emission limitation, operating

limit or work practice standard in this chapter occurring at an affected source where you are using a CMS to comply with that emission limit, operating limit or work practice standard, you shall include the information in par. ccd 1. to 10. and the information required in subds. 1. to 12. This includes periods of startup, shutdown and malfunction and any deviations from your site-specific monitoring plan as required in s. NR 462.04 c1d cdd.

- 1. The date and time that each malfunction started and stopped and a description of the nature of the deviation, i.e., what you deviated from.
- 2. The date and time that each CMS was inoperative, except for zero clow-leveld and high-level checks.
- 3. The date, time and duration that each CMS was out of control, including the information in s. NR 460.07 c3d chd.
- 4. The date and time that each deviation started and stopped and whether each deviation occurred during a period of startup, shutdown or malfunction or during another period.
- 5. A summary of the total duration of the deviation during the reporting period and the total duration as a percent of the total source operating time during that reporting period.

- cfd Each affected source that has obtained a title V operating permit pursuant to ch. NR 407 or 40 CFR part 71 shall report all deviations as defined in this chapter in the semiannual monitoring report required by s. NR 407.09 c1d ccd 3. a. or 40 CFR 71.6cadc3dciiidcAd. If an affected source submits a compliance report pursuant to Table 9 of this chapter along with, or as part of, the semiannual monitoring report required by s. NR 407.09 c1d ccd 3. a. or 40 CFR 71.6cadc3dciiidcAd, and the compliance report includes all required information concerning deviations from any emission limit, operating limit or work practice standard in this chapter, submission of the compliance report satisfies any obligation to report the same deviations in the semiannual monitoring report. cbd For each CEMS, CPMS and COMS, you shall keep records according to subds. 1. to 5.

- 1. Records described in s. NR 460.09 c2d cbd 6. to 11.
- 2. Monitoring data for a continuous opacity monitoring system during a performance evaluation as required in s. NR 460.05 c6d cfd 1, and 2.
- 3. Previous, i.e., superseded, versions of the performance evaluation plan as required in s. NR 460.07 c4d ccd.
- Request for alternatives to relative accuracy test for CEMS as required in s. NR 460.07 c6d ced 1.
- 5. Records of the date and time that each deviation started and stopped and whether the deviation occurred during a period of startup, shutdown or malfunction or during another period.
- ccd You shall keep the records required in Table 8 of this chapter, including records of all monitoring data and calculated averages for applicable operating limits, such as opacity, pressure drop, carbon monoxide and pH, to show continuous compliance with each emission limit, operating limit and work practice standard that applies to you.

ced If your boiler or process heater is subject to an emission limit or work practice standard in Table 1 of this chapter and has a federally enforceable permit that limits the annual capacity factor to less than or equal to 10% such that the unit is in one of the limited use subcategories, you shall keep the records in subds. 1. and 2.

- 1. A copy of the federally enforceable permit that limits the annual capacity factor of the source to less than or equal to 10%.
- Fuel use records for the days the boiler or process heater was operating.

**c4d** IN WHAT FORM AND HOW LONG MUST I KEEP MY RECORDS? cad Your records shall be in a form suitable and readily available for expeditious review, according to s. NR 460.09 c2d cad.

**c5d** WHO IMPLEMENTS AND ENFORCES THIS CHAPTER? EPA has delegated authority to the department to implement and enforce this chapter, but EPA retains oversight and can take enforcement actions, as appropriate.
