



2019 ASSEMBLY BILL 1007

March 20, 2020 - Introduced by Representatives SPIROS and SUBECK, cosponsored by Senators BERNIER, HANSEN and JACQUE. Referred to Committee on Transportation.

1 **AN ACT to repeal** 16.956 (6); and **to amend** 16.956 (2), 16.956 (4) (cm), 20.505
2 (1) (s) and 20.505 (1) (sa) of the statutes; **relating to:** diesel truck idling
3 reduction grants and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill eliminates the December 31, 2021, sunset for the diesel truck idling reduction grant program, under which the Department of Administration makes grants to cover a portion of a grant recipient's cost to purchase and field test devices that reduce the long-duration idling of diesel trucks.

4 **SECTION 1.** 16.956 (2) of the statutes is amended to read:
5 16.956 (2) **AUTHORITY.** ~~Beginning on July 1, 2006, and ending on June 30, 2020,~~
6 the The department may award a grant to an eligible applicant for the purchase and
7 field testing of one or more idling reduction units as provided in subs. (3) and (4).

1 **SECTION 2.** 16.956 (4) (cm) of the statutes is amended to read:

2 16.956 (4) (cm) Subject to par. (d), the department may make grants under this
3 section ~~from July 1, 2009 to June 30, 2020~~, of 50 percent of the eligible costs for an
4 idling reduction unit installed on a truck tractor, unless the department has
5 previously awarded a grant under this section for an idling reduction unit installed
6 on the truck tractor.

7 **SECTION 3.** 16.956 (6) of the statutes is repealed.

8 **SECTION 4.** 20.505 (1) (s) of the statutes is amended to read:

9 20.505 (1) (s) *Diesel truck idling reduction grant administration.* From the
10 petroleum inspection fund, the amounts in the schedule for administering the Diesel
11 Truck Idling Reduction Grant Program under s. 16.956. ~~No funds may be
12 encumbered under this paragraph after December 31, 2021.~~

13 **SECTION 5.** 20.505 (1) (sa) of the statutes is amended to read:

14 20.505 (1) (sa) *Diesel truck idling reduction grants.* From the petroleum
15 inspection fund, the amounts in the schedule for diesel truck idling reduction grants
16 under s. 16.956. ~~No funds may be encumbered under this paragraph after June 30,
17 2020.~~
