2019 ASSEMBLY BILL 1019

March 26, 2020 – Introduced by Representatives Considine, B. Meyers, Milroy, C. Taylor, Zamarripa, Spreitzer, Hebl, Sargent, Sinicki, Shankland, Ohnstad, Billings, Neubauer and Gruszynski, cosponsored by Senators Bewley, Smith, Schachtner, Erpenbach, Ringhand, Carpenter and Larson. Referred to Committee on Rules.

1 AN ACT *to create* 20.395 (2) (af) and 86.52 of the statutes; **relating to:** creating 2 a flood mitigation program in the Department of Transportation, granting 3 rule-making authority, and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill requires the Department of Transportation to administer a flood mitigation program to provide counties, cities, towns, and villages with grants reimbursing up to 50 percent of the cost of modifying, replacing, or relocating highway culverts or bridges at risk of substantial impact from flooding.

Any grant of money under the program 18 shall be paid from the appropriation under s. 20.395 (2) (af). (3) REIMBURSEMENT OF IMPROVEMENTS. All costs of an improvement funded 19 20under this section shall be the responsibility of the political subdivision. Prior to the 21commencement of an improvement, the political subdivision may apply to the department for reimbursement of not more than 50 percent of eligible costs in the 2223manner and form prescribed by the department.
