## 2019 ASSEMBLY BILL 791

January 24, 2020 – Introduced by Representatives KRUG, KURTZ, SUMMERFIELD, NOVAK, SHANKLAND, POPE, HEBL, KITCHENS, EDMING, FELZKOWSKI, OLDENBURG, VANDERMEER, KOLSTE, TRANEL, DOYLE, BALLWEG, CONSIDINE, ANDERSON, GRUSZYNSKI, NEUBAUER, MURSAU, KULP, MAGNAFICI, PETRYK, SWEARINGEN, PLUMER, C. #### Analysis by the Legislative Reference Bureau

2017 Wisconsin Act 59, the 2017 biennial budget act, repealed, effective June 30, 2021, a grant program the Department of Safety and Professional Services administers to provide grants to persons and businesses that are served by failing private on-site wastewater treatment systems (POWTS), which are commonly known as septic tanks. This bill delays the elimination of the POWTS grant program to June 30, 2023.

The bill requires DSPS to prepare literature that describes the eligibility for receiving a POWTS grant for a residence. Under the bill, DSPS supplies the literature to counties, and counties must distribute the literature to recipients of public benefits.
