## 2019 SENATE BILL 907

March 26, 2020 – Introduced by Senator JACQUE, cosponsored by Representatives SCHRAA and WICHGERS. Referred to Committee on Health and Human Services.

AN ACT to amend 40.51 (8), 40.51 (8m), 66.0137 (4), 120.13 (2) (g), 185.983 (1) (intro.) and 609.83; and to create 632.862 of the statutes; relating to: application of prescription drug payments for health coverage.

#### Analysis by the Legislative Reference Bureau

This bill requires health insurance policies that offer prescription drug benefits, self-insured health plans, and pharmacy benefit managers acting on behalf of policies or plans to apply amounts paid for prescription drugs by or on behalf of a person covered under the policy or plan to any calculation of an out-of-pocket maximum or to any cost-sharing requirement of the policy or plan. Health insurance policies are referred to in the bill as disability insurance policies.

#### **SECTION 8. Initial applicability.**

(1) (a) For policies and plans containing provisions inconsistent with this act,
the act first applies to policy or plan years beginning on January 1 of the year
following the year in which this paragraph takes effect, except as provided in par. (b).

1 (b) For policies or plans that are affected by a collective bargaining agreement 2 containing provisions inconsistent with this act, this act first applies to policy or plan 3 years beginning on the effective date of this paragraph or on the day on which the 4 collective bargaining agreement is newly established, extended, modified, or 5 renewed, whichever is later.
