1 AN ACT to create 20.285 (1) (cm) of the statutes; relating to: funding for 2 University of Wisconsin System student health services and special education 3 aid and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill provides funding to the University of Wisconsin System for additional or improved student health services related to mental and behavioral health.

The bill also provides additional funding for special education aid the Department of Public Instruction pays to school districts, independent charter schools, cooperative educational service agencies, and county children with disabilities education boards.
