## 2021 SENATE BILL 520

#### Analysis by the Legislative Reference Bureau

Under current law, in 2017 Wisconsin Act 185, section 110 (7), the Department of Corrections is required to administer a program under which DOC establishes or constructs one or more Type 1 juvenile correctional facilities, subject to the approval of the Joint Committee on Finance. This bill authorizes \$41,791,000 in general fund supported borrowing for the purpose of constructing a new Type 1 juvenile correctional facility under that program in Milwaukee County.

3	<b>SECTION 1.</b> 20.866 (2) (uz) of the statutes is amended to read:
4	20.866 (2) (uz) Corrections; juvenile correctional facilities. From the capital
5	improvement fund, a sum sufficient for the department of corrections to acquire,
6	construct, develop, enlarge or improve juvenile correctional facilities. The state may

### SECTION 2. Nonstatutory provisions.

5 (1) 2017-19 AUTHORIZED STATE BUILDING PROGRAM CHANGES; TYPE 1 JUVENILE 6 CORRECTIONAL FACILITY. In 2017 Wisconsin Act 59, section 9104 (1) (c) 1. em., as 7 created by 2017 Wisconsin Act 185, under projects financed by general fund 8 supported borrowing, the amount authorized for the project identified as "Type 1 9 juvenile correctional facilities — statewide" is increased by \$41,791,000, and the 10 appropriate totals are adjusted accordingly, for the purpose of constructing a new 11 Type 1 juvenile correctional facility in Milwaukee County.
