Analysis by the Legislative Reference Bureau

This bill allows the Department of Agriculture, Trade and Consumer Protection to provide grants to food banks, food pantries, and other nonprofit organizations to purchase Wisconsin food products. The bill creates a new biennial appropriation of \$15,000,000 to DATCP for this purpose.
