## **2023 SENATE BILL 774**

December 8, 2023 – Introduced by Senators Smith, Larson, Roys, Hesselbein, Agard, Taylor and Spreitzer, cosponsored by Representatives Doyle, Palmeri, Ratcliff, Considine, Stubbs, Moore Omokunde, Conley, Emerson, Joers, Subeck, Jacobson, J. Anderson, Neubauer, Baldeh, Ohnstad, Clancy, Shankland, Shelton, Sinicki, Vining, C. Anderson and Madison. Referred to Committee on Agriculture and Tourism.

1 AN ACT *to amend* 92.14 (3) (intro.) and 92.14 (5r); and *to create* 20.115 (7) (f) 2 and 92.14 (3) (am) of the statutes; **relating to:** county conservation staff for 3 climate change resiliency purposes and making an appropriation.

## Analysis by the Legislative Reference Bureau

Under current law, as part of the Soil and Water Resource Management program, the Department of Agriculture, Trade and Consumer Protection provides funding to counties for county conservation staffing. Current law specifies the activities that county conservation staff may engage in with funding provided under this program. This bill provides that this program may be used to fund county conservation staff who focus on climate change and climate change resiliency. The bill provides \$1,800,000 in GPR funding for this purpose. Under the bill, a county that seeks funding for this purpose must specifically indicate so in its annual grant request.

## SENATE BILL 774

1 **SECTION 5.** 92.14 (5r) of the statutes is amended to read:  $\mathbf{2}$ 92.14 (5r) ANNUAL GRANT REQUEST. Every land conservation committee shall 3 prepare annually a grant request that describes the land and water resource staffing needs and activities to be undertaken or funded by the county under this chapter and 4 ss. 281.65 and 281.66 and the funding needed for those purposes. The grant request  $\mathbf{5}$ 6 shall specifically state any request for funding for climate change personnel under 7 <u>sub. (3) (am).</u> The grant request shall be consistent with the county's plan under s. 8 92.10. The land conservation committee shall submit the grant request to the 9 department. 10 **SECTION 6. Effective date.** 11 (1) This act takes effect on the day after publication, or on the 2nd day after publication of the 2023 biennial budget act, whichever is later. 12
