Analysis by the Legislative Reference Bureau

Under this bill, the Department of Public Instruction must provide stipends to individuals who are 1) enrolled in an undergraduate or graduate program leading to licensure as a school social worker and 2) placed as a school social worker intern in a public school governed by a school board.

13	provide payments to individuals who are all of the following:
14	(1) Enrolled in an institution of higher education or an accredited graduate
15	school in a program of study leading to licensure as a school social worker.
16	(2) Placed as a school social worker intern in a public school governed by a
17	school board.
18	SECTION 4. Effective date.
19	(1) This act takes effect on the day after publication, or on the 2nd day after
20	publication of the 2025 biennial budget act, whichever is later.
