1 **Relating to:** honoring the life and public service of Assembly Chief Clerk Patrick
2 Fuller.

3 Whereas, Patrick Eli Fuller was born to Sam and Irene Fuller on February 24,
4 1954, in Rossford, Ohio; and

5 Whereas, Chief Clerk Fuller graduated from St. Francis de Sales High School,
6 received a bachelor's degree in history from the University of Toledo, and received a
7 master's of business administration from Touro University; and

8 Whereas, Chief Clerk Fuller enlisted in the United States Marine Corps as an
9 infantryman, serving as a team leader, squad leader, infantry instructor, and
10 platoon sergeant; and

11 Whereas, Chief Clerk Fuller was later commissioned as a second lieutenant of
12 marines from Officer Candidates School; and

13 Whereas, Chief Clerk Fuller then served as platoon commander, company
14 commander, and assistant operations officer in the 2nd Reconnaissance Battalion,

1 2nd Marine Division, as well as a course team director at the Amphibious
2 Reconnaissance School, Naval Amphibious Base; and

3 Whereas, Chief Clerk Fuller, after serving 13 years in the United States
4 Marine Corps, transferred to the United States Army, serving as a battalion
5 logistics officer and later a company commander within the 82nd Airborne Division;
6 and

7 Whereas, Chief Clerk Fuller was deployed in support of Operation Desert
8 Shield and Operation Desert Storm as commander of the Long Range Surveillance
9 Detachment, 82nd Airborne Division, and then became company commander of the
10 Long Range Surveillance Company, XVIII Airborne Corps; and

11 Whereas, Chief Clerk Fuller retired in 1997 as battalion executive officer, 6th
12 Infantry Division, with the rank of lieutenant colonel; and

13 Whereas, over his 25-year career in the United States military, Chief Clerk
14 Fuller received the Meritorious Service Medal, Navy Marine Corps Commendation
15 Medal, Navy Achievement Medal, Marine Corps Expedition Medal, Marine Corps
16 Good Conduct Medal, National Defense Service Medal, Navy Unit Commendation,
17 Army Service Medal, Sea Service Deployment Ribbon, Southwest Asia Service
18 Medal, Kuwait Liberation Medal, Combat Infantry Badge, Expert Infantry Badge,
19 Master Parachutist Badge, Pathfinder Badge, Ranger Tab, Combat Diver Badge,
20 Marine Corps Expert Rifle Badge, Marine Corps Expert Pistol Badge, Bronze Rifle
21 Medal for Competitive Shooting, Israeli Parachute Badge, Australia Parachute
22 Badge, German Parachute Badge, and Holland M. Smith Award and was also an
23 NRA master for the high power rifle; and

1 Whereas, Chief Clerk Fuller was appointed as assistant assembly chief clerk
2 in 2001; and

3 Whereas, Chief Clerk Fuller was elected as assembly chief clerk in 2003; and

4 Whereas, Chief Clerk Fuller earned the respect of many state officials and
5 employees for his management of assembly operations, as well as his assistance
6 with state government procedures and issues; and

7 Whereas, Chief Clerk Fuller retired from his position as assembly chief clerk
8 in 2021, having served the assembly across 10 legislative sessions with both
9 Republican and Democratic majorities; and

10 Whereas, Chief Clerk Fuller and his wife Cheryl Fuller, whom he married in
11 August of 1981, were respected members of both their parish and local community;
12 and

13 Whereas, Chief Clerk Fuller was a loving husband to his wife Cheryl, father to
14 his son Samuel John Fuller, and grandfather to his grandson Nikoli Fuller; and

15 Whereas, Chief Clerk Fuller passed away on January 30, 2025, at the age of
16 70; and

17 Whereas, Chief Clerk Fuller is missed by his family, friends, fellow service
18 members, and colleagues; now, therefore, be it

19 ***Resolved by the assembly, the senate concurring, That*** the members of
20 the Wisconsin State Legislature join in honoring the life and public service of
21 Assembly Chief Clerk Patrick Fuller and extend their condolences to his family and
22 friends.
