### *Analysis by the Legislative Reference Bureau*

In the case of *Citizens United v. F.E.C.*, the U.S. Supreme Court ruled that corporations are “persons” for the purpose of political speech, thus allowing corporations to make unlimited expenditures in political campaigns. The U.S. Constitution grants Congress the power to propose amendments to the Constitution that become effective when ratified by the legislatures of three-fourths of the states. Amendments can have the effect of overturning—in effect repealing—prior decisions of the Supreme Court. This resolution places a question on the November 2026 ballot to ask the people if Congress should propose an amendment to overturn *Citizens United v. F.E.C.*

- 2             **Resolved by the assembly, the senate concurring, That** the following  
3     question be submitted, for advisory purposes only, to the voters of this state at the  
4     general election to be held in November 2026:

- 5             **QUESTION 1: *Overturning Citizens United.*** “The U.S. Supreme Court’s  
6     decisions in *Citizens United* and related cases allow unlimited spending to influence  
7     local, state, and federal elections. To allow all Americans to have an equal say in

1     our democracy, shall Wisconsin's congressional delegation support, and the  
2     Wisconsin Legislature ratify, an amendment to the U.S. Constitution stating:

3             1.   Only human beings are *endowed* with constitutional rights—not  
4     corporations, unions, nonprofit organizations, or other artificial entities; and

5             2.   Money is not speech, and therefore limiting political contributions and  
6     spending is not equivalent to limiting political speech?"
