April 14, 2025 - Introduced by Senators CABRAL-GUEVARA and TESTIN, cosponsored by Representatives RODRIGUEZ, SNYDER, DITTRICH, GUNDRUM, KNODL, MELOTIK, MURPHY, O'CONNOR, WICHGERS and DUCHOW. Referred to Committee on Health.

SENATE BILL 190***Analysis by the Legislative Reference Bureau*****RESPIRATORY CARE INTERSTATE COMPACT**

This bill ratifies and enters Wisconsin into the Respiratory Care Interstate Compact, which provides for the ability of a respiratory care practitioner to become eligible to practice in other compact states. Significant provisions of the compact include the following:

1. The creation of a Respiratory Care Interstate Compact Commission, which includes one administrator or staff member of the licensure authorities of each member state. The commission has various powers and duties granted in the compact, including establishing bylaws, promulgating binding rules for the compact, hiring officers, electing or appointing employees, and establishing and electing an executive committee. The commission may levy on and collect an annual assessment from each member state or impose fees on licensees of member states to cover the cost of the operations and activities of the commission and its staff.

2. A process whereby a respiratory care practitioner may obtain a compact privilege to practice in another member state. A licensee's primary state of residence is considered to be his or her home state, and any other member state in which the licensee wishes to practice is considered a remote state. A licensee providing respiratory therapy in a remote state under the compact privilege is required under the compact to function within the scope of practice authorized by the remote state.

A remote state may take actions against a respiratory care practitioner's compact privilege within that remote state, and if a respiratory care practitioner's home state license is encumbered, the respiratory care practitioner loses his or her compact privilege in all remote states until the home state license is no longer encumbered and two years have elapsed from the date on which the license is no longer encumbered.

3. The ability of member states to issue subpoenas that are enforceable in other states.

4. The creation of a coordinated database and reporting system containing licensure and disciplinary action information on respiratory care practitioners. The compact provides that member states are responsible for reporting any adverse action against a licensee and for monitoring the database to determine whether adverse action has been taken against a licensee. A member state must submit a uniform data set to the data system with certain information specified in the compact, as required by the rules of the commission.

5. Provisions regarding resolutions of disputes among member states and between member and nonmember states, including a process for termination of a state's membership in the compact if the state defaults on its obligations under the compact.

The compact becomes effective in this state upon enactment in seven states. The compact provides that it may be amended upon enactment of an amendment by

all member states. A state may withdraw from the compact by repealing the statute authorizing the compact, but the compact provides that a withdrawal does not take effect until 180 days after the effective date of that repeal.

STATUTES AND RULES EXAMINATION FOR RESPIRATORY CARE PRACTITIONERS

The bill prohibits the Medical Examining Board from requiring an applicant to pass a statutes and rules examination as a condition of certification as a respiratory care practitioner. The bill allows the board to require an applicant to affirm that the applicant has read and understands the statutes and rules that apply to the applicant's practice as a respiratory care practitioner.

4 (b) This compact is designed to achieve the following objectives:

6 responsible, streamlined pathway for licensees to practice in member states with
7 the goal of improving outcomes for patients;

8 2. Enhance states' ability to protect the public's health and safety;

9 3. Promote the cooperation of member states in regulating the practice of
10 respiratory therapy within those member states;

11 4. Ease administrative burdens on states by encouraging the cooperation of
12 member states in regulating multi-state respiratory therapy practice;

13 5. Support relocating active military members and their spouses; and

14 6. Promote mobility and address workforce shortages.

15 (2) DEFINITIONS. As used in this compact, unless the context requires
16 otherwise, the following definitions shall apply:

22 14. Lease, purchase, retain, own, hold, improve, or use any property, real,
23 personal, or mixed, or any undivided interest therein;

1 15. Sell, convey, mortgage, pledge, lease, exchange, abandon, or otherwise
2 dispose of any property real, personal, or mixed;

3 16. Establish a budget and make expenditures;

4 17. Borrow money in a fiscally responsible manner;

5 18. Appoint committees, including standing committees, composed of
6 commissioners state regulators, state legislators or their representatives, and
7 consumer representatives, and such other interested persons as may be designated
8 in this compact and the bylaws;

9 19. Provide and receive information from, and cooperate with, law
10 enforcement agencies;

11 20. Establish and elect an executive committee, including a chair, vice-chair,
12 secretary, treasurer, and such other offices as the commission shall establish by
13 rule or bylaw;

14 21. Enter into contracts or arrangements for the management of the affairs of
15 the commission;

16 22. Determine whether a state's adopted language is materially different from
17 the model compact language such that the state would not qualify for participation
18 in the compact; and

19 23. Perform such other functions as may be necessary or appropriate to
20 achieve the purposes of this compact.

21 (d) *The executive committee.* 1. The executive committee shall have the power
22 to act on behalf of the commission according to the terms of this compact. The
23 powers, duties, and responsibilities of the executive committee shall include:

24 a. Overseeing the day-to-day activities of the administration of the compact,

1 including enforcement and compliance with the provisions of the compact, its rules
2 and bylaws, and other such duties as deemed necessary;

3 b. Recommending to the commission changes to the rules or bylaws, changes
4 to this compact legislation, fees charged to compact member states, fees charged to
5 licensees, and other fees;

6 c. Ensuring compact administration services are appropriately provided,
7 including by contract;

8 d. Preparing and recommending the budget;

9 e. Maintaining financial records on behalf of the commission;

10 f. Monitoring compact compliance of member states and providing compliance
11 reports to the commission;

12 g. Establishing additional committees as necessary;

13 h. Exercising the powers and duties of the commission during the interim
14 between commission meetings, except for adopting or amending rules, adopting or
15 amending bylaws, and exercising any other powers and duties expressly reserved to
16 the commission by rule or bylaw; and

17 i. Performing other duties as provided in the rules or bylaws of the
18 commission.

19 2. The executive committee shall be composed of up to 9 members, as further
20 set forth in the bylaws of the commission:

21 a. Seven voting members who are elected by the commission from the current
22 membership of the commission; and

23 b. Two ex-officio, nonvoting members.

1 3. The commission may remove any member of the executive committee as
2 provided in the commission's bylaws.

3 4. The executive committee shall meet at least annually.

4 a. Executive committee meetings shall be open to the public, except that the
5 executive committee may meet in a closed, nonpublic meeting as provided in par. (f)
6 4. below;

7 b. The executive committee shall give advance notice of its meetings, posted
8 on its website and as determined to provide notice to persons with an interest in the
9 business of the commission; and

10 c. The executive committee may hold a special meeting in accordance with
11 par. (f) 2. below.

12 (e) The commission shall adopt and provide to the member states an annual
13 report.

14 (f) *Meetings of the commission.* 1. All meetings of the commission that are not
15 closed pursuant to subd. 4. shall be open to the public. Notice of public meetings
16 shall be posted on the commission's website at least 30 days prior to the public
17 meeting.

18 2. Notwithstanding subd. 1., the commission may convene an emergency
19 public meeting by providing at least 24 hours prior notice on the commission's
20 website, and any other means as provided in the commission's rules, for any of the
21 reasons it may dispense with notice of proposed rule making under sub. (9) (g). The
22 commission's legal counsel shall certify that one of the reasons justifying an
23 emergency public meeting has been met.

24 3. Notice of all commission meetings shall provide the time, date, and location

1 of the meeting, and if the meeting is to be held or accessible via telecommunication,
2 video conference, or other electronic means, the notice shall include the mechanism
3 for access to the meeting.

4 4. The commission or the executive committee may convene in a closed,
5 nonpublic meeting for the commission or executive committee to receive or solicit
6 legal advice or to discuss:

7 a. Noncompliance of a member state with its obligations under the compact;

8 b. The employment, compensation, discipline or other matters, practices or
9 procedures related to specific employees;

10 c. Current or threatened discipline of a licensee or compact privilege holder by
11 the commission or by a member state's respiratory therapy licensing authority;

12 d. Current, threatened, or reasonably anticipated litigation;

13 e. Negotiation of contracts for the purchase, lease, or sale of goods, services, or
14 real estate;

15 f. Accusing any person of a crime or formally censuring any person;

16 g. Trade secrets or commercial or financial information that is privileged or
17 confidential;

18 h. Information of a personal nature where disclosure would constitute a
19 clearly unwarranted invasion of personal privacy;

20 i. Investigative records compiled for law enforcement purposes;

21 j. Information related to any investigative reports prepared by or on behalf of
22 or for use of the commission or other committee charged with responsibility of
23 investigation or determination of compliance issues pursuant to the compact;

24 k. Legal advice;

1 L. Matters specifically exempted from disclosure by federal or member state
2 law; or

3 m. Other matters as promulgated by the commission by rule.

4 5. If a meeting, or portion of a meeting, is closed, the presiding officer shall
5 state that the meeting will be closed and reference each relevant exempting
6 provision, and such reference shall be recorded in the minutes.

7 6. The commission shall keep minutes in accordance with commission rules
8 and bylaws. All documents considered in connection with an action shall be
9 identified in such minutes. All minutes and documents of a closed meeting shall
10 remain under seal, subject to release only by a majority vote of the commission or
11 order of a court of competent jurisdiction.

12 (g) *Financing of the commission.* 1. The commission shall pay, or provide for
13 the payment of, the reasonable expenses of its establishment, organization, and
14 ongoing activities.

15 2. The commission may accept any and all appropriate revenue sources as
16 provided herein.

17 3. The commission may levy on and collect an annual assessment from each
18 member state and impose fees on licensees of member states to whom it grants a
19 compact privilege to cover the cost of the operations and activities of the commission
20 and its staff. The aggregate annual assessment amount for member states, if any,
21 shall be allocated based upon a formula that the commission shall promulgate by
22 rule.

23 4. The commission shall not incur obligations of any kind prior to securing the
24 funds or a loan adequate to meet the same; nor shall the commission pledge the

1 credit of any of the member states, except by and with the authority of the member
2 state.

3 5. The commission shall keep accurate accounts of all receipts and
4 disbursements. The receipts and disbursements of the commission shall be subject
5 to the financial review and accounting procedures established under its bylaws.
6 However, all receipts and disbursements of funds handled by the commission shall
7 be subject to an annual financial review by a certified or licensed public accountant,
8 and the report of the financial review shall be included in and become part of the
9 annual report of the commission.

10 (h) *Qualified immunity, defense, and indemnification.* 1. Nothing herein
11 shall be construed as a limitation on the liability of any licensee for professional
12 malpractice or misconduct, which shall be governed solely by any other applicable
13 state laws.

14 2. The member states, commissioners, officers, executive directors, employees,
15 and agents of the commission shall be immune from suit and liability, both
16 personally and in their official capacity, for any claim for damage to or loss of
17 property or personal injury or other civil liability caused by or arising out of any
18 actual or alleged act, error, or omission that occurred, or that the person against
19 whom the claim is made had a reasonable basis for believing occurred within the
20 scope of commission employment, duties or responsibilities; provided that nothing
21 in this subdivision shall be construed to protect any such person from suit or
22 liability for any damage, loss, injury, or liability caused by the intentional or willful
23 or wanton misconduct of that person. The procurement of insurance of any type by

1 the commission shall not in any way compromise or limit the immunity granted
2 hereunder.

3 3. The commission shall defend any commissioner, officer, executive director,
4 employee, and agent of the commission in any civil action seeking to impose liability
5 arising out of any actual or alleged act, error, or omission that occurred within the
6 scope of commission employment, duties, or responsibilities, or as determined by
7 the commission that the person against whom the claim is made had a reasonable
8 basis for believing occurred within the scope of commission employment, duties, or
9 responsibilities; provided that nothing herein shall be construed to prohibit that
10 person from retaining their own counsel at their own expense; and provided further,
11 that the actual or alleged act, error, or omission did not result from that person's
12 intentional or willful or wanton misconduct.

13 4. The commission shall indemnify and hold harmless any commissioner,
14 member, officer, executive director, employee, and agent of the commission for the
15 amount of any settlement or judgment obtained against that person arising out of
16 any actual or alleged act, error, or omission that occurred within the scope of
17 commission employment, duties, or responsibilities, or that such person had a
18 reasonable basis for believing occurred within the scope of commission
19 employment, duties, or responsibilities, provided that the actual or alleged act,
20 error, or omission did not result from the intentional or willful or wanton
21 misconduct of that person.

22 5. Nothing in this compact shall be interpreted to waive or otherwise abrogate
23 a member state's state action immunity or state action affirmative defense with

1 respect to antitrust claims under the Sherman Act, Clayton Act, or any other state
2 or federal antitrust or anticompetitive law or regulation.

3 6. Nothing in this compact shall be construed to be a waiver of sovereign
4 immunity by the member states or by the commission.

5 (8) DATA SYSTEM. (a) The commission shall provide for the development,
6 maintenance, operation, and utilization of a coordinated database and reporting
7 system containing licensure, adverse action, and the presence of significant
8 investigative information.

9 (b) Notwithstanding any other provision of state law to the contrary, a
10 member state shall submit a uniform data set to the data system as required by the
11 rules of the commission, including but not limited to:

12 1. Identifying information;

13 2. Licensure data;

14 3 Adverse actions against a licensee, license applicant, or compact privilege
15 holder and information related thereto;

16 4. Nonconfidential information related to alternative program participation,
17 the beginning and ending dates of such participation, and other information related
18 to such participation not made confidential under member state law;

19 5. Any denial of application for licensure, and the reason(s) for such denial;

20 6. The presence of current significant investigative information; and

21 7. Other information that may facilitate the administration of this compact or
22 the protection of the public, as determined by the rules of the commission.

23 (c) No member state shall submit any information which constitutes criminal

1 history record information, as defined by applicable federal law, to the data system
2 established hereunder.

3 (d) The records and information provided to a member state pursuant to this
4 compact or through the data system, when certified by the commission or an agent
5 thereof, shall constitute the authenticated business records of the commission, and
6 shall be entitled to any associated hearsay exception in any relevant judicial, quasi-
7 judicial or administrative proceedings in a member state.

8 (e) Significant investigative information pertaining to a licensee in any
9 member state will only be available to other member states.

10 (f) It is the responsibility of the member states to report any adverse action
11 against a licensee and to monitor the database to determine whether adverse action
12 has been taken against a licensee. Adverse action information pertaining to a
13 licensee in any member state will be available to any other member state.

14 (g) Member states contributing information to the data system may designate
15 information that may not be shared with the public without the express permission
16 of the contributing state.

17 (h) Any information submitted to the data system that is subsequently
18 expunged pursuant to federal law or the laws of the member state contributing the
19 information shall be removed from the data system.

20 **(9) RULE MAKING.** (a) The commission shall promulgate reasonable rules in
21 order to effectively and efficiently implement and administer the purposes and
22 provisions of the compact. A rule shall be invalid and have no force or effect only if
23 a court of competent jurisdiction holds that the rule is invalid because the
24 commission exercised its rule-making authority in a manner that is beyond the

1 scope and purposes of the compact, or the powers granted hereunder, or based upon
2 another applicable standard of review.

3 (b) For purposes of the compact, the rules of the commission shall have the
4 force of law in each member state.

5 (c) The commission shall exercise its rule-making powers pursuant to the
6 criteria set forth in this subsection and the rules adopted thereunder. Rules shall
7 become binding as of the date specified in each rule.

8 (d) If a majority of the legislatures of the member states rejects a rule or
9 portion of a rule, by enactment of a statute or resolution in the same manner used
10 to adopt the compact within 4 years of the date of adoption of the rule, then such
11 rule shall have no further force and effect in any member state.

12 (e) Rules shall be adopted at a regular or special meeting of the commission.

13 (f) Prior to adoption of a proposed rule, the commission shall hold a public
14 hearing and allow persons to provide oral and written comments, data, facts,
15 opinions, and arguments.

16 (g) Prior to adoption of a proposed rule by the commission, and at least 30
17 days in advance of the meeting at which the commission will hold a public hearing
18 on the proposed rule, the commission shall provide a notice of proposed rule
19 making:

20 1. On the website of the commission or other publicly accessible platform;

21 2. To persons who have requested notice of the commission's notices of
22 proposed rule making, and

23 3. In such other way(s) as the commission may by rule specify.

24 (h) The notice of proposed rule making shall include:

1 1. The time, date, and location of the public hearing at which the commission
2 will hear public comments on the proposed rule and, if different, the time, date, and
3 location of the meeting where the commission will consider and vote on the
4 proposed rule;

5 2. If the hearing is held via telecommunication, video conference, or other
6 electronic means, the commission shall include the mechanism for access to the
7 hearing in the notice of proposed rule making;

8 3. The text of the proposed rule and the reason therefor;

9 4. A request for comments on the proposed rule from any interested person;
10 and

11 5. The manner in which interested persons may submit written comments.

12 (i) All hearings will be recorded. A copy of the recording and all written
13 comments and documents received by the commission in response to the proposed
14 rule shall be available to the public.

15 (j) Nothing in this subsection shall be construed as requiring a separate
16 hearing on each rule. Rules may be grouped for the convenience of the commission
17 at hearings required by this subsection.

18 (k) The commission shall, by majority vote of all commissioners, take final
19 action on the proposed rule based on the rule-making record and the full text of the
20 rule.

21 1. The commission may adopt changes to the proposed rule provided the
22 changes are consistent with the original purpose of the proposed rule.

23 2. The commission shall provide an explanation of the reasons for substantive

1 changes made to the proposed rule as well as reasons for substantive changes not
2 made that were recommended by commenters.

3 3. The commission shall determine a reasonable effective date for the rule.
4 Except for an emergency as provided in par. (L), the effective date of the rule shall
5 be no sooner than 30 days after issuing the notice that it adopted or amended the
6 rule.

7 (L) Upon determination that an emergency exists, the commission may
8 consider and adopt an emergency rule with 24 hours' notice, and with opportunity
9 to comment, provided that the usual rule-making procedures provided in the
10 compact and in this subsection shall be retroactively applied to the rule as soon as
11 reasonably possible, in no event later than 90 days after the effective date of the
12 rule. For the purposes of this provision, an emergency rule is one that must be
13 adopted immediately in order to:

- 14 1. Meet an imminent threat to public health, safety, or welfare;
15 2. Prevent a loss of commission or member state funds;
16 3. Meet a deadline for the promulgation of a rule that is established by federal
17 law or rule; or
18 4. Protect public health and safety.

19 (m) The commission or an authorized committee of the commission may direct
20 revisions to a previously adopted rule for purposes of correcting typographical
21 errors, errors in format, errors in consistency, or grammatical errors. Public notice
22 of any revisions shall be posted on the website of the commission. The revision shall
23 be subject to challenge by any person for a period of 30 days after posting. The
24 revision may be challenged only on grounds that the revision results in a material

1 change to a rule. A challenge shall be made in writing and delivered to the
2 commission prior to the end of the notice period. If no challenge is made, the
3 revision will take effect without further action. If the revision is challenged, the

5 (n) No member state's rule-making process or procedural requirements shall
6 apply to the commission.

7 1. The commission shall have no authority over any member state's rule-
8 making process or procedural requirements that do not pertain to the compact.

9 (o) Nothing in this compact, nor any rule or regulation of the commission,
10 shall be construed to limit, restrict, or in any way reduce the ability of a member
11 state to enact and enforce laws, regulations, or other rules related to the practice of
12 respiratory therapy in that state, where those laws, regulations, or other rules are
13 not inconsistent with the provisions of this compact.

14 **(10) OVERSIGHT, DISPUTE RESOLUTION, AND ENFORCEMENT.** (a) *Oversight.* 1.
15 The executive and judicial branches of state government in each member state shall
16 enforce this compact and take all actions necessary and appropriate to implement
17 the compact.

18 2. Venue is proper and judicial proceedings by or against the commission shall
19 be brought solely and exclusively in a court of competent jurisdiction where the
20 principal office of the commission is located. The commission may waive venue and
21 jurisdictional defenses to the extent it adopts or consents to participate in
22 alternative dispute resolution proceedings. Nothing herein shall affect or limit the
23 selection or propriety of venue in any action against a licensee for professional
24 malpractice, misconduct or any such similar matter.

1 3. The commission shall be entitled to receive service of process in any
2 proceeding regarding the enforcement or interpretation of the compact and shall
3 have standing to intervene in such a proceeding for all purposes. Failure to provide
4 the commission service of process shall render a judgment or order void as to the
5 commission, this compact, or promulgated rules.

6 (b) *Default, technical assistance, and termination.* 1. If the commission
7 determines that a member state has defaulted in the performance of its obligations
8 or responsibilities under this compact or the promulgated rules, the commission
9 shall provide written notice to the defaulting state. The notice of default shall
10 describe the default, the proposed means of curing the default, and any other action
11 that the commission may take, and shall offer training and specific technical
12 assistance regarding the default.

13 2. The commission shall provide a copy of the notice of default to the other
14 member states.

15 (c) If a state in default fails to cure the default, the defaulting state may be
16 terminated from the compact upon an affirmative vote of a majority of the
17 commissioners of the member states, and all rights, privileges and benefits
18 conferred on that state by this compact may be terminated on the effective date of
19 termination. A cure of the default does not relieve the offending state of obligations
20 or liabilities incurred during the period of default.

21 (d) Termination of membership in the compact shall be imposed only after all
22 other means of securing compliance have been exhausted. Notice of intent to
23 suspend or terminate shall be given by the commission to the governor, the majority
24 and minority leaders of the defaulting state's legislature, the defaulting state's

1 respiratory therapy licensing authority and each of the member states' respiratory
2 therapy licensing authorities.

3 (e) A state that has been terminated is responsible for all assessments,
4 obligations, and liabilities incurred through the effective date of termination,
5 including obligations that extend beyond the effective date of termination, if
6 necessary.

7 (f) Upon the termination of a state's membership from this compact, that
8 state shall immediately provide notice to all licensees and compact privilege holders
9 (of which the commission has a record) within that state of such termination. The
10 terminated state shall continue to recognize all licenses granted pursuant to this
11 compact for a minimum of 180 days after the date of said notice of termination.

12 (g) The commission shall not bear any costs related to a state that is found to
13 be in default or that has been terminated from the compact, unless agreed upon in
14 writing between the commission and the defaulting state.

15 (h) The defaulting state may appeal the action of the commission by
16 petitioning the U.S. District Court for the District of Columbia or the federal
17 district where the commission has its principal offices. The prevailing party shall
18 be awarded all costs of such litigation, including reasonable attorney's fees.

19 (i) *Dispute resolution.* 1. Upon request by a member state, the commission
20 shall attempt to resolve disputes related to the compact that arise among member
21 states and between member and nonmember states.

22 2. The commission shall promulgate a rule providing for both mediation and
23 binding dispute resolution for disputes, as appropriate.

24 (j) *Enforcement.* 1. By majority vote, as may be further provided by rule, the

1 commission may initiate legal action against a member state in default in the
2 United States District Court for the District of Columbia or the federal district
3 where the commission has its principal offices to enforce compliance with the
4 provisions of the compact and its promulgated rules. A member state by enactment
5 of this compact consents to venue and jurisdiction in such court for the purposes set
6 forth herein. The relief sought may include both injunctive relief and damages. In
7 the event judicial enforcement is necessary, the prevailing party shall be awarded
8 all costs of such litigation, including reasonable attorney's fees. The remedies
9 herein shall not be the exclusive remedies of the commission. The commission may
10 pursue any other remedies available under federal or the defaulting member state's
11 law.

12 2. A member state may initiate legal action against the commission in the
13 U.S. District Court for the District of Columbia or the federal district where the
14 commission has its principal offices to enforce compliance with the provisions of the
15 compact and its promulgated rules. The relief sought may include both injunctive
16 relief and damages. In the event judicial enforcement is necessary, the prevailing
17 party shall be awarded all costs of such litigation, including reasonable attorney's
18 fees.

19 3. No person other than a member state shall enforce this compact against the
20 commission.

21 **(11) EFFECTIVE DATE, WITHDRAWAL, AND AMENDMENT.** (a) The compact shall
22 come into effect on the date on which the compact statute is enacted into law in the
23 7th member state ("effective date").

24 1. On or after the effective date of the compact, the commission shall convene

1 and review the enactment of each of the first 7 member states (“charter member
2 states”) to determine if the statute enacted by each such charter member state is
3 materially different than the model compact.

4 a. A charter member state whose enactment is found to be materially
5 different from the model compact shall be entitled to the default process set forth in
6 sub. (10).

7 b. If any member state is later found to be in default, or is terminated or
8 withdraws from the compact, the commission shall remain in existence and the
9 compact shall remain in effect even if the number of member states should be less
10 than 7.

11 2. Member states enacting the compact subsequent to the 7 initial charter
12 member states shall be subject to the process set forth herein and commission rule
13 to determine if their enactments are materially different from the model compact
14 and whether they qualify for participation in the compact.

15 3. All actions taken for the benefit of the commission or in furtherance of the
16 purposes of the administration of the compact prior to the effective date of the
17 compact or the commission coming into existence shall be considered to be actions
18 of the commission unless specifically repudiated by the commission. The
19 commission shall own and have all rights to any intellectual property developed on
20 behalf or in furtherance of the commission by individuals or entities involved in
21 organizing or establishing the commission, as may be further set forth in rules of
22 the commission.

23 4. Any state that joins the compact subsequent to the commission’s initial
24 adoption of the rules and bylaws shall be subject to the rules and bylaws as they

1 exist on the date on which the compact becomes law in that state. Any rule that has
2 been previously adopted by the commission shall have the full force and effect of law
3 on the date the compact becomes law in that state.

4 (b) Any member state may withdraw from this compact by enacting a statute
5 repealing the same.

6 1. A member state's withdrawal shall not take effect until 180 days after
7 enactment of the repealing statute.

8 2. Withdrawal shall not affect the continuing requirement of the withdrawing
9 state's respiratory therapy licensing authority to comply with the investigative and
10 adverse action reporting requirements of this compact prior to the effective date of
11 withdrawal.

12 3. Upon the enactment of a statute withdrawing from this compact, a state
13 shall immediately provide notice of such withdrawal to all licensees and compact
14 privilege holders (of which the commission has a record) within that state.
15 Notwithstanding any subsequent statutory enactment to the contrary, such
16 withdrawing state shall continue to recognize all licenses granted pursuant to this
17 compact for a minimum of 180 days after the date of such notice of withdrawal.

18 (c) Nothing contained in this compact shall be construed to invalidate or
19 prevent any licensure agreement or other cooperative arrangement between a
20 member state and a nonmember state that does not conflict with the provisions of
21 this compact.

22 (d) This compact may be amended by the member states. No amendment to
23 this compact shall become effective and binding upon any member state until it is
24 enacted into the laws of all member states.

1 **(12) CONSTRUCTION AND SEVERABILITY.** (a) This compact and the
2 commission's rule-making authority shall be liberally construed so as to effectuate
3 the purposes and the implementation and administration of the compact.
4 Provisions of the compact expressly authorizing or requiring the promulgation of
5 rules shall not be construed to limit the commission's rule-making authority solely
6 for those purposes.

7 (b) The provisions of this compact shall be severable, and if any phrase,
8 clause, sentence or provision of this compact is held by a court of competent
9 jurisdiction to be contrary to the constitution of any member state, a state seeking
10 participation in the compact, or of the United States, or the applicability thereof to
11 any government, agency, person or circumstance is held to be unconstitutional by a
12 court of competent jurisdiction, the validity of the remainder of this compact and
13 the applicability thereof to any other government, agency, person or circumstance
14 shall not be affected thereby.

15 (c) Notwithstanding par. (b), the commission may deny a state's participation
16 in the compact or, in accordance with the requirements of sub. (10), terminate a
17 member state's participation in the compact, if it determines that a constitutional
18 requirement of a member state is a material departure from the compact.
19 Otherwise, if this compact shall be held to be contrary to the constitution of any
20 member state, the compact shall remain in full force and effect as to the remaining
21 member states and in full force and effect as to the member state affected as to all
22 severable matters.

23 **(13) CONSISTENT EFFECT AND CONFLICT WITH OTHER STATE LAWS.** (a) Nothing

16 (2) The department may impose a fee for an individual to receive a compact
17 privilege as provided in s. 448.9886 (3) (b).

18 (3) (a) An individual who holds a compact privilege shall comply with s.
