2025 SENATE BILL 295

May 30, 2025 - Introduced by Senators Kapenga and Bradley, cosponsored by Representatives Maxey, Kitchens, Allen, Armstrong, Behnke, Brill, Dittrich, Donovan, Gundrum, Gustafson, Kaufert, Knodl, Kreibich, Melotik, Murphy, Mursau, Neylon, O'Connor, Penterman, Piwowarczyk and Wichgers. Referred to Committee on Judiciary and Public Safety.

AN ACT to renumber 807.14; to renumber and amend 967.09; to create

807.14 (2), 885.37 (6), 885.38 (9) and 967.09 (2) of the statutes; **relating to:** the use of artificial intelligence or other machine assisted translation in court proceedings and of telephone or live audiovisual interpretation in criminal trials.

Analysis by the Legislative Reference Bureau

Under this bill, a court may allow the use of artificial intelligence or other machine assisted translation in civil or criminal proceedings, certain municipal proceedings, and administrative contested case proceedings.

Under current law, on request of any party, the court may permit an interpreter to act in any criminal proceeding, other than trial, by telephone or live audiovisual means. The bill allows an interpreter to act by telephone or live audiovisual means in a criminal trial in addition to other types of proceedings.
