

## **2025 SENATE JOINT RESOLUTION 78**

July 16, 2025 - Introduced by Senators HESSELBEIN, CARPENTER, DASSLER-ALFHEIM, DRAKE, HABUSH SINYKIN, LARSON, PFAFF, RATCLIFF, ROYS, SMITH, SPREITZER, WALL and WIRCH, cosponsored by Representatives NEUBAUER, ANDRACA, ARNEY, BARE, BROWN, CLANCY, CRUZ, DESMIDT, DOYLE, EMERSON, FITZGERALD, GOODWIN, HONG, HYSELL, JOERS, JOHNSON, KIRSCH, MADISON, MAYADEV, MIRESSE, MOORE OMOKUNDE, ORTIZ-VELEZ, PALMERI, PHELPS, PRADO, ROE, SHEEHAN, SINICKI, SNODGRASS, SPAUDE, STROUD, STUBBS, SUBECK, TENORIO, UDELL and VINING. 2	Bradley.
3	Whereas, Chief Justice Ann Walsh Bradley has deep roots in Wisconsin,
4	coming from a family that has lived in the state since the 1850s; and
5	Whereas, Chief Justice Bradley was born and raised in Richland Center,
6	growing up in the house that her grandparents owned and where her father was
7	born; and
8	Whereas, after earning her bachelor's degree at Webster University, Chief
9	Justice Bradley began her long career in public service as a high school teacher in
10	La Crosse; and
11	Whereas, Chief Justice Bradley then earned her J.D. at the University of
12	Wisconsin Law School, where she was recognized as a Knapp Scholar; and
13	Whereas, in 1985, Chief Justice Bradley was appointed by Governor Tony Earl

1	to serve as a circuit court judge in Marathon County, the first woman to serve in
2	that position in county history; and
3	Whereas, upon being sworn in, Chief Justice Bradley pledged "my energy, my
4	intellect, my good humor, and my sincerity" in service of the people of Wisconsin;
5	and
6	Whereas, Chief Justice Bradley subsequently won election to the same court
7	in 1986, earning respect as a jurist, remaining deeply involved in the community,
8	and, alongside her husband, Mark, raising a young family; and
9	Whereas, Chief Justice Bradley became the first woman in state history to
10	reach the Wisconsin Supreme Court by way of election, securing her first 10-year
11	term in 1995; and
12	Whereas, Chief Justice Bradley was reelected to the court in 2005 and 2015;
13	and
14	Whereas, over the course of her tenure, Chief Justice Bradley heard thousands
15	of cases, earning the confidence of her colleagues and the broader public; and
16	Whereas, Chief Justice Bradley has devoted her time and talents to
17	organizations advancing gender and human rights and inclusive justice around the
18	globe, including serving as Vice-Chair of the Board of Directors of the International
19	Judicial Academy, as a founding member of the Global Network on Electoral
20	Justice, and as the chair of the Board of Trustees of the International Association of
21	Women Judges; and
22	Whereas, in 2025, Chief Justice Ann Walsh Bradley was chosen by her
23	colleagues to serve as Chief Justice; now, therefore, be it
