## 2021 WISCONSIN ACT

AN ACT *to repeal and recreate* 3.11 to 3.18 of the statutes; **relating to:** congressional redistricting.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**SECTION 1.** 3.11 to 3.18 of the statutes are repealed and recreated to read:

**3.11 First congressional district.** All of the following territory constitutes the first congressional district:

(1) **WHOLE COUNTIES.** Kenosha and Racine.

(2) **MILWAUKEE COUNTY.** That part of Milwaukee County consisting of all of the following:

- (a) The villages of Greendale and Hales Corners.
- (b) The cities of Franklin and Oak Creek.

(3) **ROCK COUNTY.** That part of Rock County consisting of all of the following:

(a) The towns of Bradford, Clinton, Harmony, Janesville, Johnstown, La Prairie, Lima, Milton, and Rock.

**SECTION 2. Initial applicability.**

(1) This act first applies, with respect to regular elections, to offices filled at the 2022 general election.

(2) This act first applies, with respect to special or recall elections, to offices filled or contested concurrently with the 2022 general election.
