Senate Committee on Transportation and Local Government Testimony on Senate Bill 345

Thank you Chairman Petrowski and committee members for hearing Senate Bill (SB) 345, which would designate State Highway 21 as a Purple Heart Memorial Highway. Thank you Sen. Pfaff for cosponsoring this bipartisan legislation.

Rep. Kurtz and I drafted this bill after veterans with the Necedah Veterans of Foreign Wars (VFW) Post approached us regarding this memorial designation. SB 345 will designate the 123.4 miles of State Highway 21 from Sparta to Oshkosh as a Purple Heart Memorial Highway.

Currently, the Purple Heart Medal, per regulation is awarded in the name of the President of the United States to any member of the Armed Forces of the United States who, while serving under competent authority in any capacity with one of the U.S. Armed Services after April 5, 1917 has been wounded, killed, or has died after being wounded by enemy action.

The Purple Heart originated as the Badge of Military Merit, established by General George Washington, when he served as commander-in-chief of the Continental Army, by his order on August 7, 1782. The Badge of Military Merit was only awarded to three Revolutionary War soldiers. For unknown reasons, the medal was not awarded again, but it was not abolished.

General Douglas MacArthur signed General Order No. 3 on February 22, 1932, the 200th Anniversary of George Washington's birth, creating the modern Purple Heart. It is the nation's oldest military award, and although the criteria has been modified several times, the recipients are those who have been wounded in battle or made the ultimate sacrifice defending our freedoms.

I am thankful for the men and women who have served, their sacrifices and bravery. Please join me in supporting SB 345 to show our appreciation and say – THANK YOU!

AB 339, the companion legislation to SB 345, was recommended for passage by the Assembly Committee on Transportation 13-0 on June 22, 2021. Thank you again to the committee for hearing this proposal, and your timely action on the bill.

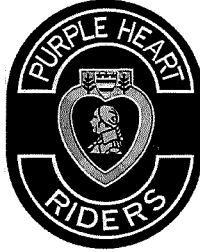
Thank you Chairman Petrowski for holding a public hearing on Senate Bill 345 (SB 345) today and thank you to the members of the committee for taking my testimony.
