Embracing AI isn't merely an option; it's a necessity for modernizing our state's operations and securing our position at the forefront of innovation.

AB 1068 strategically focuses on leveraging AI to enhance the efficiency of state agencies, enabling us to achieve more with available resources. The provisions outlined in this bill align with global best practices, ensuring Wisconsin's competitiveness and adaptability in the ever-evolving landscape of technology and governance.

Let me emphasize, this bill is NOT an excuse to fire state employees. We are in the middle of a workforce shortage. Anything we can do to ensure the job gets done and prevent burnout from our talented workers should be done. This bill will embolden our departments to support their staff while assisting the citizens of the State of Wisconsin.
