

## 2003 BILL

1     **AN ACT to repeal** 20.625 (3); **to amend** 48.977 (4) (b) 5., 48.978 (2) (b) 10., 303.068  
2           (1m), 767.05 (2), 801.05 (11) and 948.31 (3) (b); and **to repeal and recreate**  
3           chapter 822 of the statutes; **relating to:** the Uniform Child Custody  
4           Jurisdiction and Enforcement Act.

### ***Analysis by the Legislative Reference Bureau***

This bill replaces the Uniform Child Custody Jurisdiction Act (UCCJA), enacted into current law in 1975, with the updated Uniform Child Custody Jurisdiction and Enforcement Act (UCCJEA), which was in 1997 approved and recommended for passage in all states by the National Conference of Commissioners on Uniform State Laws. The purpose of the UCCJEA is to provide standardization among the states of the general procedural and jurisdictional requirements for interstate child custody matters, which under the UCCJEA include legal custody, physical placement, and visitation.

With respect to child custody proceedings and orders, the UCCJEA does all of the following:

1. Specifies what notice is sufficient for a court to have jurisdiction over a person who is outside the state and specifies to whom notice must be given before a court may make a child custody determination.

2. Authorizes a court of one state to communicate with a court of another state concerning a child custody proceeding in one of those states and to request the court of the other state to perform various functions, such as ordering an evaluation, holding an evidentiary hearing, and forwarding a transcript of a hearing.

3. Specifies the circumstances under which a court of a state has jurisdiction to make an initial child custody determination, such as when the state is the home state of the child.

4. Authorizes temporary emergency jurisdiction to make a child custody determination if the child is present in the state and has been abandoned or is being subjected to or threatened with mistreatment or abuse.

5. Specifies how long a court that made a child custody determination has exclusive, continuing jurisdiction over the determination, such as until a court of that or another state determines that the child and the child's parents no longer reside in the state.

6. Specifies the circumstances under which a court that made a child custody determination has jurisdiction to modify that determination and the circumstances under which a court has jurisdiction to modify a child custody determination made by a court of another state.

7. Specifies that a court may decline to exercise its jurisdiction to make a child custody determination if it is an inconvenient forum and provides factors for a court to consider in making that determination.

8. Provides procedures for a court to follow with respect to a child custody proceeding if a child custody proceeding already has been commenced in another state.

9. Specifies basic information that must be included in the first pleading in a child custody proceeding and the persons whom the court may require to appear in a child custody proceeding.

10. Imposes a duty on a court to recognize and enforce a child custody determination made by another court if that other court exercised jurisdiction in conformity with the standards under the UCCJEA.

11. Provides defenses for a respondent when a court orders that a petitioner may take immediate physical custody of a child.

12. Authorizes a court to issue a warrant that directs law enforcement to take immediate physical custody of a child if the court finds that the child is imminently likely to suffer serious physical harm or be removed from the state.

In general, the UCCJEA under the bill provides clearer standards for original jurisdiction in child custody proceedings and more complete standards for jurisdiction to modify child custody determinations than does the UCCJA under current law. In addition, the UCCJEA adds standards for continuing jurisdiction over child custody determinations, for temporary emergency jurisdiction over child custody matters, and for enforcement of child custody determinations.

12          767.05 **(2)** ACTIONS FOR CUSTODY OF CHILDREN. Subject to ch. 822, the question  
13       of a child’s custody may be determined as an incident of any action affecting the  
14       family or in an independent action for custody. The effect of any determination of a  
15       child’s custody shall not be binding personally against any parent or guardian unless  
16       the parent or guardian has been made personally subject to the jurisdiction of the  
17       court in the action as provided under ch. 801 or has been notified under s. ~~822.05~~  
18       822.08 as provided in s. ~~822.12~~ 822.06. Nothing in this section may be construed to  
19       foreclose a person other than a parent who has physical custody of a child from  
20       proceeding under ch. 822.

21          **SECTION 6.** 801.05 (11) of the statutes is amended to read:

22          801.05 **(11)** CERTAIN MARITAL ACTIONS. In addition to personal jurisdiction under  
23       sub. (1) and s. 801.06, in any action affecting the family, except for actions under ch.  
24       769, in which a personal claim is asserted against the respondent commenced in the  
25       county in which the petitioner resides at the commencement of the action when the

1 respondent resided in this state in marital relationship with the petitioner for not  
2 less than 6 consecutive months within the 6 years next preceding the commencement  
3 of the action and the respondent is served personally under s. 801.11. The effect of  
4 any determination of a child's custody shall not be binding personally against any  
5 parent or guardian unless the parent or guardian has been made personally subject  
6 to the jurisdiction of the court in the action as provided under this chapter or has been  
7 notified under s. ~~822.05~~ 822.08 as provided in s. ~~822.12~~ 822.06.

13 **SUBCHAPTER I**

14 **GENERAL PROVISIONS**

15 **822.01 Short title; purposes; construction of provisions.** (1) This  
16 chapter may be cited as the "Uniform Child Custody Jurisdiction and Enforcement  
17 Act."

18 **(2)** The general purposes of this chapter are to:

19 (a) Avoid jurisdictional competition and conflict with courts of other states in  
20 matters of child custody that have in the past resulted in the shifting of children from  
21 state to state with harmful effects on their well-being.

22 (b) Promote cooperation with the courts of other states to the end that a custody  
23 decree is rendered in the state that can best decide the case in the interest of the child.

24 (c) Discourage the use of the interstate system for continuing controversies  
25 over child custody.

1 (d) Deter abductions of children.

2 (e) Avoid relitigation in this state of custody decisions of other states.

3 (f) Facilitate the enforcement of custody decrees of other states.

4 **822.02 Definitions.** In this chapter:

5 (1) “Abandoned” means left without provision for reasonable and necessary  
6 care or supervision.

7 (2) “Child” means an individual who has not attained 18 years of age.

8 (3) “Child custody determination” means a judgment, decree, or other order of  
9 a court providing for legal custody, physical custody, physical placement, or visitation  
10 with respect to a child. The term includes a permanent, temporary, initial, and  
11 modification order. The term does not include an order relating to child support or  
12 other monetary obligation of an individual.

13 (4) “Child custody proceeding” means a proceeding in which legal custody,  
14 physical custody, physical placement, or visitation with respect to a child is an issue.  
15 The term includes a proceeding for divorce, legal separation, neglect, abuse,  
16 dependency, guardianship, paternity, termination of parental rights, and protection  
17 from domestic violence, in which the issue may appear. “Child custody proceeding”  
18 does not include a proceeding involving juvenile delinquency, contractual  
19 emancipation, or enforcement under subch. III.

20 (5) “Commencement” means the filing of the first pleading in a proceeding.

21 (6) “Court” means an entity authorized under the law of a state to establish,  
22 enforce, or modify a child custody determination.

23 (7) “Home state” means the state in which a child lived with a parent or a  
24 person acting as a parent for at least 6 consecutive months immediately before the  
25 commencement of a child custody proceeding. In the case of a child less than 6

1 months of age, the term means the state in which the child lived from birth with any  
2 of the persons mentioned in this subsection. A period of temporary absence of any  
3 of the persons mentioned in this subsection is part of the period.

4 **(8)** “Initial determination” means the first child custody determination  
5 concerning a particular child.

6 **(9)** “Issuing court” means the court that makes a child custody determination  
7 for which enforcement is sought under this chapter.

8 **(10)** “Issuing state” means the state in which a child custody determination is  
9 made.

10 **(11)** “Modification” means a child custody determination that changes,  
11 replaces, supersedes, or is otherwise made after a previous determination  
12 concerning the same child, whether or not it is made by the court that made the  
13 previous determination.

14 **(12)** “Person” means an individual, corporation, business trust, estate, trust,  
15 partnership, limited liability company, association, joint venture, or government;  
16 governmental subdivision, agency, or instrumentality; public corporation; or any  
17 other legal or commercial entity.

18 **(13)** “Person acting as a parent” means a person, other than a parent, to whom  
19 all of the following apply:

20 (a) He or she has physical custody of the child or has had physical custody for  
21 a period of 6 consecutive months, including any temporary absence, within one year  
22 immediately before the commencement of a child custody proceeding.

23 (b) He or she has been awarded legal custody by a court or claims a right to legal  
24 custody under the law of this state.

25 **(14)** “Physical custody” means the physical care and supervision of a child.

1           **(15)** “State” means a state of the United States, the District of Columbia,  
2           Puerto Rico, the U.S. Virgin Islands, or any territory or insular possession subject  
3           to the jurisdiction of the United States.

4           **(16)** “Tribe” means an American Indian tribe or band, or Alaskan Native  
5           village, that is recognized by federal law or formally acknowledged by a state.

6           **(17)** “Warrant” means an order issued by a court authorizing law enforcement  
7           officers to take physical custody of a child.

8           **822.03 Proceedings governed by other law.** This chapter does not govern  
9           an adoption proceeding or a proceeding pertaining to the authorization of emergency  
10          medical care for a child.

11          **822.04 Application to Indian tribes.** A child custody proceeding that  
12          pertains to an Indian child as defined in the Indian Child Welfare Act, 25 USC 1901  
13          et seq., is not subject to this chapter to the extent that it is governed by the Indian  
14          Child Welfare Act.

15          **822.05 International application. (1)** A court of this state shall treat a  
16          foreign country as if it were a state for the purpose of applying this subchapter and  
17          subch. II.

18          **(2)** Except as provided in sub. (3), a child custody determination made in a  
19          foreign country under factual circumstances in substantial conformity with the  
20          jurisdictional standards of this chapter shall be recognized and enforced under  
21          subch. III.

22          **(3)** A court of this state need not apply this chapter if the child custody law of  
23          a foreign country violates fundamental principles of human rights.

24          **822.06 Effect of child custody determination.** A child custody  
25          determination made by a court of this state that had jurisdiction under this chapter

1 binds all persons who have been served in accordance with the laws of this state or  
2 notified in accordance with s. 822.08 or who have submitted to the jurisdiction of the  
3 court, and who have been given an opportunity to be heard. As to those persons, the  
4 determination is conclusive as to all decided issues of law and fact except to the  
5 extent that the determination is modified.

6 **822.07 Priority.** If a question of existence or exercise of jurisdiction under this  
7 chapter is raised in a child custody proceeding, the question, upon request of a party,  
8 shall be given priority on the calendar and handled expeditiously.

9 **822.08 Notice to persons outside state. (1)** Notice required for the exercise  
10 of jurisdiction when a person is outside this state may be given in a manner  
11 prescribed by the law of this state for service of process or by the law of the state in  
12 which the service is made. Notice shall be given in a manner reasonably calculated  
13 to give actual notice but may be by publication if other means are not effective.

14 **(2)** Proof of service may be made in the manner prescribed by law of this state  
15 or by the law of the state in which the service is made.

16 **(3)** Notice is not required for the exercise of jurisdiction with respect to a person  
17 who submits to the jurisdiction of the court.

18 **822.09 Appearance and limited immunity. (1)** A party to a child custody  
19 proceeding, including a modification proceeding, or a petitioner or respondent in a  
20 proceeding to enforce or register a child custody determination, is not subject to  
21 personal jurisdiction in this state for another proceeding or purpose solely by reason  
22 of having participated, or of having been physically present for the purpose of  
23 participating, in the proceeding.

24 **(2)** A person who is subject to personal jurisdiction in this state on a basis other  
25 than physical presence is not immune from service of process in this state. A party

1 present in this state who is subject to the jurisdiction of another state is not immune  
2 from service of process allowable under the laws of that state.

3 (3) The immunity granted by sub. (1) does not extend to civil litigation based  
4 on acts unrelated to the participation in a proceeding under this chapter committed  
5 by an individual while present in this state.

6 **822.10 Communication between courts.** (1) In this section, “record”  
7 means information that is inscribed on a tangible medium or that is stored in an  
8 electronic or other medium and is retrievable in perceivable form.

9 (2) A court of this state may communicate with a court in another state  
10 concerning a proceeding arising under this chapter.

11 (3) The court may allow the parties to participate in the communication. If the  
12 parties are not able to participate in the communication, they shall be given the  
13 opportunity to present facts and legal arguments before a decision on jurisdiction is  
14 made.

15 (4) Communication between courts on schedules, calendars, court records, and  
16 similar matters may occur without informing the parties. A record need not be made  
17 of the communication.

18 (5) Except as provided in sub. (4), a record shall be made of a communication  
19 under this section. The parties shall be informed promptly of the communication and  
20 granted access to the record.

21 **822.11 Taking testimony in another state.** (1) In addition to other  
22 procedures available to a party, a party to a child custody proceeding may offer  
23 testimony of witnesses who are located in another state, including testimony of the  
24 parties and the child, by deposition or other means allowable in this state for  
25 testimony taken in another state. The court on its own motion may order that the

1 testimony of a person be taken in another state and may prescribe the manner in  
2 which and the terms upon which the testimony is taken.

3       **(2)** A court of this state may permit an individual residing in another state to  
4 be deposed or to testify by telephone, audiovisual means, or other electronic means  
5 before a designated court or at another location in that state. A court of this state  
6 shall cooperate with courts of other states in designating an appropriate location for  
7 the deposition or testimony.

8       **(3)** Documentary evidence transmitted from another state to a court of this  
9 state by technological means that do not produce an original writing may not be  
10 excluded from evidence on an objection based on the means of transmission.

11       **822.12 Cooperation between courts; preservation of records. (1)** A  
12 court of this state may request the appropriate court of another state to do any of the  
13 following:

14       (a) Hold an evidentiary hearing.

15       (b) Order a person to produce or give evidence under procedures of that state.

16       (c) Order that an evaluation be made with respect to the custody of a child  
17 involved in a pending proceeding.

18       (d) Forward to the court of this state a certified copy of the transcript of the  
19 record of the hearing, the evidence otherwise presented, and any evaluation  
20 prepared in compliance with the request.

21       (e) Order a party to a child custody proceeding or any person having physical  
22 custody of the child to appear in the proceeding with or without the child.

23       **(2)** Upon request of a court of another state, a court of this state may hold a  
24 hearing or enter an order described in sub. (1).

**(3)** Travel and other necessary and reasonable expenses incurred under subs. (1) and (2) may be assessed against the parties according to the law of this state.

**(4)** A court of this state shall preserve the pleadings, orders, decrees, records of hearings, evaluations, and other pertinent records with respect to a child custody proceeding until the child attains 18 years of age. Upon appropriate request by a court or law enforcement official of another state, the court shall forward a certified copy of those records.

## SUBCHAPTER II

## JURISDICTION

**822.21 Initial child custody jurisdiction. (1)** Except as provided in s. 822.24, a court of this state has jurisdiction to make an initial determination only if any of the following applies:

(a) This state is the home state of the child on the date of the commencement of the proceeding, or was the home state of the child within 6 months before the commencement of the proceeding and the child is absent from this state but a parent or person acting as a parent continues to live in this state.

(b) A court of another state does not have jurisdiction under par. (a), or a court of the home state of the child has declined to exercise jurisdiction on the ground that this state is the more appropriate forum under s. 822.27 or 822.28, and all of the following apply:

1. The child and the child's parents, or the child and at least one parent or a person acting as a parent, have a significant connection with this state other than mere physical presence.

2. Substantial evidence is available in this state concerning the child's care, protection, training, and personal relationships.

1 (c) All courts having jurisdiction under par. (a) or (b) have declined to exercise  
2 jurisdiction on the ground that a court of this state is the more appropriate forum to  
3 determine the custody of the child under s. 822.27 or 822.28.

4 (d) No court of any other state would have jurisdiction under the criteria  
5 specified in par. (a), (b), or (c).

6 **(2)** Subsection (1) is the exclusive jurisdictional basis for making a child  
7 custody determination by a court of this state.

8 **(3)** Physical presence of, or personal jurisdiction over, a party or a child is not  
9 necessary or sufficient to make a child custody determination.

10 **822.22 Exclusive, continuing jurisdiction. (1)** Except as provided in s.  
11 822.24, a court of this state that has made a child custody determination consistent  
12 with s. 822.21 or 822.23 has exclusive, continuing jurisdiction over the  
13 determination until any of the following occurs:

14 (a) A court of this state determines that neither the child, nor the child and one  
15 parent, nor the child and a person acting as a parent have a significant connection  
16 with this state and that substantial evidence is no longer available in this state  
17 concerning the child's care, protection, training, and personal relationships.

18 (b) A court of this state or a court of another state determines that the child,  
19 the child's parents, and all persons acting as parents do not presently reside in this  
20 state.

21 **(2)** A court of this state that has made a child custody determination and that  
22 does not have exclusive, continuing jurisdiction under this section may modify that  
23 determination only if it has jurisdiction to make an initial determination under s.  
24 822.21.

1           **822.23 Jurisdiction to modify determination.** Except as provided in s.  
2           822.24, a court of this state may not modify a child custody determination made by  
3           a court of another state unless a court of this state has jurisdiction to make an initial  
4           determination under s. 822.21 (1) (a) or (b) and one of the following applies:

5           **(1)** The court of the other state determines that it no longer has exclusive,  
6           continuing jurisdiction under s. 822.22 or that a court of this state would be a more  
7           convenient forum under s. 822.27.

8           **(2)** A court of this state or a court of the other state determines that the child,  
9           the child's parents, and all persons acting as parents do not presently reside in the  
10          other state.

11          **822.24 Temporary emergency jurisdiction. (1)** A court of this state has  
12          temporary emergency jurisdiction if the child is present in this state and the child  
13          has been abandoned or it is necessary in an emergency to protect the child because  
14          the child, or a sibling or parent of the child, is subjected to or threatened with  
15          mistreatment or abuse.

16          **(2)** If there is no previous child custody determination that is entitled to be  
17          enforced under this chapter and a child custody proceeding has not been commenced  
18          in a court of a state having jurisdiction under ss. 822.21 to 822.23, a child custody  
19          determination made under this section remains in effect until an order is obtained  
20          from a court of a state having jurisdiction under ss. 822.21 to 822.23. If a child  
21          custody proceeding has not been or is not commenced in a court of a state having  
22          jurisdiction under ss. 822.21 to 822.23, a child custody determination made under  
23          this section becomes a final determination, if it so provides and this state becomes  
24          the home state of the child.

1           **(3)** If a previous child custody determination is entitled to be enforced under  
2 this chapter, or a child custody proceeding has been commenced in a court of a state  
3 having jurisdiction under ss. 822.21 to 822.23, any order issued by a court of this  
4 state under this section shall specify in the order a period that the court considers  
5 adequate to allow the person seeking an order to obtain an order from the state  
6 having jurisdiction under ss. 822.21 to 822.23. The order issued in this state remains  
7 in effect until an order is obtained from the other state within the period specified  
8 or until the period expires.

9           **(4)** A court of this state that has been asked to make a child custody  
10 determination under this section, upon being informed that a child custody  
11 proceeding has been commenced in, or that a child custody determination has been  
12 made by, a court of a state having jurisdiction under ss. 822.21 to 822.23, shall  
13 immediately communicate with the other court. A court of this state that is  
14 exercising jurisdiction under ss. 822.21 to 822.23, upon being informed that a child  
15 custody proceeding has been commenced in, or that a child custody determination  
16 has been made by, a court of another state under a statute similar to this section,  
17 shall immediately communicate with the court of that state to resolve the emergency,  
18 protect the safety of the parties and the child, and determine a period for the duration  
19 of the temporary order.

20           **822.25 Notice; opportunity to be heard; joinder. (1)** Before a child custody  
21 determination is made under this chapter, notice and an opportunity to be heard in  
22 accordance with the standards of s. 822.08 shall be given to all persons entitled to  
23 notice under the law of this state as in child custody proceedings between residents  
24 of this state, any parent whose parental rights have not been previously terminated,  
25 and any person having physical custody of the child.

1           **(2)** This chapter does not govern the enforceability of a child custody  
2 determination made without notice or an opportunity to be heard.

3           **(3)** The obligation to join a party and the right to intervene as a party in a child  
4 custody proceeding under this chapter are governed by the law of this state as in child  
5 custody proceedings between residents of this state.

6           **822.26 Simultaneous proceedings.** **(1)** Except as provided in s. 822.24, a  
7 court of this state may not exercise its jurisdiction under this subchapter if, at the  
8 time of the commencement of the proceeding, a proceeding concerning the custody  
9 of the child has been commenced in a court of another state having jurisdiction  
10 substantially in conformity with this chapter, unless the proceeding has been  
11 terminated or is stayed by the court of the other state because a court of this state  
12 is a more convenient forum under s. 822.27.

13           **(2)** Except as provided in s. 822.24, a court of this state, before hearing a child  
14 custody proceeding, shall examine the court documents and other information  
15 supplied by the parties under s. 822.29. If the court determines that a child custody  
16 proceeding has been commenced in a court in another state having jurisdiction  
17 substantially in accordance with this chapter, the court of this state shall stay its  
18 proceeding and communicate with the court of the other state. If the court of the state  
19 having jurisdiction substantially in accordance with this chapter does not determine  
20 that the court of this state is a more appropriate forum, the court of this state shall  
21 dismiss the proceeding.

22           **(3)** In a proceeding to modify a child custody determination, a court of this state  
23 shall determine whether a proceeding to enforce the determination has been  
24 commenced in another state. If a proceeding to enforce a child custody determination  
25 has been commenced in another state, the court may do any of the following:

1 (a) Stay the proceeding for modification pending the entry of an order of a court  
2 of the other state enforcing, staying, denying, or dismissing the proceeding for  
3 enforcement.

4 (b) Enjoin the parties from continuing with the proceeding for enforcement.

5 (c) Proceed with the modification under conditions it considers appropriate.

6 **822.27 Inconvenient forum. (1)** A court of this state that has jurisdiction  
7 under this chapter to make a child custody determination may decline to exercise its  
8 jurisdiction at any time if it determines that it is an inconvenient forum under the  
9 circumstances and that a court of another state is a more appropriate forum. The  
10 issue of inconvenient forum may be raised upon the motion of a party, the court's own  
11 motion, or the request of another court.

12 **(2)** Before determining whether it is an inconvenient forum, a court of this state  
13 shall consider whether it is appropriate for a court of another state to exercise  
14 jurisdiction. For this purpose, the court shall allow the parties to submit information  
15 and shall consider all relevant factors, including all of the following:

16 (a) Whether domestic violence has occurred and is likely to continue in the  
17 future and which state could best protect the parties and the child.

18 (b) The length of time that the child has resided outside this state.

19 (c) The distance between the court in this state and the court in the state that  
20 would assume jurisdiction.

21 (d) The relative financial circumstances of the parties.

22 (e) Any agreement of the parties as to which state should assume jurisdiction.

23 (f) The nature and location of the evidence required to resolve the pending  
24 litigation, including testimony of the child.

1           (g) The ability of the court of each state to decide the issue expeditiously and  
2 the procedures necessary to present the evidence.

3           (h) The familiarity of the court of each state with the facts and issues in the  
4 pending litigation.

5           **(3)** If a court of this state determines that it is an inconvenient forum and that  
6 a court of another state is a more appropriate forum, the court shall stay the  
7 proceedings upon condition that a child custody proceeding be promptly commenced  
8 in another designated state and may impose any other condition that the court  
9 considers just and proper.

10          **(4)** A court of this state may decline to exercise its jurisdiction under this  
11 chapter if a child custody determination is incidental to an action for divorce or  
12 another proceeding while still retaining jurisdiction over the divorce or other  
13 proceeding.

14          **822.28 Jurisdiction declined by reason of conduct. (1)** Except as  
15 provided in s. 822.24, if a court of this state has jurisdiction under this chapter  
16 because a person seeking to invoke its jurisdiction has engaged in unjustifiable  
17 conduct, the court shall decline to exercise its jurisdiction unless any of the following  
18 occurs:

19           (a) The parents and all persons acting as parents have acquiesced in the  
20 exercise of jurisdiction.

21           (b) A court of the state otherwise having jurisdiction under ss. 822.21 to 822.23  
22 determines that this state is a more appropriate forum under s. 822.27.

23           (c) No court of any other state would have jurisdiction under the criteria  
24 specified in ss. 822.21 to 822.23.

**BILL**

1           **(2)** If a court of this state declines to exercise its jurisdiction under sub. (1), it  
2 may fashion an appropriate remedy to ensure the safety of the child and prevent a  
3 repetition of the unjustifiable conduct, including staying the proceeding until a child  
4 custody proceeding is commenced in a court having jurisdiction under ss. 822.21 to  
5 822.23.

6           **(3)** If a court dismisses a petition or stays a proceeding because it declines to  
7 exercise its jurisdiction under sub. (1), it shall assess against the party seeking to  
8 invoke its jurisdiction necessary and reasonable expenses including costs,  
9 communication expenses, attorney fees, investigative fees, expenses for witnesses,  
10 travel expenses, and expenses for child care during the course of the proceedings,  
11 unless the party from whom fees are sought establishes that the assessment would  
12 be clearly inappropriate. The court may not assess fees, costs, or expenses against  
13 this state unless authorized by law other than this chapter.

14           **822.29 Information to be submitted to court.** **(1)** In a child custody  
15 proceeding, each party, in its first pleading or in an attached affidavit, shall give  
16 information, if reasonably ascertainable, under oath as to the child's present address  
17 or whereabouts, the places where the child has lived during the last 5 years, and the  
18 names and present addresses of the persons with whom the child has lived during  
19 that period. The pleading or affidavit shall state whether the party:

20           (a) Has participated, as a party or witness or in any other capacity, in any other  
21 proceeding concerning the custody of or physical placement or visitation with the  
22 child and, if so, shall identify the court, the case number, and the date of the child  
23 custody determination, if any.

24           (b) Knows of any proceeding that could affect the current proceeding, including  
25 proceedings for enforcement and proceedings relating to domestic violence,

1 protective orders, termination of parental rights, and adoptions and, if so, shall  
2 identify the court, the case number, and the nature of the proceeding.

3 (c) Knows the names and addresses of any person not a party to the proceeding  
4 who has physical custody of the child or claims rights of legal custody or physical  
5 custody of, or physical placement or visitation with, the child and, if so, the names  
6 and addresses of those persons.

7 (2) If the information required by sub. (1) is not furnished, the court, upon  
8 motion of a party or its own motion, may stay the proceeding until the information  
9 is furnished.

10 (3) If the declaration as to any of the items described in sub. (1) (a) to (c) is in  
11 the affirmative, the declarant shall give additional information under oath as  
12 required by the court. The court may examine the parties under oath as to details  
13 of the information furnished and other matters pertinent to the court's jurisdiction  
14 and the disposition of the case.

15 (4) Each party has a continuing duty to inform the court of any proceeding in  
16 this or any other state that could affect the current proceeding.

17 (5) If a party alleges in an affidavit or a pleading under oath that the health,  
18 safety, or liberty of a party or child would be jeopardized by disclosure of identifying  
19 information, the information shall be sealed and may not be disclosed to the other  
20 party or the public unless the court orders the disclosure to be made after a hearing  
21 in which the court takes into consideration the health, safety, or liberty of the party  
22 or child and determines that the disclosure is in the interest of justice.

23 **822.295 Appearance of parties and child. (1)** In a child custody proceeding  
24 in this state, the court may order a party to the proceeding who is in this state to  
25 appear before the court in person with or without the child. The court may order any

1 person who is in this state and who has physical custody or control of the child to  
2 appear in person with the child.

3 (2) If a party to a child custody proceeding whose presence is desired by the  
4 court is outside this state, the court may order that a notice given under s. 822.08  
5 include a statement directing the party to appear in person with or without the child  
6 and informing the party that failure to appear may result in a decision adverse to the  
7 party.

8 (3) The court may enter any orders necessary to ensure the safety of the child  
9 and of any person ordered to appear under this section.

10 (4) If a party to a child custody proceeding who is outside this state is directed  
11 to appear under sub. (2) or desires to appear personally before the court with or  
12 without the child, the court may require another party to pay reasonable and  
13 necessary travel and other expenses of the party so appearing and of the child.

14 SUBCHAPTER III

15 ENFORCEMENT

16 **822.31 Definitions.** In this subchapter:

17 (1) “Judicial day” means each day except Saturday, Sunday, or a legal holiday  
18 under s. 895.20.

19 (2) “Petitioner” means a person who seeks enforcement of an order for the  
20 return of a child under the Hague Convention on the Civil Aspects of International  
21 Child Abduction or enforcement of a child custody determination.

22 (3) “Respondent” means a person against whom a proceeding has been  
23 commenced for enforcement of an order for the return of a child under the Hague  
24 Convention on the Civil Aspects of International Child Abduction or enforcement of  
25 a child custody determination.

**BILL**

1           **822.32 Enforcement under Hague Convention.** Under this subchapter, a  
2 court of this state may enforce an order for the return of the child made under the  
3 Hague Convention on the Civil Aspects of International Child Abduction as if it were  
4 a child custody determination.

5           **822.33 Duty to enforce. (1)** A court of this state shall recognize and enforce  
6 a child custody determination of a court of another state if the latter court exercised  
7 jurisdiction in substantial conformity with this chapter or the determination was  
8 made under factual circumstances meeting the jurisdictional standards of this  
9 chapter and the determination has not been modified in accordance with this  
10 chapter.

11           **(2)** A court of this state may utilize any remedy available under other law of  
12 this state to enforce a child custody determination made by a court of another state.  
13 The remedies provided in this subchapter are cumulative and do not affect the  
14 availability of other remedies to enforce a child custody determination

15           **822.34 Temporary physical placement or visitation. (1)** A court of this  
16 state that does not have jurisdiction to modify a child custody determination may  
17 issue a temporary order enforcing any of the following:

18           (a) A physical placement or visitation schedule made by a court of another  
19 state.

20           (b) The physical placement or visitation provisions of a child custody  
21 determination of another state that does not provide for a specific physical placement  
22 or visitation schedule.

23           **(2)** If a court of this state makes an order under sub. (1) (b), it shall specify in  
24 the order a period that it considers adequate to allow the petitioner to obtain an order  
25 from a court having jurisdiction under the criteria specified in subch. II. The order

1 remains in effect until an order is obtained from the other court or until the period  
2 expires.

3 **822.35 Registration of child custody determination. (1)** A child custody  
4 determination issued by a court of another state may be registered in this state, with  
5 or without a simultaneous request for enforcement, by sending to the office of the  
6 clerk of any circuit court in this state all of the following:

7 (a) A letter or other document requesting registration.

8 (b) Two copies, including one certified copy, of the determination sought to be  
9 registered, and a statement under penalty of perjury that to the best of the  
10 knowledge and belief of the person seeking registration the determination has not  
11 been modified.

12 (c) Except as provided in s. 822.29, the name and address of the person seeking  
13 registration and any parent or person acting as a parent who has been awarded  
14 custody, physical placement, or visitation in the child custody determination sought  
15 to be registered.

16 **(2)** On receipt of the documents required by sub. (1), the registering court shall  
17 do all of the following:

18 (a) Cause the determination to be filed as a foreign judgment, together with one  
19 copy of any accompanying documents and information, regardless of their form.

20 (b) Serve notice upon the persons named under sub. (1) (c) and provide them  
21 with an opportunity to contest the registration in accordance with this section.

22 **(3)** The notice required by sub. (2) (b) shall state all of the following:

23 (a) That a registered determination is enforceable as of the date of the  
24 registration in the same manner as a determination issued by a court of this state.

1           (b) That a hearing to contest the validity of the registered determination shall  
2       be requested within 20 days after service of the notice.

3           (c) That failure to contest the registration will result in confirmation of the child  
4       custody determination and preclude further contest of that determination with  
5       respect to any matter that could have been asserted.

6           **(4)** A person seeking to contest the validity of a registered determination shall  
7       request a hearing within 20 days after service of the notice. At that hearing, the court  
8       shall confirm the registered determination unless the person contesting registration  
9       establishes any of the following:

10          (a) The issuing court did not have jurisdiction under subch. II.

11          (b) The child custody determination sought to be registered has been vacated,  
12       stayed, or modified by a court having jurisdiction to do so under subch. II.

13          (c) The person contesting registration was entitled to notice, but notice was not  
14       given in accordance with the standards of s. 822.08 in the proceedings before the  
15       court that issued the determination for which registration is sought.

16          **(5)** If a timely request for a hearing to contest the validity of the registration  
17       is not made, the registration is confirmed as a matter of law and the person  
18       requesting registration and all persons served must be notified of the confirmation.

19          **(6)** Confirmation of a registered determination, whether by operation of law or  
20       after notice and hearing, precludes further contest of the determination with respect  
21       to any matter that could have been asserted at the time of registration.

22          **822.36 Enforcement of registered determination. (1)** A court of this state  
23       may grant any relief normally available under the law of this state to enforce a  
24       registered child custody determination made by a court of another state.

**BILL**

1           **(2)** A court of this state shall recognize and enforce, but may not modify, except  
2           in accordance with subch. II, a registered child custody determination of a court of  
3           another state.

4           **822.37 Simultaneous proceedings.** If a proceeding for enforcement under  
5           this subchapter is commenced in a court of this state and the court determines that  
6           a proceeding to modify the determination is pending in a court of another state  
7           having jurisdiction to modify the determination under subch. II, the enforcing court  
8           shall immediately communicate with the modifying court. The proceeding for  
9           enforcement continues unless the enforcing court, after consultation with the  
10          modifying court, stays or dismisses the proceeding.

11          **822.38 Expedited enforcement of child custody determination. (1)** A  
12          petition under this subchapter must be verified. Certified copies of all orders sought  
13          to be enforced and any order confirming registration must be attached to the petition.  
14          A copy of a certified copy of an order may be attached instead of the original.

15          **(2)** A petition for enforcement of a child custody determination shall state all  
16          of the following:

17          (a) Whether the court that issued the determination identified the  
18          jurisdictional basis it relied upon in exercising jurisdiction and, if so, what the basis  
19          was.

20          (b) Whether the determination for which enforcement is sought has been  
21          vacated, stayed, or modified by a court whose decision shall be enforced under this  
22          chapter and, if so, shall identify the court, the case number, and the nature of the  
23          proceeding.

24          (c) Whether any proceeding has been commenced that could affect the current  
25          proceeding, including proceedings relating to domestic violence, protective orders,

1 determination of parental rights, and adoptions and, if so, shall identify the court,  
2 the case number, and the nature of the proceeding.

3 (d) The present physical address of the child and the respondent, if known.

4 (e) Whether relief, in addition to the immediate physical custody of the child  
5 and attorney fees is sought, including a request for assistance from law enforcement  
6 officials and, if so, the relief sought.

7 (f) If the child custody determination has been registered and confirmed under  
8 s. 822.35, the date and place of registration.

9 **(3)** Upon the filing of a petition, the court shall issue an order directing the  
10 respondent to appear in person with or without the child at a hearing and may enter  
11 any order necessary to ensure the safety of the parties and the child. The hearing  
12 shall be held on the next judicial day after service of the order unless that date is  
13 impossible. In that event, the court shall hold the hearing on the first judicial day  
14 possible. The court may extend the date of hearing at the request of the petitioner.

15 **(4)** An order issued under sub. (3) shall state the time and place of the hearing  
16 and advise the respondent that at the hearing the court will order that the petitioner  
17 may take immediate physical custody of the child and the payment of costs, fees, and  
18 expenses under s. 822.42, and the court may schedule a hearing to determine  
19 whether further relief is appropriate, unless the respondent appears and establishes  
20 one of the following:

21 (a) The child custody determination has not been registered and confirmed  
22 under s. 822.35 and any of the following:

23 1. The issuing court did not have jurisdiction under subch. II.

24 2. The child custody determination for which enforcement is sought has been  
25 vacated, stayed, or modified by a court having jurisdiction to do so under subch. II.

**BILL**

1           3. The respondent was entitled to notice, but notice was not given in accordance  
2 with the standards of s. 822.08 in the proceedings before the court that issued the  
3 order for which enforcement is sought.

4           (b) The child custody determination for which enforcement is sought was  
5 registered and confirmed under s. 822.35, but has been vacated, stayed, or modified  
6 by a court of a state having jurisdiction to do so under subch. II.

7           **822.39 Service of petition and order.** Except as provided in s. 822.41, the  
8 petition and order must be served, by any method authorized by the laws of this state,  
9 upon the respondent and any person who has physical custody of the child.

10          **822.40 Hearing and order. (1)** Unless the court issues a temporary  
11 emergency order under s. 822.24, upon a finding that a petitioner is entitled to  
12 immediate physical custody of the child, the court shall order that the petitioner may  
13 take immediate physical custody of the child unless the respondent establishes one  
14 of the following:

15          (a) The child custody determination has not been registered and confirmed  
16 under s. 822.35 and any of the following:

17           1. The issuing court did not have jurisdiction under subch. II.

18           2. The child custody determination for which enforcement is sought has been  
19 vacated, stayed, or modified by a court of a state having jurisdiction to do so under  
20 subch. II.

21           3. The respondent was entitled to notice, but notice was not given in accordance  
22 with the standards of s. 822.08 in the proceedings before the court that issued the  
23 order for which enforcement is sought.

**BILL**

1           (b) The child custody determination for which enforcement is sought was  
2 registered and confirmed under s. 822.35, but has been vacated, stayed, or modified  
3 by a court of a state having jurisdiction to do so under subch. II.

4           **(2)** The court shall award the costs, fees, and expenses authorized under s.  
5 822.42 and may grant additional relief, including a request for the assistance of law  
6 enforcement officials, and may set a further hearing to determine whether additional  
7 relief is appropriate.

8           **(3)** If a party called to testify refuses to answer on the ground that the  
9 testimony may be self-incriminating, the court may draw an adverse inference from  
10 the refusal.

11           **(4)** A privilege against disclosure of communications between spouses and a  
12 defense of immunity based on the relationship of husband and wife or parent and  
13 child may not be invoked in a proceeding under this subchapter.

14           **822.41 Warrant to take physical custody of child.** **(1)** Upon the filing of  
15 a petition seeking enforcement of a child custody determination, the petitioner may  
16 file a verified application for the issuance of a warrant to take physical custody of the  
17 child if the child is imminently likely to suffer serious physical harm or be removed  
18 from this state.

19           **(2)** If the court, upon the testimony of the petitioner or other witness, finds that  
20 the child is imminently likely to suffer serious physical harm or be removed from this  
21 state, it may issue a warrant to take physical custody of the child. The petition shall  
22 be heard on the next judicial day after the warrant is executed unless that date is  
23 impossible. In that event, the court shall hold the hearing on the first judicial day  
24 possible. The application for the warrant must include the statements required by  
25 s. 822.38 (2).

**BILL**

1           **(3)** A warrant to take physical custody of a child shall do all of the following:

2           (a) Recite the facts upon which a conclusion of imminent serious physical harm  
3 or removal from the state is based.

4           (b) Direct law enforcement officers to take physical custody of the child  
5 immediately.

6           (c) Provide for the placement of the child pending final relief.

7           **(4)** The respondent shall be served with the petition, warrant, and order  
8 immediately after the child is taken into physical custody.

9           **(5)** A warrant to take physical custody of a child is enforceable throughout this  
10 state. If the court finds on the basis of the testimony of the petitioner or other witness  
11 that a less intrusive remedy is not effective, it may authorize law enforcement  
12 officers to enter private property to take physical custody of the child. If required by  
13 exigent circumstances of the case, the court may authorize law enforcement officers  
14 to make a forcible entry at any hour.

15           **(6)** The court may impose conditions upon placement of a child to ensure the  
16 appearance of the child and the child's custodian.

17           **822.42 Costs, fees, and expenses. (1)** The court shall award the prevailing  
18 party, including a state, necessary and reasonable expenses incurred by or on behalf  
19 of the party, including costs, communication expenses, attorney fees, investigative  
20 fees, expenses for witnesses, travel expenses, and expenses for child care during the  
21 course of the proceedings, unless the party from whom fees or expenses are sought  
22 establishes that the award would be clearly inappropriate.

23           **(2)** The court may not assess fees, costs, or expenses against a state unless  
24 authorized by law other than this chapter.

**BILL**

1           **822.43 Recognition and enforcement.** A court of this state shall accord full  
2 faith and credit to an order issued by another state and consistent with this chapter  
3 that enforces a child custody determination by a court of another state unless the  
4 order has been vacated, stayed, or modified by a court having jurisdiction to do so  
5 under subch. II.

6           **822.44 Appeals.** An appeal may be taken from a final order in a proceeding  
7 under this subchapter in accordance with ch. 809. Unless the court enters a  
8 temporary emergency order under s. 822.24, the enforcing court may not stay an  
9 order enforcing a child custody determination pending appeal.

10           **822.45 Role of prosecutor. (1)** A prosecutor, in a case arising under this  
11 chapter or involving the Hague Convention on the Civil Aspects of International  
12 Child Abduction, may take any lawful action, including resort to a proceeding under  
13 this subchapter or any other available civil proceeding to locate a child, obtain the  
14 return of a child, or enforce a child custody determination if any of the following  
15 exists:

16           (a) A child custody determination.

17           (b) A request to do so from a court in a pending child custody proceeding.

18           (c) A reasonable belief that a criminal statute has been violated.

19           (d) A reasonable belief that the child has been wrongfully removed or retained  
20 in violation of the Hague Convention on the Civil Aspects of International Child  
21 Abduction.

22           **(2)** A prosecutor acting under this section acts on behalf of the court and may  
23 not represent any party.

24           **822.46 Role of law enforcement.** At the request of a prosecutor acting under  
25 s. 822.45, a law enforcement officer may take any lawful action reasonably necessary

1 to locate a child or a party and assist a prosecutor with responsibilities under s.  
2 822.45.

3 **822.47 Costs and expenses.** If the respondent is not the prevailing party, the  
4 court may assess against the respondent all direct expenses and costs incurred by the  
5 prosecutor and law enforcement officers under s. 822.45 or 822.46.

6 **SECTION 8.** 948.31 (3) (b) of the statutes is amended to read:

7 948.31 **(3)** (b) After being served with process in an action affecting the family  
8 but prior to the issuance of a temporary or final order determining child custody  
9 rights, takes the child or causes the child to leave with intent to deprive the other  
10 parent of physical custody as defined in s. 822.02 ~~(9)~~ (14).

11 **SECTION 9. Initial applicability.**

12 (1) This act first applies to child custody proceedings, including modification  
13 proceedings, and proceedings to enforce or register child custody determinations  
14 that are commenced on the effective date of this subsection.
