This Memo lists the issues that committee members have raised regarding election law reform. The list is comprised of issues that were raised for the first time at the November 17 meeting of the committee and issues that had been previously identified and discussed in Memo No. 2, dated November 10, 2004. The issues have been organized into three categories: Pre-Election Issues; Election Day Issues; and Post-Election Issues. Each category will have a separate Memo prepared for it in which background material will be supplied concerning the listed issues. These Memos will be the basis for future committee discussions.
