WHEREAS, the absentee voting process was originally designed to enable elderly, disabled, hospitalized, military and overseas voters, and people who where going to be absent from the Village on Election Day an alternate means to cash their ballot; and

WHEREAS, 1999 Wisconsin Act 182 was adopted which allows voters to request an absentee ballot to me mailed to their home or to vote early in the Village Clerk's office without having to give a reason; and

WHEREAS, various political parties and special interest groups have mailed promotional material encouraging electors to vote by absentee ballot for the sake of convenience; and

WHEREAS, postage for each absentee ballot sent costs the Village \$0.97, plus the cost of the absentee envelopes, supplies and labor involved to process and track absentee ballots, in addition to the extra burden put on election workers on Election Day to process the absentee ballots; and

WHEREAS, the Village of Valders must absorb the cost of absentee voting for all elections without any financial assistance for the State of Wisconsin.

NOW THEREFORE BE IT RESOLVED, that the Village Board of Trustees of the Village of Valders hereby petitions the State of Wisconsin Legislature to reinstate the law requiring a person to receive an absentee ballot only if they are elderly, disabled, hospitalized, in the military, living overseas, or absent from the Village on Election Day.

WHEREAS, the Village of Valders, resolution #2005-2 was introduced and its adoption moved by Trustee Harrington and seconded by Trustee Bartelme. Upon a poll vote thereon; the results are as follows:
