Analysis by the Legislative Reference Bureau

This bill is explained in the NOTES provided by the Joint Legislative Council in the bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

PREFATORY NOTE: This draft was prepared for the Joint Legislative Council's Special Committee on Recodification of Chapter 45, Veterans, based on recommendations of the committee's drafting subcommittee. The special committee was directed to conduct a recodification of ch. 45, relating to veterans, to include reorganizing the chapter in a logical manner, renumbering and retitling sections, consolidating related provisions, modernizing language, resolving ambiguities in language, making other necessary organizational changes, and making minor substantive changes.

The draft does the following:

1. Reorganizes the entire chapter by subdividing it into 8 subchapters. Currently, the chapter consists of 2 subchapters, one of which relates to housing programs, and the other of which includes all other veterans programs and services.
2. Makes nonsubstantive editorial changes to modernize language to make the language consistent with current drafting style.
3. Repeals several provisions considered no longer necessary. For example, language regarding construction of veterans memorials that have already been constructed is eliminated. As another example, language regarding employment of disabled veterans is eliminated in light of the state Fair Employment Act and the federal Americans with Disabilities Act.
4. Moves to other chapters of the statutes provisions from current ch. 45 that are not directly related to veterans. For example, provisions dealing with military service (ss. 45.50, 45.51, and 45.53) are moved to ch. 21, which relates to military affairs. As another example, the provision dealing with the educational approval board (s. 45.54) is moved to ch. 39, which relates to educational agencies.
5. Simplifies confusing statutory language by drafting it in a format that is easier to understand. For example, the formula for awarding grants to veterans organizations in current s. 45.353 (2) is simplified in the new s. 45.41 (2) by showing how much is received by the organization depending on the level of expenditure.
6. Makes minor substantive changes that the special committee concluded are relatively noncontroversial. These include the following:
 - a. Expanding the definition of "veteran" that is used in current ch. 45 to include persons who are missing in action, persons who died as the result of a service-connected disability, and persons who died in the line of duty while on active duty for training purposes.
 - b. Changing the names of the state veterans facilities in current statutes to the Wisconsin Veterans Home at Union Grove, the Wisconsin Veterans Home at King, and the Wisconsin Veterans Home at Chippewa Falls, and generally applying the laws that currently apply to just one or 2 of the homes to all 3 homes.
 - c. Expanding the definition of "war period" to include any period after the Iraq War that results in a person receiving an Expeditionary Medal and that the state department

of veterans affairs determines and designates by rule. In designating a war period, the department would be required to review the criteria used to establish the war periods currently listed in the statutes and consult with the U.S. department of veterans affairs.

d. Requiring that ch. 45 be construed as liberally as the language permits in favor of applicants. Currently, the liberal construction provision applies to many, but not all, parts of the chapter.

7 him or her to receive the Armed Forces Expeditionary Medal, established by
8 executive order 10977 on December 4, 1961, the Vietnam Service Medal established
9 by executive order 11231 on July 8, 1965, the Navy Expeditionary Medal, or the
10 Marine Corps Expeditionary Medal.

11 (d) A person who has served on active duty in the U.S. armed forces or in forces
12 incorporated as part of the U.S. armed forces under honorable conditions, for 2
13 continuous years or more or for the full period of his or her initial service obligation,
14 whichever is less.

15 (e) A person who was honorably discharged from the U.S. armed forces or from
16 forces incorporated as part of the U.S. armed forces for a service-connected
17 disability, for a disability subsequently adjudicated to have been service connected,
18 or for reasons of hardship.

19 (f) A person who was released under honorable conditions from the U.S. armed
20 forces or from forces incorporated as part of the U.S. armed forces due to a reduction
21 in the U.S. armed forces.

22 (g) A person who died while in service in the U.S. armed forces or in forces
23 incorporated as part of the U.S. armed forces.

24 (h) A person who, while serving in the U.S. armed forces or in forces
25 incorporated as part of the U.S. armed forces, is missing in action.

1 (i) A person who died as the result of a service-connected disability.

2 (j) A person who died in the line of duty while on active duty for training
3 purposes in the U.S. armed forces or in forces incorporated as part of the U.S. armed
4 forces.

****NOTE: In this bill, the following 3 categories of persons are included in the definition of “veteran” that are not included under current law:

a. A person who is missing in action while serving in the U.S. armed forces or in forces incorporated as part of the armed forces.

b. A person who dies as a result of a service-connected disability.

c. A person who dies in the line of duty while on active duty for training purposes in the U.S. armed forces or forces incorporated in the armed forces.

5 **(12)** “Veterans home” means the Wisconsin Veterans Home at Union Grove, the
6 Wisconsin Veterans Home at King, and the Wisconsin Veterans Home at Chippewa
7 Falls.

****NOTE: This bill defines the term “veterans home” to mean the 3 veterans homes — at King, Union Grove, and Chippewa Falls. Thus, particularly in subch. V provisions where “veterans home” or “veterans homes” appears, the term pertains to all 3 facilities. Under current law, many of the provisions refer by name to just one or 2 of the homes.

8 **(13)** “War period” means any of the following:

9 (a) Indian War: between 1860 and 1898.

10 (b) Spanish–American War: between April 21, 1898, and April 11, 1899.

11 (c) Philippine Insurrection: between April 12, 1899, and July 4, 1902 (extended
12 to July 15, 1903, if actually engaged in Moro Province hostilities).

13 (d) Boxer Rebellion: between June 16, 1900, and May 12, 1901.

14 (e) Mexican border service: between June 19, 1916, and April 5, 1917.

15 (f) World War I: between April 6, 1917, and November 11, 1918 (extended to
16 April 1, 1920, if service was in Russia).

17 (g) World War II: between August 27, 1940, and July 25, 1947.

18 (h) Korean conflict: between June 27, 1950, and January 31, 1955.

1 (i) Vietnam War: between August 5, 1964, and January 1, 1977, excepting
2 service on active duty for training purposes only.

3 (j) Persian Gulf War: between August 1, 1990, and the ending date of Operation
4 Desert Shield or the ending date of Operation Desert Storm as established by the
5 department by rule.

6 (k) Afghanistan War: between September 11, 2001, and the ending date of
7 Operation Enduring Freedom or an operation that is a successor to Operation
8 Enduring Freedom, as established by the department by rule.

****NOTE: The language in par. (k), above, is not in current ch. 45. It is intended to provide a mechanism for designating future war periods without having to enact legislation each time. Instead, the department of veterans affairs (DVA) would be authorized to determine and designate a war period by rule, after reviewing criteria used to establish existing war periods and consulting with the U.S. DVA, when the U.S. is in a conflict that places persons at such risk that the DVA concludes the period should be designated a war period.

9 (m) Iraq War: between March 19, 2003, and the ending date of Operation Iraqi
10 Freedom or an operation that is a successor to Operation Iraqi Freedom, as
11 established by the department by rule.

12 (n) Any period after the period specified in par. (j) that results in a person
13 receiving an expeditionary medal, and that the department determines and
14 designates by rule, after reviewing the criteria used to establish the war periods
15 under pars. (a) to (m) and after consultation with the U.S. department of veterans
16 affairs, to be a period when the United States is in a conflict that places persons at
17 such a risk that the period should be designated as a war period for purposes of this
18 chapter.

19 **45.02 Eligibility for benefits. (1)** Any person whose service on active duty
20 with the U.S. armed forces or in forces incorporated as part of the U.S. armed forces
21 makes that person eligible for general U.S. department of veterans affairs benefits

1 shall be considered to have served under honorable conditions for purposes of this
2 chapter.

3 (2) Except as provided in sub. (3), to be eligible for benefits under this chapter
4 an applicant shall be a resident of and living in this state at the time of making
5 application or the veteran from whom the applicant derives eligibility is deceased,
6 and the veteran from whom eligibility is derived meets one of the following
7 conditions:

8 (a) His or her selective service local board, if any, and home of record at the time
9 of entry or reentry into active service as shown on the veteran's report of separation
10 from the U.S. armed forces for a qualifying period were in this state.

11 (b) The veteran was a resident of this state at the time of entry or reentry into
12 active duty.

13 (c) The veteran was a resident of this state for any consecutive 12-month period
14 after entry or reentry into service and before the date of his or her application or
15 death.

16 (3) Veterans who are otherwise eligible and who are serving on active duty in
17 the U.S. armed forces need not be living in this state on the date of application to
18 qualify for benefits from the department.

19 (4) If the department determines that a person applying for a benefit under this
20 chapter meets the residency requirement under sub. (2) (c), the department may not
21 require the person to reestablish that he or she meets that residency requirement
22 when he or she later applies for any other benefit under this chapter that requires
23 that residency.

24 **45.03 Department of veterans affairs. (1) POLICY.** It is the policy of the
25 state to give health, educational, and economic assistance to veterans and their

1 dependents who are residents of this state to the extent and under the conditions
2 determined by the board within the limitations set forth in this section.

3 **(2) BOARD FUNCTIONS.** The board may promulgate rules necessary to carry out
4 the purposes of this chapter and the powers and duties conferred upon it. The records
5 and files of the department of military affairs and of any other state department or
6 officer shall, upon request, be made available to the board.

***NOTE: Under current s. 45.35 (7a), DVA is required to provide the register of
deeds in every county with the names of all persons from the county who died while in
the service during wars ranging from the Spanish–American War through the Vietnam
War. After consulting with registers of deeds and determining that they have not been
receiving such lists, the subcommittee concluded that the requirement is outdated and
should be removed.

7 **(3) COUNCIL ON VETERANS PROGRAMS.** (a) The council on veterans programs
8 created under s. 15.497 shall advise the board and the department on solutions and
9 policy alternatives relating to the problems of veterans.

10 (b) The council on veterans programs and the department, jointly or separately,
11 shall submit a report regarding the council on veterans programs to the chief clerk
12 of each house of the legislature for distribution to the legislature under s. 13.172 (2)
13 by September 30 of every odd–numbered year. The report shall include a general
14 summary of the activities and membership over the past 2 years of the council and
15 each organization on the council.

16 **(4) DEPARTMENT STAFF.** (a) The department shall employ staff necessary to
17 carry out its functions. The secretary shall appoint under the classified service such
18 persons as are necessary to carry out the policy of the board. All persons appointed
19 by the department shall, if possible, be veterans and preference shall be given to
20 disabled veterans.

21 (b) The department upon request shall assist without charge all persons
22 residing in the state having claims against the United States where the claims have

1 arisen out of or by reason of service in the U.S. armed forces. The department may
2 act as agent or power of attorney in pursuing claims for persons requesting the
3 department to do so.

4 (c) The department shall employ regional coordinators. The duties of a regional
5 coordinator shall include providing direct claims and benefit application assistance
6 to veterans. The regional coordinators shall coordinate claims and benefit
7 application assistance with the appropriate county veterans service officers to
8 maximize the level of assistance and benefits provided to veterans.

9 (d) The department shall employ claims officers. The claims officers shall
10 provide federal claims and benefit assistance to veterans and shall be based in the
11 department's regional office in Milwaukee County.

12 (e) The department shall employ mobile claims officers in each of the
13 department's regions. The mobile claims officers shall provide claims and benefit
14 assistance to veterans. The mobile claims officers shall coordinate that claims and
15 benefit assistance with the appropriate county veterans service officers to maximize
16 the level of assistance and benefits provided to veterans.

17 **(5) DEPARTMENT POWERS TO PROVIDE STRUCTURES, FACILITIES, AND PERMANENT**
18 **IMPROVEMENTS. (a) In this subsection, unless the context requires otherwise:**

19 1. "Existing building" in relation to any conveyance, lease, or sublease made
20 under par. (c) 1. means all detention, treatment, administrative, recreational,
21 infirmary, hospital, vocational, and academic buildings; all dormitories and cottages;
22 all storage facilities, heating plants, sewage disposal plants, and other buildings,
23 structures, facilities, and permanent improvements that in the judgment of the
24 board are needed or useful for the purposes of the department, and all equipment for

1 them and all improvements and additions to them that were erected, constructed, or
2 installed prior to the making of the conveyance, lease, or sublease.

3 2. “New building” in relation to any conveyance, lease, or sublease made under
4 par. (c) 1. means all detention, treatment, administrative, recreational, infirmary,
5 hospital, vocational, and academic buildings; all dormitories and cottages; all
6 storage facilities, heating plants, sewage disposal plants, and other buildings,
7 structures, facilities, and permanent improvements as in the judgment of the board
8 are needed or useful for the purposes of the department, and all equipment for them
9 and all improvements and additions to them that are erected, constructed, or
10 installed after the making of the conveyance, lease, or sublease.

11 3. “Nonprofit corporation” means a nonstock corporation that is organized
12 under ch. 181 and that is a nonprofit corporation, as defined in s. 181.0103 (17).

13 (b) The department may acquire by gift, purchase, or condemnation property
14 for the purposes of providing a headquarters and museum building for the
15 department.

16 (c) 1. To provide new buildings and to enable the construction and financing of
17 new buildings, to refinance indebtedness created by a nonprofit corporation for the
18 purpose of providing a new building or buildings or additions or improvements to a
19 new building that is located on land owned by, or owned by the state and held for, the
20 department or on lands of the institutions under the jurisdiction of the department
21 or by the nonprofit corporation, or for any one or more of these purposes, the
22 department has the following powers and duties:

23 a. Without limitation by reason of any other provisions of the statutes, unless
24 otherwise required by law, the power to sell and to convey title in fee simple to a
25 nonprofit corporation any land and any existing buildings owned by the state that

1 are under the jurisdiction of the department for the consideration and upon the
2 terms and conditions as in the judgment of the board are in the public interest.

3 b. Unless otherwise required by law, the power to lease to a nonprofit
4 corporation for a term or terms not exceeding 50 years each any land and any existing
5 buildings owned by the state that are under the jurisdiction of the department upon
6 the terms and conditions as in the judgment of the board are in the public interest.

7 c. The power to lease or sublease from the nonprofit corporation, and to make
8 available for public use, any land, or any land and existing buildings conveyed or
9 leased to such nonprofit corporation under subd. 1. a. and b., and any new buildings
10 erected upon such land or upon any other land owned by the nonprofit corporation,
11 upon the terms, conditions, and rentals, subject to available appropriations, as in the
12 judgment of the board are in the public interest.

13 d. The duty to submit the plans and specifications for all new buildings to the
14 building commission for approval whenever required by law and to submit plans and
15 specifications for all new buildings and all conveyances, leases, and subleases made
16 under this subsection to the department of administration and the governor for
17 written approval before they are finally adopted, executed, and delivered.

18 e. The power to pledge and assign all or any part of the revenues derived from
19 the operation of any land or new buildings as security for the payment of rentals due
20 and to become due under any lease or sublease of new buildings under subd. 1. c.

21 f. The power to covenant and agree in any lease or sublease of any land or new
22 buildings made under subd. 1. c. to impose fees, rentals, or other charges for the use
23 and occupancy or other operation of new buildings in an amount calculated to
24 produce net revenues sufficient to pay the rentals due and to become due under the
25 lease or sublease.

1 g. The power to apply all or any part of the revenues derived from the operation
2 of any land or existing buildings to the payment of rentals due and to become due
3 under any lease or sublease made under subd. 1. c.

4 h. The power to pledge and assign all or any part of the revenues derived from
5 the operation of any land or existing buildings to the payment of rentals due and to
6 become due under any lease or sublease made under subd. 1. c.

7 i. The power to covenant and agree in any lease or sublease made under subd.
8 1. c. to impose fees, rentals, or other charges for the use and occupancy or other
9 operation of any land or existing buildings in an amount calculated to produce net
10 revenues sufficient to pay the rentals due and to become due under the lease or
11 sublease.

12 j. The power and duty, upon receipt of notice of any assignment by any nonprofit
13 corporation of any lease or sublease made under subd. 1. c., or of any of its rights
14 under any sublease, to recognize and give effect to the assignment, and to pay to the
15 assignee rentals or other payments then due or that may become due under any lease
16 or sublease that has been assigned by the nonprofit corporation.

17 2. The state shall be liable for accrued rentals and for any other default under
18 any lease or sublease made under subd. 1. c., and may be sued for the accrued rentals
19 or other default on contract as in other contract actions under ch. 775, except that
20 the lessor under the lease or sublease or any assignee of the lessor or any person or
21 other legal entity proceeding on behalf of the lessor is not required to file any claim
22 with the legislature prior to the commencement of the action.

23 3. Nothing in this subsection empowers the board or the department to incur
24 any state debt.

1 4. All powers and duties conferred upon the board or the department under this
2 subsection shall be exercised and performed by resolution of the board. All
3 conveyances, leases, and subleases made under this subsection, when authorized by
4 resolution of the board, shall be made, executed, and delivered in the name of the
5 department and shall be signed by the secretary and sealed with the seal of the
6 department.

7 5. All laws, conflicting with any provisions of this subsection, are, insofar as
8 they conflict with this section and no further, superseded by this subsection.

9 **(6) COORDINATION DUTIES.** The department shall coordinate the activities of all
10 state agencies and the University of Wisconsin Hospitals and Clinics Authority
11 performing functions relating to the medical, hospital, or other remedial care;
12 placement and training; and educational, economic, or vocational rehabilitation of
13 veterans. In particular, the department shall coordinate the activities of the
14 technical college system board, state selective service administration, department
15 of health and family services, department of workforce development, department of
16 public instruction, the University of Wisconsin System and other educational
17 institutions, the University of Wisconsin Hospitals and Clinics Authority, and all
18 other departments or agencies performing any of the functions specified, to the end
19 that the benefits provided in this section may be made available to veterans as
20 promptly and effectively as possible.

21 **(7) CONTACT DUTIES.** The department shall maintain contacts with county
22 veterans service officers and local agencies, the American Red Cross, and veterans
23 organizations concerned with the welfare of veterans and shall contact and cooperate
24 with federal agencies in securing for veterans all benefits to which they may be
25 entitled.

1 **(8) MINORS' EXECUTION OF DOCUMENTS; BENEFITS EXEMPT FROM EXECUTION.** (a) Any
2 minor who is a veteran and any minor who is the spouse, surviving spouse, or child
3 of a veteran may execute notes, mortgages, and other contracts and conveyances to
4 the department and the notes, mortgages, contracts, and conveyances are not subject
5 to the defense of infancy.

6 (b) The benefits and aid provided under ss. 45.20 (3) and 45.40 are not
7 assignable and are exempt from garnishment and execution.

8 **(9) VOCATIONAL TRAINING.** The department in cooperation with the department
9 of workforce development shall make available to disabled veterans the benefits of
10 vocational training and guidance, including those veterans who have filed claims for
11 federal rehabilitation benefits and during the pendency of the claims. If the claims
12 are allowed and federal reimbursement is made to the state, the money shall be paid
13 into the veterans trust fund.

14 **(10) TRAINING AND EMPLOYMENT OF VETERANS.** The department, in cooperation
15 with the department of workforce development and state selective service
16 administration and any other federal, state, or local agency, shall formulate and
17 carry out plans for the training and employment of veterans.

18 **(11) APPROVAL AGENCY FOR VETERANS TRAINING.** (a) Except as provided in par.
19 (b), the department shall be the state approval agency for the education and training
20 of veterans and other eligible persons. The department shall approve and supervise
21 schools and courses of instruction for the training of veterans and eligible persons
22 under 38 USC 3670, and may enter into and receive money under contracts with the
23 U.S. department of veterans affairs or other appropriate federal agencies.

24 (b) The governor may designate the following agencies for approval and
25 supervision of special phases of the program of veterans education:

1 1. On-the-job and apprenticeship training program, the department of
2 workforce development.

3 2. On-the-farm training program, the technical college system board.

4 3. Funeral directors apprentices, the funeral directors examining board.

NOTE: Do these programs exist?

5 **(12) GIFTS AND BEQUESTS.** (a) The department may receive gifts and bequests
6 in its name for the benefit of Wisconsin veterans and their dependents in accordance
7 with policies adopted by the board. Moneys received shall be credited to the veterans
8 trust fund.

9 (b) The department may receive moneys or other gifts and bequests in its name
10 for the benefit of the Wisconsin Veterans Museum. Moneys received shall be credited
11 to the veterans trust fund and used, as far as practicable, in accordance with the
12 wishes of the donors and in accordance with the board's policies.

13 **(13) ADDITIONAL DUTIES.** The department shall do all the following:

14 (a) Assist in the coordination of the state, county, municipal, and private
15 activities relating to veterans housing.

16 (b) Cooperate with any federal departments, agencies, and independent
17 establishments relating to veterans housing, benefits, priorities, and finances.

18 (c) Assist any housing authority, municipality, or private enterprise engaged
19 in supplying veterans housing in the acquisition of materials, finances, legal aid, and
20 compliance with federal regulations.

21 (d) Utilize the services and facilities of state agencies and county veterans
22 service officers, including legal services furnished to the department by the
23 department of justice.

1 (e) Provide county veterans service officers with the information provided to
2 the department by the adjutant general under s. 21.19 (14) and may provide county
3 veterans service officers with information on all necessary military points of contact
4 and general deployment information for reserve units of the U.S. armed forces.

5 **(14) LIBERAL CONSTRUCTION INTENDED.** This chapter shall be construed as
6 liberally as the language permits in favor of applicants.

****NOTE: Current law requires that certain provisions of ch. 45 be construed as liberally as the language permits in favor of applicants (for veterans benefits). Those provisions relate to: (1) general DVA powers and duties; (2) tuition reimbursement; (3) economic assistance; (4) personal loans; (5) veterans homes; and (6) housing loans. This bill would extend that requirement for liberal construction of provisions to the chapter as a whole.

7 **(15) DEFERRAL OF PAYMENTS AND INTEREST ON LOANS.** When a veteran or a
8 member of the veteran's family makes application for deferment of payment of
9 monthly installments and waiver of interest charges on veterans loans made under
10 this chapter, showing that the ability of the veteran to make payment is materially
11 and adversely affected by reason of military service, the department may, with the
12 approval of the board, defer payment of monthly installments and waive interest
13 charges on veterans loans made under this chapter for the duration of any period of
14 service in the armed forces of the United States during a national emergency or in
15 time of war or under P.L. 87-117 and 6 months from date of discharge or separation
16 and the time for payment may be extended for the same period. However, when funds
17 estimated to be received in the veterans mortgage loan repayment fund to pay debt
18 service on public debt contracted under s. 20.866 (2) (zn) and (zo) are less than the
19 funds estimated to be required for the payment of the debt service, the board may
20 grant deferral of payments and interest on loans provided under s. 45.37 only when
21 so required by federal law.

1 **(16) APPLICATION REQUIREMENTS AND PENALTIES.** (a) If the department finds that
2 an applicant for benefits from the department has willfully made or caused to be
3 made, or conspired, assisted in, agreed to, arranged for, or in any way procured the
4 making of a false or fraudulent affidavit, declaration, certificate, statement, or other
5 writing, it may suspend all benefits available to the applicant from the department
6 under this chapter.

7 (b) Any person who, with the intent to secure any benefits under this chapter
8 for personal benefit or for others, willfully makes or causes to be made, or conspires,
9 assists in, agrees to, arranges for, or in any way procures the making or presentation
10 of a false or fraudulent affidavit, declaration, certificate, statement, or other writing,
11 may be fined not more than \$500 or be imprisoned for not more than 6 months, or
12 both. The fine or imprisonment may be imposed in addition to the penalty provided
13 in par. (a).

14 (c) 1. As used in this paragraph, “fair consideration” means the exchange of
15 property, assets, or obligations for a fair equivalent, in an amount not
16 disproportionately small or large compared to the value of the property, assets, or
17 obligations, as reflected in similar market transactions.

18 2. The department shall declare immediately due and payable any loan made
19 after July 29, 1979, under a program administered by the department under s. 45.40
20 or subch. III, if it finds that the loan was granted to an ineligible person due to any
21 of the following circumstances:

22 a. The applicant did not report income amounts as required on the loan
23 application.

24 b. The applicant did not make the disclosures required under subd. 3. a., b., or
25 c. on the loan application.

1 c. The applicant transferred assets or liabilities or incurred liabilities for less
2 than fair consideration with the intent to qualify for and secure the loan.

3 3. Loan application forms processed by the department for programs
4 administered under s. 45.40 or subch. III shall do all of the following:

5 a. Require disclosure of any asset with a value over \$500 transferred by the
6 applicant for less than fair consideration, within one year immediately prior to the
7 loan application date. In determining the applicant's need for a loan, the department
8 shall consider those transferred assets to be assets of the applicant.

9 b. Require disclosure of any liability of more than \$500 incurred by the
10 applicant for less than fair consideration, within one year immediately prior to the
11 loan application date. In determining the applicant's need for a loan, the department
12 shall not consider these liabilities to be liabilities of the applicant.

13 c. Require disclosure of all liabilities transferred by the applicant within one
14 year immediately prior to the loan application date. The liabilities transferred for
15 less than fair consideration shall be considered by the department to be liabilities of
16 the applicant to the extent he or she is liable for their payment or for reimbursement
17 of the transferee.

18 d. Contain notification of the penalties provided for in this subsection.

19 4. The department shall incorporate the payment acceleration requirements
20 of subd. 2. in all loan documents for programs administered by the department under
21 s. 45.40 or subch. III.

22 **(17) LOAN REPAYMENTS.** The department shall deposit all repayments of loans
23 and payments of interest made on loans under s. 45.351 (2), 1995 stats., s. 45.356,
24 1995 stats., or s. 45.80, 1989 stats., in the veterans trust fund.

1 **(18) COLLECTIONS.** The department may enter into contracts to collect
2 delinquent loan payments owed to the department. The department may allocate a
3 portion of the amounts collected under the contracts to pay contract costs.
4 Notwithstanding the provisions of s. 45.04, the department may release information
5 contained in its files pertaining to applications for benefits to contractors providing
6 collection services to the department.

7 **(19) LOAN GUARANTEE.** The department may provide a loan guarantee for
8 multifamily transitional housing for homeless veterans.

9 **45.04 Release of information and records. (1) DEFINITIONS.** In this section:

10 (a) “Duly authorized representative” means any person authorized in writing
11 by the veteran to act for the veteran, the veteran’s guardian if the veteran is
12 adjudicated incompetent, or a legal representative if the veteran is deceased. Where
13 for proper reason no representative has been or will be appointed, the veteran’s
14 spouse, an adult child, or, if the veteran is unmarried, either parent of the veteran
15 shall be recognized as the duly authorized representative.

16 (b) “Service office” means a county veterans service office.

17 **(2) SEPARATION DOCUMENTS.** Separation documents and copies of separation
18 documents evidencing service in the armed forces of the U.S. are confidential and
19 privileged. Examination of these records in the possession of the department or
20 service office is limited to authorized employees of the department or service office
21 and information entered in these records may be disclosed only to veterans and their
22 duly authorized representatives or to interested governmental agencies for the
23 purpose of assisting veterans and their dependents to obtain the rights and benefits
24 to which they may be entitled.

1 **(3) U.S. DEPARTMENT OF VETERANS AFFAIRS RECORDS.** Records and papers in the
2 possession of the department or service office that are released to the department or
3 service office by the U.S. department of veterans affairs or that contain information
4 provided by the U.S. department of veterans affairs are confidential. Release of
5 information from these records or papers may be made only under regulations of the
6 U.S. department of veterans affairs.

7 **(4) INVESTIGATION.** All reports of investigation made by employees of the
8 department or at the direction of the department for official departmental purposes
9 are only for the use of the secretary and staff. Materials and information that
10 disclose the investigative techniques of the department or the identity of confidential
11 informants and material received in confidence by representatives of the department
12 may not be released.

13 **(5) VITAL RECORDS.** The service office may obtain a copy of a vital record under
14 s. 69.30 (2) and may transmit the copy to the department or to the U.S. department
15 of veterans affairs to assist a veteran or his or her dependent in obtaining a benefit.

16 **(6) DISCLOSURE OF MONETARY BENEFITS.** The department shall disclose, to any
17 person who requests, the amount of any payment, grant, or loan made by the
18 department to any applicant. A person seeking this information shall be required
19 to sign a statement setting forth the person's name and address and the reason for
20 making the request and certifying that the person will not use the information
21 obtained for commercial or political purposes.

22 **(7) DISCLOSURE OF LOAN STATUS INFORMATION.** The department may disclose to
23 a consumer reporting agency, as defined in 15 USC 1681a (f), the current repayment
24 status of, the balances due on, and other relevant information pertaining to
25 department loans that is readily accessible on any loans on which balances are due

1 and owing the department. The department may charge consumer reporting
2 agencies an amount sufficient to cover all the costs of preparation and delivery of the
3 information.

4 **(8) DISCLOSURE OF OTHER INFORMATION.** Except as provided in subs. (2) to (6),
5 all files, records, reports, papers, and documents pertaining to applications for
6 benefits from the department, and information contained in them, may be released
7 by the department or service office only under rules of the department. The rules
8 shall provide for the furnishing of information required under sub. (7) and for official
9 purposes by any agency of the U.S. government, by any agency of this state, by any
10 law enforcement, social services, or human services agency of any Wisconsin county,
11 or by members of the state senate and assembly. The rules shall otherwise provide
12 for release of personal information pertaining to or contained in any application for
13 benefits, whether pending or adjudicated, only when authorized in writing by the
14 applicants or when necessary to assist applicants in securing veterans benefits that
15 the applicants may be entitled to or when necessary for the efficient management of
16 loans made by the department.

17 **45.05 Registration of certificate of discharge.** Every person who has
18 served in the U.S. armed forces at any time, and who has been honorably discharged
19 or given a certificate of service or relieved from active service may record with the
20 register of deeds of any county, in a suitable book provided by the county for that
21 purpose, a certificate of discharge or release. The certificate shall be accessible only
22 to the discharged person or that person's dependents or duly authorized
23 representative, as defined in s. 45.04 (1) (a), the county veterans service officer, the
24 department, or any person with written authorization from the discharged person
25 or that discharged person's dependents. The register of deeds may not charge for

1 recording, except that in counties where the register of deeds is under the fee system
2 and not paid a fixed salary, the county shall pay the fee specified in s. 59.43 (2) (ag).
3 The record of any certificate of discharge or release made prior to July 6, 1919, is
4 legalized.

5 **45.06 Security. (1)** It shall be unlawful for any person to receive or accept as
6 a security or to withhold from a veteran or a person who was honorably discharged
7 from the U.S. armed forces any discharge paper, citation, warrant, medal, badge, or
8 evidence upon which the veteran is entitled to certain rights, as a veteran under the
9 laws of the United States or of this state, and any transfer of the item during the life
10 of the veteran upon a consideration or otherwise shall be null and void, and the
11 refusal or willful neglect of any person to return or deliver upon demand the
12 discharge paper, citation, warrant, medal, badge, or evidence is punishable as
13 provided in sub. (2).

14 **(2)** Any person who violates this section shall be fined not more than \$100 or
15 imprisoned for not more than 6 months, or both.

16 **45.07 Wisconsin Veterans Museum. (1)** The department of administration
17 shall provide suitable space for the purpose of a memorial hall, designated as the
18 Wisconsin Veterans Museum, dedicated to the veterans of Wisconsin and to the men
19 and women of Wisconsin who served in the armed forces of the United States in the
20 civil war of 1861 to 1865. The department of veterans affairs shall operate the
21 Wisconsin Veterans Museum. The mission of the Wisconsin Veterans Museum is to
22 acknowledge, commemorate, and affirm the role of Wisconsin veterans in the United
23 States of America's military past by means of instructive exhibits and other
24 educational programs.

1 **(2)** The battle flags of Wisconsin units serving in the nation's wars and all relics
2 and mementos of the nation's wars donated to or otherwise acquired by the state for
3 display in the Wisconsin Veterans Museum shall constitute the memorial collection.

4 The department shall do all of the following:

5 (a) Catalog and identify all war relics and mementos of the memorial collection.

6 (b) Restore, preserve, and safeguard the relics and mementos of the memorial
7 collection.

8 (c) Procure additions to the memorial collection.

9 (d) Provide proper display equipment and display the memorial collection to
10 make it instructive and attractive to visitors.

11 **45.08 Memorial Day. (1)** Every department and agency of the state
12 government, every court of the state, and every political subdivision of the state,
13 shall give a leave of absence with pay for the last Monday in May of each year, the
14 day of celebration for May 30, Memorial Day, to every person in the employ of the
15 state or political subdivision who has at any time served in and been honorably
16 discharged from the U.S. armed forces or from forces incorporated as part of the U.S.
17 armed forces. A refusal to give the leave of absence to a person entitled to the leave
18 constitutes neglect of duty.

19 **(2)** If the nature of the duties of the department, agency, court, or political
20 subdivision necessitates the employment of persons eligible for a leave of absence
21 under sub. (1), the department, agency, court, or political subdivision shall arrange
22 and assign the necessary work so as to permit the largest possible numbers of eligible
23 persons to have a leave of absence either all or part of Memorial Day.

****NOTE: Under current law and this bill, all state government departments and agencies, including state courts, every "superintendent or foreman on the public works of the state," and all political subdivisions must give a paid leave of absence to veterans

1 or quarter credit requirements of the program or school in which the student is
2 enrolled.

3 c. Enrollment by any other eligible student in courses for which no more than
4 11 semester or the equivalent trimester or quarter credits will be given upon
5 satisfactory completion.

6 d. Study during a summer semester or session.

7 3. “Tuition” means any of the following:

8 a. For the University of Wisconsin System, academic fees, as described in s.
9 36.27 (1), and segregated fees.

10 b. For technical colleges, program fees, as described in s. 38.24 (1m) (a) and (b)
11 and additional fees reported and assessed by the college for the course of study.

12 c. For a high school, a school that is approved under s. 45.03 (11), or a
13 proprietary school that is approved under s. 39.90, the charge for the courses for
14 which a person is enrolled.

15 d. For an institution from which a person receives a waiver of nonresident
16 tuition under s. 39.47, the amount of the reciprocal fee under s. 39.47 (2) and any fees
17 that are similar to segregated fees for the University of Wisconsin System.

18 (b) *Income limit.* 1. No veteran may receive reimbursement under this section
19 if the department determines that the income of the veteran and his or her spouse
20 exceeds \$50,000 plus \$1,000 for each additional dependent in excess of 2 dependents.

21 2. In determining eligibility under this section, the department shall verify all
22 reported income amounts.

23 (c) *Reimbursement limit.* The amount of the reimbursement under sub. (2) or
24 (3) may not exceed the total cost of the veteran’s tuition or the standard cost for a state
25 resident for tuition for an equivalent undergraduate course at the University of

1 Wisconsin–Madison per course, whichever is less, minus any grants or scholarships
2 that the veteran receives specifically for the payment of tuition.

3 (d) *Child support or maintenance delinquency.* The department may provide
4 reimbursement under sub. (2) or (3) to a veteran who is delinquent in child support
5 or maintenance payments or who owes past support, medical expenses, or birth
6 expenses, as established by appearance of the veteran’s name on the statewide
7 support lien docket under s. 49.854 (2) (b), only if the veteran provides the
8 department with one of the following:

9 1. A repayment agreement that the veteran has entered into, that has been
10 accepted by the county child support agency under s. 59.53 (5), and that has been
11 kept current for the 6–month period immediately preceding the date of the
12 application.

13 2. A statement that the veteran is not delinquent in child support or
14 maintenance payments and does not owe past support, medical expenses, or birth
15 expenses, signed by the department of workforce development or its designee within
16 7 working days before the date of the application.

17 **(2) TUITION REIMBURSEMENT PROGRAM.** (a) *Eligibility.* A veteran is eligible for
18 the tuition reimbursement program under this subsection if he or she meets all of the
19 following conditions:

20 1. The veteran applies for the tuition reimbursement program for courses
21 begun within 10 years after separation from the service.

22 2. The veteran is a resident at the time of application for the tuition
23 reimbursement program.

24 3. The veteran is enrolled for at least 12 credits during the semester for which
25 reimbursement is sought.

1 (b) *Program benefits.* 1. A veteran who meets the requirements under par. (a),
2 upon satisfactory completion of a full-time undergraduate semester in any
3 institution of higher education in this state, any school that is approved under s.
4 45.03 (11), any proprietary school that is approved under s. 39.90, or any institution
5 from which the veteran receives a waiver of nonresident tuition under s. 39.47, may
6 be reimbursed an amount not to exceed the total cost of the veteran's tuition minus
7 any grants or scholarships that the veteran receives specifically for the payment of
8 the tuition. Reimbursement is available only for tuition that is part of a curriculum
9 that is relevant to a degree in a particular course of study at the institution.

10 2. The application for reimbursement of tuition under this subsection shall
11 meet all of the following conditions:

12 a. Be completed and received by the department no later than 60 days after the
13 completion of the semester. The department may accept an application received
14 more than 60 days after the completion of the semester if the applicant shows good
15 cause for the delayed receipt.

16 b. Contain the information necessary to establish eligibility as determined by
17 the department.

18 c. Be on the application form approved by the department.

19 d. Contain the signatures of both the applicant and a representative of the
20 institution or school certifying that the applicant has satisfactorily completed the
21 semester.

22 3. Reimbursement provided under this subsection shall be paid from the
23 appropriation under s. 20.485 (2) (tf). If the amount of funds applied for exceeds the
24 amount available under s. 20.485 (2) (tf), the department may deny applications for
25 reimbursement that would otherwise qualify under this subsection. In those cases,

1 the department shall determine eligibility on the basis of the dates on which
2 applications for reimbursement were received.

3 4. Reimbursement of tuition and fees for a course may be provided at an
4 institution or school under subd. 1. other than one from which the veteran is
5 receiving his or her degree if all of the following apply:

6 a. The curriculum at the institution or school consists only of courses necessary
7 to complete a degree in a particular course of study.

8 b. The course is accepted as transfer credits at the institution or school listed
9 under subd. 1. from which the veteran is receiving his or her degree but is not
10 available at that institution or school.

11 (c) *Limitations.* 1. A veteran is not eligible for reimbursement under this
12 subsection for more than 120 credits or 8 full semesters of full-time study at any
13 institution of higher education in this state, 60 credits or 4 full semesters of full-time
14 study at any institution of higher education in this state that offers a degree upon
15 completion of 60 credits, or an equivalent amount of credits at a school that is
16 approved under s. 45.03 (11), at a proprietary school that is approved under s. 39.90,
17 or at an institution where he or she is receiving a waiver of nonresident tuition under
18 s. 39.47.

19 2. A veteran may not receive reimbursement under this subsection for any
20 semester in which he or she received reimbursement under sub. (3) or s. 21.49.

21 **(3) CORRESPONDENCE COURSES AND PART-TIME CLASSROOM STUDY.** (a) *Eligibility*
22 The following persons are eligible for benefits under this section:

23 1. A veteran.

24 2. An unremarried surviving spouse or minor or dependent child of a deceased
25 veteran.

1 (b) *Program benefits.* 1. A person, upon the completion of any correspondence
2 course or part–time classroom study from an institution of higher education located
3 in this state, from a school that is approved under s. 45.03 (11), from a proprietary
4 school that is approved under s. 39.90, or from any public or private high school, may
5 be reimbursed in part for the cost of the course by the department. The person shall
6 present to the department a certificate from the school indicating that the person has
7 completed the course and stating tuition and shall apply for reimbursement on an
8 application that is received by the department no later than 60 days after the
9 termination of the course for which the application for reimbursement is made. The
10 department shall accept and process an application received more than 60 days after
11 the termination of the course if the applicant shows good cause for the delayed
12 receipt.

13 2. A person who is a resident of this state and otherwise qualified to receive
14 benefits under this subsection may receive the benefits under this subsection upon
15 the completion of any correspondence courses or part–time classroom study from an
16 institution of higher education located outside this state if any of the following
17 applies:

18 a. The part–time classroom study is not offered within 50 miles of the person’s
19 residence by any school or institution under sub. (2) and the educational institution
20 from which the study is offered is located not more than 50 miles from the boundary
21 line of this state.

22 b. The correspondence course is not offered by an institution in this state.

23 3. Enrolled part–time classroom study or direct correspondence courses from
24 a qualified educational institution may be authorized and the person reimbursed in
25 part by the department when the courses are related to one’s occupational,

1 professional, or employment objectives, and to the extent that payment or
2 reimbursement is not available from any other sources, or, in cases where
3 reimbursement is not specifically for tuition, to the extent that the reimbursement
4 is insufficient to cover all educational costs.

5 (b) *Limitations.* 1. a. No person who has obtained a master's degree or its
6 equivalent is eligible for reimbursement under this subsection.

7 b. No person who has obtained at least a baccalaureate degree or its equivalent
8 but not a master's degree or its equivalent is eligible for reimbursement under this
9 subsection if the person has remaining U.S. department of veterans affairs education
10 benefits.

11 c. For the purpose of this subsection, any person who has received a
12 baccalaureate degree shall be deemed to be a graduate student whether he or she is
13 taking graduate or undergraduate courses.

14 2. The department may not provide reimbursement under this subsection
15 unless the department determines that a course for which an application is made is
16 related to the applicant's occupational, professional, or employment objectives.

17 3. A person may not be reimbursed under this subsection more than 4 times
18 during any consecutive 12-month period.

19 **45.21 Retraining assistance program. (1) AMOUNT AND APPLICATION.** The
20 department may pay a veteran not more than \$3,000 for retraining to enable the
21 veteran to obtain gainful employment. The department shall determine the amount
22 of the payment based on the veteran's financial need. A veteran may apply for aid
23 to the county veterans service officer of the county in which the veteran is living. The
24 department may, on behalf of a veteran who is engaged in a structured on-the-job

1 training program and who meets the requirements under sub. (2), make a payment
2 under this subsection to the veteran's employer.

3 **(2) ELIGIBILITY.** The department may provide aid under this section if all of the
4 following apply:

5 (a) The veteran is enrolled in a training course in a technical college under ch.
6 38 or in a proprietary school in the state approved by the educational approval board
7 under s. 39.90, other than a proprietary school offering a 4-year degree or 4-year
8 program, or is engaged in a structured on-the-job training program that meets
9 program requirements promulgated by the department by rule.

10 (b) The veteran meets the financial assistance criteria established under sub.
11 (3) (c).

12 (c) The veteran is unemployed, underemployed, as defined by rule, or has
13 received a notice of termination of employment.

14 (d) The veteran requesting aid has not received reimbursement under s. 45.20
15 for courses completed during the same semester for which a grant would be received
16 under this section.

17 (e) The department determines that the veteran's proposed program will
18 provide retraining that could enable the veteran to find gainful employment. In
19 making its determination, the department shall consider whether the proposed
20 program provides adequate employment skills and is in an occupation for which
21 favorable employment opportunities are anticipated.

22 **(3) RULES.** The department shall promulgate rules for the distribution of aid
23 under this program, including all of the following:

24 (a) Standard budgets for single and married veterans.

25 (b) Selection procedures.

1 (c) Uniform need determination procedures.

2 (d) Application procedures.

3 (e) Coordination with other occupational training programs.

4 (f) Other provisions the department deems necessary to assure uniform
5 administration of this program.

6 **(4) REPORT.** The department shall include in its biennial report under s. 15.04
7 (1) (d) information relating to the veterans retraining assistance program, including
8 the number of veterans obtaining gainful employment after receiving aid and a
9 description of the veterans receiving aid, including their sex, age, race, educational
10 level, service-connected disability status, and income before and after obtaining
11 gainful employment. This information may be based on a valid statistical sample.

12 SUBCHAPTER III

13 VETERANS HOUSING LOAN PROGRAM

14 **45.30 Purpose. (1) LEGISLATIVE FINDINGS.** It is determined that veterans, who
15 have sacrificed in the service of their country valuable years of their lives and
16 considerable earning potential, constitute a readily identifiable and particularly
17 deserving segment of this state's population. It is further determined that by making
18 additional housing funds available to eligible veterans, limited private home loan
19 funds will be more readily available to all. It is further determined that the loan
20 programs established under this subchapter are special purpose credit programs for
21 an economically disadvantaged class of persons for the purposes of 15 USC
22 1691–1691f.

23 **(2) LEGISLATIVE INTENT.** This subchapter is created principally to enable the
24 state and the authority to exercise their borrowing power to increase those funds
25 available for loans providing for the purchase or construction of private housing,

1 without requiring down payments beyond the reach of families of modest means. It
2 is the intent of the legislature that the department in its administration of this
3 subchapter avoid the duplication of those administrative services available through
4 private lending institutions, utilizing the administrative services of such
5 institutions to the maximum extent consistent with the purposes of this subchapter.

6 **45.31 Definitions.** In this subchapter:

7 **(1)** “Anticipated annual shelter payment” means the total annual payments
8 anticipated for the following, as determined by the department or authorized lender
9 on the basis of the loan applied for under s. 45.37:

10 (a) Real estate taxes on the premises to be mortgaged.

11 (b) Insurance premiums for coverage required under s. 45.37 (3) (b).

12 (c) Required payments on principal and interest on all mortgages placed or to
13 be placed against the home of an eligible person.

14 **(2)** “Authority” means the Wisconsin Housing and Economic Development
15 Authority.

16 **(3)** “Authorized lender” means any lender or servicer authorized under s. 45.37

17 (5) (a) 5. to make or service loans under s. 45.37.

18 **(4)** “Closing costs” include:

19 (a) Any origination fee authorized under s. 45.37 (5) (b).

20 (b) Attorney fees.

21 (c) Recording fees.

22 (d) Other costs authorized by the department.

23 **(5)** “Eligible person” means any person eligible under s. 45.33 (1) and not
24 disqualified under s. 45.33 (2) to receive a loan under this subchapter.

1 **(6)** “Federal Home Loan Mortgage Corporation” means the corporation created
2 under 12 USC 1451 to 1459.

3 **(7)** “Funds” include cash on hand and liquid investments owned by the veteran
4 and his or her spouse, individually or jointly, unless the veteran and spouse are
5 legally separated under s. 767.07.

6 **(8)** “Guaranteed loan” means a loan guaranteed by the U.S. department of
7 veterans affairs under 38 USC 1801 to 1827.

8 **(9)** “Home” means a building or portion of a building used as the veteran’s
9 principal place of residence, and includes condominiums and income-producing
10 property, a portion of which is used as a principal place of residence by the veteran,
11 and the land, including existing improvements, appertaining to the building.

12 **(10)** “Income” means the sum of the federal adjusted gross income plus any
13 income received that may reasonably be expected to be regular and dependable.

14 **(11)** “Insurer” means any insurer authorized to do business in this state.

15 **(12)** “Manufactured home” means a structure, as defined by the Federal Home
16 Loan Mortgage Corporation, which meets or exceeds the statutory size under s.
17 348.07 (2).

18 **(13)** “Monthly payment” means all of the following:

19 (a) Required payments on principal and interest.

20 (b) Insurance premiums for coverage required under s. 45.37 (3) (b).

21 (c) One-twelfth of annual real estate taxes on the mortgaged property.

22 **(14)** “Qualified purpose” means any purpose authorized under s. 45.34 (1).

23 **45.32 Powers of the department.** With respect to loans made by and
24 mortgages and mortgage notes executed or properties mortgaged to the department

1 or to authorized lenders under this subchapter, the department may do any of the
2 following:

3 (1) Execute necessary instruments.

4 (2) Collect interest and principal.

5 (3) Compromise indebtedness due on mortgage notes.

6 (4) Sue and be sued.

7 (5) Exercise the rights of a mortgagee, generally including the right to do any
8 of the following:

9 (a) Acquire or take possession of the mortgaged property and in so doing the
10 department may accept voluntary surrender and conveyance of title to the property
11 in full satisfaction of a mortgage debt or may bid for and purchase the property at
12 a sheriff's sale or replevin the property.

13 (b) Commit itself to execute and execute subordination agreements, partial
14 releases, and other necessary instruments.

15 (c) Set up and follow procedures to assure proper disbursement of the proceeds
16 of insurance checks, share drafts, or other drafts covering damages sustained on
17 mortgaged properties.

18 (d) Pay the principal and interest on any obligations incurred in connection
19 with the mortgages on the property including real estate taxes, insurance premiums,
20 attorney fees, and obligations created as a result of its exercise of powers vested in
21 it under this subchapter.

22 (e) Exercise any other powers as may be necessary for the efficient
23 administration of this subchapter.

24 (6) In contracts entered into under s. 45.37 (5) (a) 1., empower authorized
25 lenders to exercise any of the powers vested in the department under this subchapter.

1 **(7)** Manage, operate, lease, exchange, sell, and otherwise convey real property.

2 **(8)** Grant easements in any real property the department acquires.

3 **(9)** Upon application by the mortgagor and agreement in writing executed by
4 the parties:

5 (a) Extend the time in which the obligation under a mortgage note or any part
6 of the obligation must be paid.

7 (b) Reduce the amounts of monthly installments and provide other terms and
8 conditions relative to time and manner of repaying the obligation as it deems
9 necessary or reasonable.

10 **45.33 Eligibility and disqualifying factors. (1) ELIGIBLE PERSONS.** Subject
11 to sub. (2) (a) or (b), the following persons may receive a loan under this subchapter:

12 (a) A veteran.

13 (b) A person who served on active duty for more than 6 months during the
14 period between February 1, 1955, and August 4, 1964, and was honorably
15 discharged.

16 (c) The unremarried surviving spouse or dependent child, as defined in s. 45.01
17 (6) (a) 2., of a deceased veteran or of a deceased person described in par. (b).

18 **(2) DISQUALIFYING FACTORS.** (a) A person listed in sub. (1) may not receive a loan
19 under this subchapter if the department or authorized lender determines that any
20 of the following applies:

21 1. The person will be incurring an excessive indebtedness in view of the person's
22 income.

23 2. The person has a previous loan outstanding under this subchapter, unless
24 any of the following apply:

1 a. The previous loan has been assumed by an eligible person with the
2 department's approval upon the sale of the residence securing the previous loan.

3 b. The person is applying for a loan under s. 45.37 for a purpose under s. 45.34
4 (1) (c) and the previous loan was made under s. 45.37.

5 (b) A person listed in sub. (1) who is not a permanently and totally disabled
6 veteran may not receive a loan under this subchapter if the department or authorized
7 lender determines that any of the following applies:

8 1. The person is delinquent in child support or maintenance payments or owes
9 past support, medical expenses, or birth expenses, as evidenced by the appearance
10 of the person's name on the statewide support lien docket under s. 49.854 (2) (b),
11 unless the person provides the department or authorized lender with one of the
12 following:

13 a. A repayment agreement that the person has entered into, that has been
14 accepted by the county child support agency under s. 59.53 (5) and that has been kept
15 current for the 6-month period immediately preceding the date of the application.

16 b. A statement that the person is not delinquent in child support or
17 maintenance payments and does not owe past support, medical expenses, or birth
18 expenses, signed by the department of workforce development or its designee within
19 7 working days before the date of the application.

20 2. The amount of the loan exceeds 2.5 times the median price of a home in this
21 state. The department shall establish the median price of a home in this state for
22 each fiscal year by using the most recent housing price index generated by the
23 Wisconsin Realtors Association before July 1.

1 **45.34 Uses for loan proceeds. (1)** MORTGAGE LOAN PROGRAM. An authorized
2 lender may, with the approval of the department, make loans under s. 45.37 for any
3 of the following purposes:

4 (a) The purchase of one of the following:

5 1. A manufactured home or real property on which a manufactured home is to
6 be situated, but only if the eligible person has available and applies on the total cost
7 of the property, an amount equivalent to at least 15 percent of the total cost. This
8 15 percent requirement does not apply to a disabled veteran.

9 2. A home and eligible rehabilitation of a home, as defined in s. 234.49 (1) (d).

10 (b) The construction of a home, including housing accommodation and garage,
11 and the acquisition of land therefor.

12 (c) A loan of not more than \$25,000 to improve a home, including the
13 construction of a garage or the removal or other alteration of existing improvements
14 that were made to improve the accessibility of a home for a permanently and totally
15 disabled individual.

16 (d) 1. Refinancing the balance due on an indebtedness that was incurred for a
17 use designated in pars. (a) to (c) if the balance owing on the indebtedness does not
18 exceed the amount requested in a prior loan application from that eligible person and
19 if the indebtedness was incurred by that person after a prior loan application from
20 that person was denied by the department. Refinancing loans may be made under
21 this paragraph only if the board reverses the department's denial after determining
22 that the prior application met requirements in effect on the date of the denial and
23 that the loan application should have been approved.

1 2. Refinancing the balance due on a construction period loan, bridge loan, or
2 other financing if the financing was used for a purpose designated in par. (b) and has
3 a term of 24 months or less.

4 **(2) CONDITIONS.** (a) No loan may be made under this subchapter if the
5 department or authorized lender determines that the total cost of the property
6 exceeds its market value unless the amount by which the cost of the property exceeds
7 its market value is paid by the borrower in addition to the contribution required by
8 s. 45.35. This paragraph does not apply to a permanently and totally disabled
9 veteran.

10 (b) The department or authorized lender may require any person applying for
11 a loan under this subchapter to certify that:

12 1. The residence to be purchased, constructed, improved, or refinanced with
13 financial assistance under this subchapter will be used as the person's principal
14 residence.

15 2. Unless other acceleration provisions are permitted under s. 45.36 (2), the
16 loan made under this subchapter will be repaid in full upon sale of the residence or
17 any of the person's interest in it. A divorce judgment divesting the person's interest
18 in the residence or a quit claim deed executed under the judgment does not constitute
19 a sale.

20 **45.35 Contribution.** No loan may be made under this subchapter unless, in
21 addition to the closing costs that the person may be required to pay, the person has
22 available, and applies on the total cost of the property for which the loan is made, an
23 amount equivalent to at least 5% of the total cost. The amount may consist of money
24 or other assets, including equity in real property. This section does not apply to a
25 permanently and totally disabled veteran.

1 **45.36 Manner of repayment. (1) MONTHLY PAYMENTS; RIGHT TO PREPAY.** Each
2 loan made under this subchapter shall be repaid in monthly installments with the
3 option to pay additional sums. Any additional payments must be paid on the regular
4 installment payment date.

5 **(2) ACCELERATION PROVISIONS.** All loans made under this subchapter shall be
6 repaid in full upon sale of the residence securing the loan or any interest in such
7 residence, unless one of the following applies:

8 (a) The sale is to another eligible person.

9 (b) The department or authorized lender servicing the loan determines that
10 acceleration will jeopardize collection of the loan balance.

11 (c) The loan is a guaranteed loan which is assumed or paid in regular monthly
12 installments under s. 45.37 (11) (a).

13 **45.37 Mortgage loan program. (1) LOANS AUTHORIZED.** An authorized lender
14 or a county veterans service officer may, as agent for and with the approval of the
15 department, make loans to eligible persons for qualified purposes in the manner
16 provided under this section.

17 **(2) LOAN APPLICATIONS.** (a) Applications for loans under this section for a
18 purpose specified in s. 45.34 (1) (a), (b), or (d) shall be made to an authorized lender
19 and applications for loans under this section for a purpose specified under s. 45.34
20 (1) (c) may be made to the department or to a county veterans service officer on forms
21 approved by the department and signed by the applicant. If the applicant is married
22 and not legally separated under s. 767.02 (1) (d) or in the process of obtaining a
23 divorce, the applicant's spouse also shall sign the application.

24 (b) The applicant may apply directly to the department or through a county
25 veterans service officer for certification of eligibility.

1 **(3) LOANS TO BE SECURED.** (a) Each loan made under this section, except a loan
2 of \$3,000 or less for a purpose specified under s. 45.34 (1) (c), shall be evidenced by
3 a promissory installment note and secured by a mortgage on the real estate in respect
4 to which the loan is granted. A loan of \$3,000 or less made for a purpose specified
5 under s. 45.34 (1) (c) shall be evidenced by a promissory installment note and shall
6 be secured by a guarantor or by a mortgage on the real estate in respect to which the
7 loan is granted. Any loan having as its source funds provided under sub. (6) (a) and
8 secured by a mortgage shall have the mortgage name the department as mortgagee
9 and payee. Any loan having as its source funds provided under sub. (6) (b) and
10 secured by a mortgage shall have the mortgage name the authorized lender involved
11 as mortgagee and payee, and such mortgage and note shall be assigned by the
12 authorized lender to the authority immediately upon execution. A mortgage
13 securing a loan made for a purpose specified in s. 45.34 (1) (a), (b), or (d) shall have
14 priority over all liens against the mortgaged premises and the buildings and
15 improvements to the buildings, except tax and special assessment liens filed after
16 the recording of the mortgage. A mortgage securing a loan made for a purpose
17 specified under s. 45.34 (1) (c) is acceptable if the applicant can establish a minimum
18 equity in the property, as established by the department by rule.

19 (b) Mortgages given to secure loans under this section shall provide for
20 adequate fire and extended coverage insurance. Policies providing such insurance
21 coverage shall name the authorized lender or the department as an insured.

22 **(4) INTEREST RATE DETERMINED.** (a) The board shall determine the interest rate
23 on loans made under this section. Except as provided in sub. (11), the interest rate
24 determined may not be increased during the term of the loan. Except as provided
25 in sub. (11), the interest rate shall be as low as possible but shall be sufficient to fully

1 pay all expenses and to provide reserves that are reasonably expected to be required
2 in the judgment of the board in accordance with par. (b) and sub. (7) (a) 3.

3 (b) 1. The board shall select and implement the methods of insuring against
4 losses arising from delinquency and default in the repayment of loans funded under
5 sub. (6) (a) and shall select and implement the methods of managing and selling any
6 property securing loans funded under sub. (6) (a).

7 2. The board shall charge or cause to be charged to borrowers all costs necessary
8 to insure against losses under subd. 1.

9 3. Moneys collected under subd. 2. and that are held by the state shall be
10 deposited, reserved, and expended as provided in sub. (7) (a) 3.

11 (c) Loans made pursuant to this section shall not be subject to s. 138.05,
12 138.051, or 138.052, except that a loan originated under this section after May 3,
13 1996, is subject to s. 138.052 (5).

14 **(5) ADMINISTRATIVE PROVISIONS.** (a) The department may do any of the
15 following:

16 1. Enter into contracts with authorized lenders throughout this state
17 authorizing such lenders to process applications and close and service loans made
18 under this section. The contracts shall include the responsibilities of the authorized
19 lender with respect to credit evaluations, financial eligibility determinations,
20 valuation of the home for which the loan is to be made, collection procedures in the
21 event of delinquent loan repayments, and other functions that the department may
22 require. The contracts shall authorize the lender to retain an amount from the
23 monthly payments for servicing loans made under this section. The rate of the
24 service fee shall not exceed a maximum rate established by the department with the
25 lender in accordance with current practices under similar programs, and shall be

1 stated in the contracts. The department shall specify in the contracts a maximum
2 length of time between receipt of monthly mortgage payments by the lender and
3 transmittal of such payments to the state or the authority.

4 2. Commit to advance and advance funds in the full amount of any mortgage
5 securing a purchase loan to be made by an authorized lender in accordance with the
6 terms under this section.

7 3. Commit to advance and advance in installments up to the full amount of any
8 mortgage securing a construction loan made by an authorized lender, to provide for
9 the purchase and improvement of a lot and the completion of the construction for
10 which the loan is to be made, under the terms of this section.

11 4. Mail checks, share drafts, or other drafts, or otherwise transfer or arrange
12 for transfer of funds to authorized lenders not sooner than 7 days prior to proposed
13 closing or disbursement dates.

14 5. Designate and maintain a current list of lenders authorized to make or
15 service loans under this section. The department shall promulgate rules
16 establishing standards for and governing the performance of authorized lenders in
17 making and servicing loans under this section and shall periodically monitor such
18 performance. The department shall promulgate rules to provide for the removal
19 from its list of authorized lenders of any lender that makes an excessive number of
20 errors on loan applications processed under subd. 1. The department may
21 summarily remove from its list of authorized lenders any lender that indicates it does
22 not wish to participate in the program and after hearing on notice remove from its
23 list of authorized lenders any lender that fails to conform with the rules of the
24 department governing that performance, and may refuse to permit a lender so

1 removed to make or service any loan under this section until the department is
2 satisfied that the lender will conform with its rules.

3 6. Require borrowers to make monthly escrow payments to be held by the
4 authorized lender or the department for real estate taxes and casualty insurance
5 premiums. The authorized lender or the department shall pay all of the amounts due
6 for real estate taxes and casualty insurance premiums, even if the amount held in
7 escrow is insufficient to cover the amounts due. If the amount held in escrow is
8 insufficient to cover the amounts due, the authorized lender or the department shall
9 recover from the borrower, after paying the amounts due under this subdivision, an
10 amount equal to the difference between the amounts paid and the amount held in
11 escrow. If the amount held in escrow is more than the amounts due, the authorized
12 lender or the department shall refund to the borrower, after paying the amounts due
13 under this subdivision, an amount equal to the difference between the amount held
14 in escrow and the amounts paid by the authorized lender or the department.

15 7. Obtain guarantees for loans under 38 USC 1801 to 1827.

16 8. Exercise all of the powers vested in it under this subchapter with respect to
17 any applications for loans and loans approved under this section and with respect to
18 any mortgages and mortgage notes executed to authorized lenders and assigned to
19 and purchased by the authority under this section and the properties securing those
20 mortgages. The department may exercise or authorize those powers to be exercised
21 in its own name.

22 9. With prior approval of the building commission, retire all 1981 veterans
23 home loan revenue bonds and transfer any assets remaining in the bond fund after
24 retirement into the veterans trust fund. The department may sell the assets

1 transferred to the veterans trust fund under this subdivision and deposit the
2 proceeds of any sale into the veterans trust fund.

3 10. Service loans made under this section and purchase from authorized
4 lenders the servicing rights for loans made by authorized lenders under this section.

5 11. Enter into contracts with persons other than authorized lenders for the
6 servicing of loans made under this section.

7 12. Loan money from the veterans trust fund to the veterans mortgage loan
8 repayment fund to fund loans under this section.

9 (b) At the time of closing, persons receiving loans under this section shall pay
10 an origination fee to the authorized lender participating in the loan, except that the
11 department shall pay, on behalf of a veteran who receives a loan under this section
12 and who has at least a 30 percent service-connected disability rating for purposes
13 of 38 USC 1114 or 1134, the origination fee to the authorized lender. The origination
14 fee charged under this paragraph shall be negotiated between the department and
15 the authorized lender but may not exceed that which the authorized lender would
16 charge other borrowers in the ordinary course of business under the same or similar
17 circumstances.

18 **(6) SOURCES OF LOAN FUNDS.** Funding for loans authorized under this section
19 may, at the discretion of the building commission, be provided by one or a
20 combination of the following:

21 (a) The secretary, with the approval of the governor and subject to the limits
22 of s. 20.866 (2) (zn), may request that state debt be contracted in accordance with ch.
23 18. Debt requested shall meet all of the following additional requirements:

24 1. State debt may be contracted when it reasonably appears to the building
25 commission that all state obligations so incurred under this paragraph and s. 20.866

1 (2) (zo) can be fully paid from moneys received from veterans repayments of loans on
2 mortgages and mortgage notes funded under this paragraph and other available
3 revenues of the veterans mortgage loan repayment fund. In making this
4 determination, the building commission may take into account the effect of its
5 planned future actions to refinance existing state debt, to create reserve funds, and
6 to modify the structure of the total debt outstanding so as to ensure that projected
7 repayments of loans on mortgages and mortgage notes, together with other available
8 moneys, will be sufficient as received to fund debt service payments as due. It is the
9 intent of the legislature that the program authorized under this section be fully
10 self-supporting and that it be administered so that all debt service and all related
11 costs of the program under this section will require no supplemental support from
12 the general fund.

13 2. The chairperson of the board shall certify that the chairperson does not
14 expect proceeds of state debt issued under this paragraph to be used in a manner that
15 would cause the debt to be arbitrage bonds as defined in the Internal Revenue Code,
16 if that debt is a bond that is exempt from federal taxation.

17 (b) Loans made under this section may be purchased by the authority from the
18 veterans housing loan fund under s. 234.41. All receipts of interest, except amounts
19 retained as servicing fees by the authorized lenders servicing the loans purchased
20 by the authority, and principal on the loans, payments of losses by insurers not used
21 for restoration of the property securing the loans, and any other collections, shall be
22 deposited by the authority into the veterans housing bond redemption fund under
23 s. 234.43 and shall be disbursed from the fund as provided in s. 234.43 (2).

24 (c) The secretary, with the approval of the governor and subject to the limits
25 of sub. (10), may request that revenue obligations be contracted in accordance with

1 subch. II of ch. 18. Revenue obligations requested shall meet all of the following
2 additional requirements:

3 1. Revenue obligations may be contracted when it reasonably appears to the
4 building commission that all obligations incurred under this paragraph can be fully
5 paid from moneys received from veterans repayments of loans on mortgages and
6 mortgage notes funded under this paragraph.

7 2. The chairperson of the board shall certify that the board and the department
8 do not expect and shall not use proceeds of revenue obligations issued under this
9 paragraph in a manner that would cause the revenue obligations to be arbitrage
10 bonds as defined in the Internal Revenue Code, where that debt is a bond that is
11 exempt from federal taxation.

12 **(7) REPAYMENT OF MORTGAGE LOANS.** (a) There is created the veterans mortgage
13 loan repayment fund. All moneys received by the department for the repayment of
14 loans funded under sub. (6) (a) except for servicing fees required to be paid to
15 authorized lenders, net proceeds from the sale of mortgaged properties, any
16 repayment to the department of moneys paid to authorized lenders, gifts, grants,
17 other appropriations, and interest earnings accruing, any repayment of moneys
18 borrowed under s. 45.42 (8) (a), all moneys received under sub. (5) (a) 6., and any
19 moneys deposited or transferred under s. 18.04 (6) (b) or (d) shall be promptly
20 deposited into the veterans mortgage loan repayment fund. The board shall
21 establish by resolution a system of accounts providing for the maintenance and
22 disbursement of moneys of the veterans mortgage loan repayment fund to fund loans
23 under sub. (6) (a) or to fund, refund, or acquire public debt as provided in s. 18.04 (5).
24 The system of accounts shall record and provide moneys for all of the following
25 purposes:

- 1 1. Transfer to the bond security and redemption fund.
- 2 2. Acquisition or redemption of public debt in accordance with resolutions of
3 the building commission.
- 4 3. Payment of losses arising from delinquency or default in the repayment of
5 loans funded under sub. (6) (a), including loss of principal and interest accrued to the
6 point of final disposition of the defaulted loan and the expenses of management and
7 sale of the property taken upon default of loan repayment.
- 8 4. Payment of all costs incurred by the department in processing and servicing
9 loans, purchasing servicing rights for loans under this section, and accounting for
10 and administering the program under this section, including a portion of grants
11 made to county veterans service officers under s. 45.80 (8).
- 12 5. Payment of all costs incurred in contracting public debt for the purposes
13 under s. 18.04 (5) and under s. 18.04 (2) for the purpose of funding veterans housing
14 loans.
- 15 6. Payment of costs of issuance of obligations to fund loans under sub. (6) (c)
16 if not paid from the proceeds of the obligations.
- 17 7. Payment of obligations arising from loans funded under sub. (6) (b).
- 18 8. Payment of any other costs of program operation and management
19 authorized under this section.
- 20 9. Loan money to the veterans trust fund, upon prior approval of the building
21 commission for each loan, for the purposes under s. 45.42.
- 22 10. Payment of origination fees, on behalf of veterans who have at least a 30
23 percent service-connected disability rating for purposes of 38 USC 1114 or 1134, to
24 authorized lenders under sub. (5) (b).
- 25 11. Payment required of the department under sub. (5) (a) 6.

1 12. Payment of obligations arising from the acquisition of a headquarters and
2 museum building for the department under s. 45.03 (5) (b).

3 (b) The board may amend the system of accounts established under par. (a) only
4 by resolution of the board that is approved by the building commission.

5 (c) If revenues of the veterans mortgage loan repayment fund are insufficient
6 to meet all current expenses, the secretary of administration shall establish a
7 repayment schedule whereby the general fund will be reimbursed in an orderly
8 manner for moneys advanced. Interest rates to be charged on loans subsequently
9 issued shall be adjusted to provide sufficient revenues to meet all of this repayment
10 schedule.

11 (d) After meeting all expenses and providing for reserves under par. (a) 3.,
12 assets in the veterans mortgage loan repayment fund, upon prior approval of the
13 building commission, may be transferred to the veterans trust fund and used to fund
14 loans under s. 45.42.

15 **(8) USE OF SURPLUSES.** Surpluses may be used under sub. (11) (c) only if there
16 are no unrestricted fund balances available for that purpose in the funds created
17 under sub. (10). Section 20.001 (3) (e) shall not be construed to prohibit this action.

18 **(9) LIMITATION ON REMODELING OR ALTERATION FOR A DISABLED VETERAN.** Not more
19 than 50 percent of the proceeds of a loan granted under this section for a purpose
20 under s. 45.34 (1) (a) may be used for remodeling or alteration of the housing
21 accommodation after purchase to meet the special needs of a permanently and totally
22 disabled veteran. That portion of the proceeds used for this purpose shall be reserved
23 and distributed by the authorized lender.

24 **(10) REPAYMENT OF REVENUE OBLIGATIONS.** (a) All moneys received from any
25 source for repayment of loans, mortgages, or mortgage loan notes funded with

1 proceeds of revenue obligations issued under sub. (6) (c) shall be deposited into one
2 or more separate nonlapsible trust funds in the state treasury or with a trustee
3 appointed for that purpose by the authorizing resolution for the revenue obligations.
4 The board may pledge revenues received by the funds to secure revenue obligations
5 issued under sub. (6) (c) and shall have all other powers necessary and convenient
6 to distribute the proceeds of the revenue obligations and loan repayments in
7 accordance with subch. II of ch. 18. Unrestricted balances in the funds may be used
8 to fund additional loans issued under sub. (6) (c) and pay the balances owing on loans
9 after the assumptions of the loans or the closings of the sales of residences under sub.
10 (11) (c).

11 (b) Revenue obligations issued under sub. (6) (c) may not exceed \$280,000,000
12 in principal amount, excluding obligations issued to fund or refund outstanding
13 revenue obligation notes or to refund outstanding revenue obligation bonds.

14 (c) Except as may otherwise be expressly provided in resolutions authorizing
15 the issuance of revenue obligations or in other agreements with the holders of
16 revenue obligations, each issue of revenue obligations shall be on a parity with every
17 other revenue obligation issued under sub. (6) (c) and payable in accordance with
18 subch. II of ch. 18.

19 **(11) GUARANTEED LOANS.** (a) Upon any sale of the residence which secures a
20 guaranteed loan made under this section after April 3, 1980, except for the purchase
21 of the residence at the time the loan is initially made, the guaranteed loan may be
22 assumed or continue to be paid in regular monthly installments if the person who
23 assumes the mortgage loan payments or who will make the regular monthly
24 installments agrees to all of the following:

1 1. To pay interest on the loan from the date of the assumption of the loan, if the
2 loan is assumed, or from the date of the closing of the sale of the residence at the
3 maximum rates of interest being charged on guaranteed loans on the date the loan
4 was initially made.

5 2. To increase the amortization payments on the loan by an amount sufficient
6 to amortize the loan by the date the balance on the loan is payable in full according
7 to the original terms of the loan.

8 (b) The department and authorized lenders shall increase the interest rates
9 and amortization payments on loans assumed under par. (a).

10 (c) After the assumption of a guaranteed loan funded under sub. (6) (c), if the
11 loan is assumed, or the closing of the sale of a residence on which a balance is owing
12 on a guaranteed loan funded under sub. (6) (c), the balance owing on the loan on the
13 date of the assumption of the loan, if the loan is assumed, or the closing of the sale
14 may be paid to the funds created under sub. (10) from available surpluses, if any, in
15 the veterans mortgage loan repayment fund under sub. (7) (d). The loan and the
16 mortgage and mortgage note pertaining to the loan may be purchased by the
17 veterans mortgage loan repayment fund under sub. (7).

18 **(12) PRIOR PROGRAM LOANS.** Subject to this section and ss. 45.33 to 45.35, neither
19 the department nor an authorized lender may deny a person a loan under this section
20 because of the reason the person sold any property previously mortgaged by the
21 person to the department or an authorized lender, if the person completely paid the
22 balance of any previous loan under this subchapter in accordance with the terms and
23 conditions of the promissory note and the mortgage or other agreement executed in
24 connection with the previous loan.

1 committee on finance may, from the appropriation under s. 20.865 (4) (u),
2 supplement the appropriation under s. 20.485 (2) (vm) in an amount equal to the
3 amount that the department expects to expend under this subsection.
4 Notwithstanding s. 13.101 (3) (a), the committee is not required to find that an
5 emergency exists. If the cochairpersons of the committee do not notify the secretary
6 within 14 working days after the date of the department's submittal that the
7 committee intends to schedule a meeting to review the request, the appropriation
8 account shall be supplemented as provided in the request. If, within 14 working days
9 after the date of the department's submittal, the cochairpersons of the committee
10 notify the secretary that the committee intends to schedule a meeting to review the
11 request, the appropriation account shall be supplemented only as approved by the
12 committee.

13 **(2) HEALTH CARE AID.** The department may provide to a veteran or the
14 dependent of a veteran temporary health care aid if the department considers it
15 advisable to prevent undue hardship. Health care aid to pay medical or hospital bills
16 under this subsection is limited to a payment of up to \$5,000 per veteran or
17 dependent for a 12-month period beginning on the first day of care for which the
18 person seeks reimbursement under this subsection. The department may issue a
19 certificate of entitlement stating that a veteran or dependent is eligible for health
20 care aid under this subsection if the treatment is received within a time period that
21 the department promulgates by rule. The department may not provide health care
22 aid to pay for care provided to the veteran or dependent before the time period
23 identified in the certificate of entitlement, except for emergency care, as determined
24 by the department, if the application for the health care aid is submitted within 90
25 days after the emergency care ends. Health care aid may be used to provide payment

1 for the treatment of alcoholism or other drug addiction or to provide payment for
2 health care required because of alcoholism or other drug addiction or alcohol or other
3 drug abuse. The department may not provide health care aid under this subsection
4 unless the person's health care provider agrees to accept, as full payment for the
5 medical treatment for which the aid is to be granted, the amount of the aid, the
6 amount of the person's health insurance or other 3rd-party payments, if any, and the
7 amount that the department determines the person is capable of paying. The
8 department may not provide health care aid under this subsection if the combined
9 liquid assets of the veteran and veteran's dependents who are living in the same
10 household are in excess of \$1,000.

11 **(3) APPROPRIATIONS.** The department may provide aid under this section from
12 the appropriation in s. 20.485 (2) (vm). Nothing in this section empowers the
13 department to incur any state debt.

14 **45.41 Payments to veterans organizations. (1)** In this section:

15 (a) "Regional office" means the U.S. department of veterans affairs regional
16 office in Wisconsin.

17 (b) "State veterans organization" means the state organization or department
18 of a national veterans organization incorporated by an act of congress.

19 **(2)** Upon application the department shall make a payment to any state
20 veterans organization that establishes that it, or its national organization, or both,
21 has maintained a full-time service office at the regional office for 5 consecutive years
22 out of the 10-year period immediately preceding the application. The payment shall
23 be calculated based on the total amount of all salaries and travel expenses under sub.

1 (3) paid during the previous fiscal year by the state veterans organization to
2 employees engaged in veterans claims service and stationed at the regional office.

3 The payment shall be as follows:

4 (a) If the total amount paid under sub. (3) is from \$1 to \$2,499, the organization
5 shall receive the amount paid.

6 (b) If the total amount paid under sub. (3) is from \$2,500 to \$9,999, the
7 organization shall receive \$2,500.

8 (c) If the total amount paid under sub. (3) is from \$10,000 to \$119,999, the
9 organization shall receive 25 percent of the amount paid.

10 (d) If the total amount paid under sub. (3) is \$120,000 or more, the organization
11 shall receive \$30,000.

12 **(3)** A state veterans organization shall file an application annually with the
13 department for the previous 12-month period ending on March 31 of the year in
14 which it is filed. The application shall contain a statement of salaries and travel
15 expenses paid to employees of the organization engaged in veterans claims service
16 activities at the regional office by the state veterans organization covering the period
17 for which application for a payment is made. The statement shall be certified as
18 correct by a certified public accountant licensed or certified under ch. 442 and sworn
19 to as correct by the adjutant or principal officer of the state veterans organization.
20 The application shall include the state organization's financial statement for its
21 previous fiscal year and evidence of claims service activity that the department
22 requires. The state veterans organization shall submit with its initial application
23 sufficient evidence to establish that it or its national organization, or both, has
24 maintained a full-time service office at the regional office for 5 consecutive years out
25 of the 10-year period immediately preceding the application. Subsequent

1 applications shall be accompanied by an affidavit by the adjutant or principal officer
2 of the state veterans organization stating that the organization, on its own or with
3 its national organization, maintained a full-time service office at the regional office
4 for the entire 12-month period for which application for a payment is made.

****NOTE: Under current law, state veterans organizations may apply to DVA to receive payments for services they provide to veterans at the regional U.S. DVA office. To receive reimbursement, the organizations must have maintained a full-time service office at the regional office for 5 of the 10 years preceding application. The bill clarifies here and in s. 45.41 (3) that the service must have been provided for 5 consecutive years within that 10-year period.

5 **(4)** From the appropriation under s. 20.485 (2) (s), the department shall
6 annually provide a payment of \$100,000 to the Wisconsin department of the Disabled
7 American Veterans for the provision of transportation services to veterans.

8 **45.42 Veterans personal loans. (1)** It is determined that the loan program
9 established under this section is a special purpose credit program for an economically
10 disadvantaged class of persons for purposes of 15 USC 1691-1691f.

11 **(2)** The department may lend a veteran, a veteran's unremarried surviving
12 spouse, or a deceased veteran's child not more than \$25,000, or a lesser amount
13 established by the department under sub. (9). The department may prescribe loan
14 conditions, but the term of the loan may not exceed 10 years. The department shall
15 ensure that the proceeds of any loan made under this section shall first be applied
16 to pay any delinquent child support or maintenance payments owed by the person
17 receiving the loan and then to pay any past support, medical expenses, or birth
18 expenses owed by the person receiving the loan.

19 **(3)** The department may lend to the remarried surviving spouse of a deceased
20 veteran or to the parent of a deceased veteran's child not more than \$25,000, or a
21 lesser amount established by the department under sub. (9), for the education of the
22 deceased veteran's child.

1 **(4)** The department may execute necessary instruments, collect interest and
2 principal, compromise indebtedness, sue and be sued, post bonds, and write off
3 indebtedness that it considers uncollectible. If a loan under this section is secured
4 by a real estate mortgage, the department may exercise the rights of owners and
5 mortgagees generally and the rights and powers set forth in s. 45.32. The
6 department shall pay all interest and principal repaid on the loan into the veterans
7 trust fund.

8 **(5)** The department may charge loan expenses incurred under this section to
9 the loan applicant. The department shall pay all expenses received under this
10 subsection into the veterans trust fund.

11 **(6)** The department may provide a loan under this section to an applicant
12 whose name appears on the statewide support lien docket under s. 49.854 (2) (b) only
13 if the applicant does one of the following:

14 (a) Provides to the department a repayment agreement that the applicant has
15 entered into, that has been accepted by the county child support agency under s.
16 59.53 (5), and that has been kept current for the 6-month period immediately
17 preceding the date of the application.

18 (b) Provides to the department a statement that the applicant is not delinquent
19 in child support or maintenance payments and does not owe past support, medical
20 expenses, or birth expenses, signed by the department of workforce development or
21 its designee within 7 working days before the date of the application.

22 (c) Agrees to use the loan proceeds to pay any delinquent child support or
23 maintenance payments and to pay any past support, medical expenses, or birth
24 expenses if the applicant fails to meet the requirements under par. (a) or (b).

1 **(7)** No person may receive a loan under this section in an amount that, when
2 added to the balance outstanding on the person's existing loans under s. 45.351 (2),
3 1995 stats., and s. 45.356, 1995 stats., would result in a total indebtedness to the
4 department of more than \$25,000.

5 **(8)** (a) The department may borrow from the veterans mortgage loan
6 repayment fund under s. 45.37 (7) (a) to obtain money to make loans under this
7 section.

8 (b) The department may enter into transactions with the state investment
9 board to obtain money to make loans under this section. Transactions authorized
10 under this paragraph may include the sale of loans.

11 **(9)** Subject to the limits established in subs. (2) and (3), the department may
12 periodically adjust the maximum loan amount based upon financial market
13 conditions, funds available, needs of the veterans trust funds, or other factors that
14 the department considers relevant.

15 **(10)** The department may periodically adjust the interest rates for loans made
16 under this section, which may vary based upon the term of the loan, the type of
17 security offered, the method of payment, or other factors that the department
18 considers relevant.

19 **(11)** If an applicant's total indebtedness for loans made under this section is
20 more than \$5,000, the loan shall be evidenced by a promissory note and secured by
21 a mortgage on real estate located in this state. A loan of \$5,000 or less made to an
22 applicant whose total indebtedness for loans made under this section is \$5,000 or less
23 shall be evidenced by a promissory note and secured by a guarantor or by a mortgage
24 on real estate located in this state. A mortgage securing a loan made under this
25 section is acceptable if the applicant has equity in the property subject to the

1 mortgage equal to or exceeding a minimum amount that the department establishes
2 by rule.

3 **45.43 Veterans assistance program. (1)** The department shall administer
4 a program to provide assistance to persons who served in the U.S. armed forces or
5 in forces incorporated as part of the U.S. armed forces and who were discharged
6 under conditions other than dishonorable. The department shall provide assistance
7 to persons whose need for services is based upon homelessness, incarceration, or
8 other circumstances designated by the department by rule. The department shall
9 designate the assistance available under this section, which may include assistance
10 in receiving medical care, dental care, education, employment, and transitional
11 housing. The department may provide payments to facilitate the provision of
12 services under this section.

13 **(2)** The department may charge fees for transitional housing and for other
14 assistance provided under this section that the department designates. The
15 department shall promulgate rules establishing the fee schedule and the manner of
16 implementation of that schedule.

17 SUBCHAPTER V

18 VETERANS HOMES

19 **45.50 Veterans homes; management. (1)** (a) The department shall operate
20 the Wisconsin Veterans Home at King and employ a commandant for the home. The
21 department may employ a commandant for the Wisconsin Veterans Home at Union
22 Grove or the Wisconsin Veterans Home at Chippewa Falls. The department may
23 employ any personnel that are necessary for the proper management and operation
24 of veterans homes. In compliance with the compensation plan established pursuant
25 to s. 230.12 (3), a commandant may recommend to the director of personnel charges

1 for meals, living quarters, laundry, and other services furnished to employees and
2 members of the employees' family maintained at veterans homes. The department
3 shall provide complete personal maintenance and medical care, including programs
4 and facilities that promote comfort, recreation, well-being, or rehabilitation, to all
5 members of veterans homes.

****NOTE: Under current law, DVA is required to employ a commandant at the
Veterans Home at King and is authorized to employ one at the Veterans Home at Union
Grove. This bill permits DVA also to employ a commandant at the Veterans Home at
Chippewa Falls.

6 (b) All moneys received as reimbursement for services to veterans homes
7 employees or as payment for meals served to guests at veterans homes shall be
8 accumulated in an account named "employee maintenance credits" and shall be paid
9 into the general fund within one week after receipt and credited to the appropriation
10 under s. 20.485 (1) (gk).

11 (c) Veterans homes with a skilled nursing facility shall include a geriatric
12 evaluation, research, and education program. The program staff shall be funded
13 from the appropriations under s. 20.485 (1) (hm), (j), and (mj).

14 (2) (a) Subject to authorization under ss. 13.48 (10) and 20.924 (1), the
15 department may construct or renovate and operate residential, treatment, and
16 nursing care facilities, including a community-based residential facility, to be known
17 as the Wisconsin Veterans Home at Union Grove.

18 (b) Subject to authorization under ss. 13.48 (10) and 20.924 (1), the department
19 may develop, construct or renovate, and operate residential, treatment, and nursing
20 care facilities and programs for veterans in northwestern Wisconsin, on the property
21 of the Northern Wisconsin Center for the Developmentally Disabled in Chippewa
22 Falls to be known as the Wisconsin Veterans Home at Chippewa Falls. The programs
23 and facilities may include an assisted living facility, a skilled nursing facility, a

1 medical clinic, an adult day health care center, an activities center, and a veterans
2 assistance program.

3 **(3)** The department may acquire, by gift, purchase, or condemnation, lands
4 necessary for the purposes of the Wisconsin Veterans Home at Union Grove and the
5 Wisconsin Veterans Home at King. Title to the lands shall be taken in the name of
6 this state and shall be held by and for the uses and purposes of the homes. No
7 payment may be made out of the state treasury or otherwise for the land until the
8 title has been examined and approved by the attorney general. Every such deed of
9 conveyance shall be immediately recorded in the office of the proper register of deeds
10 and filed with the secretary of state.

****NOTE: Under current law, DVA is authorized to acquire by gift, purchase, or
condemnation lands necessary for the purposes of the veterans homes at King and Union
Grove. Should this bill extend that authorization for purposes of the Veterans Home at
Chippewa Falls?

11 **(4)** The department may use moneys appropriated under s. 20.485 (1) (h) to
12 purchase, erect, construct, or remodel buildings, to provide additions and
13 improvements, to provide equipment, materials, supplies, and services necessary for
14 the purposes of veterans homes, and for expenses that are necessary and incidental
15 to acquisition of property under s. 45.51 (10) and (11).

16 **(5)** The department may accept gifts, bequests, grants, or donations of money
17 or of property from private sources to be administered by the department for the
18 purposes of veterans homes. All moneys received shall be paid into the general fund
19 and appropriated as provided in s. 20.485 (1) (h), except that gifts or grants received
20 specifically for the purposes of the geriatric program at veterans homes are
21 appropriated as provided in s. 20.485 (1) (hm). The department may not apply to the
22 gifts and bequests fund interest on certificate of savings deposits for those members
23 who do not receive maximum monthly retained income. The department shall

1 establish for those persons upon their request individual accounts with savings and
2 interest applied as the member requests.

3 **(6)** (a) The department may enter into agreements for furnishing and charging
4 for water and sewer service from facilities constructed at and for veterans homes to
5 public and private properties lying in the immediate vicinity of veterans homes.

6 (b) Agreements under this section shall be drafted to hold harmless the
7 department, to require all expense to be paid by the applicant, and to be terminable
8 by the department when other water and sewer services become available to the
9 applicant.

10 **(7)** A commandant and employees designated by the commandant may
11 summarily arrest all persons within or upon the grounds of veterans homes who are
12 guilty of any offense against the laws of this state or the rules governing veterans
13 homes. For this purpose, a commandant and deputies have the power of constables.

14 **(8)** A fire department at a veterans home in response to emergency fire calls
15 may make runs and render fire fighting service beyond the confines of a veterans
16 home.

17 **(9)** The department may develop a program to provide stipends to individuals
18 to attend school and receive the necessary credentials to become employed at
19 veterans homes. If the department develops a stipend program under this
20 subsection, the department shall promulgate rules related to the program, including
21 the application process, eligibility criteria, stipend amount, repayment provisions,
22 and other provisions that the department determines are necessary to administer
23 the program.

24 **(10)** The department may establish a hospital at the veterans homes. All
25 hospitals established under this subsection may not have a total approved bed

1 capacity, as defined in s. 150.01 (4m), greater than 16 beds. The approved bed
2 capacity of a skilled nursing facility operated at a veterans home is reduced by one
3 bed for each approved bed at the hospital established under this subsection at that
4 home.

5 **45.51 Eligibility for membership. (1) GENERAL STATEMENT.** Within the
6 limitations of veterans homes, the department may admit to membership in veterans
7 homes persons who meet the qualifications set forth in this section.

8 **(2) ELIGIBILITY.** (a) The following persons are eligible for benefits under this
9 subchapter if they meet the applicable requirements of this subchapter:

10 1. A veteran.

11 2. A person who has served on active duty under honorable conditions in the
12 U.S. armed forces or in forces incorporated as part of the U.S. armed forces for 90
13 days or more and at least one day during a war period or under section 1 of executive
14 order 10957, dated August 10, 1961.

15 3. A spouse, surviving spouse, or parent of a person under subd. 1. or 2.

16 (b) A person under par. (a) 1. or 2. may be admitted to a veterans home if the
17 person meets all of the following conditions:

18 1. Is a resident of this state on the date of admission to a veterans home.

19 2. Is permanently incapacitated due to physical disability or age from any
20 substantially gainful occupation.

21 3. Has not been convicted of a felony or of a crime involving moral turpitude
22 or, if so, has produced sufficient evidence of subsequent good conduct and
23 reformation of character as to be satisfactory to the department.

24 4. Provides a complete financial statement containing information that the
25 department determines is necessary to evaluate the financial circumstances of the

1 person. The department may require a member of a veterans home to provide the
2 department with information necessary for the department to determine the
3 financial circumstances of the person. If a person fails to provide the additional
4 information, the department may discharge the person from the veterans home.

5 5. Has care needs that the veterans home is able to provide within the resources
6 allocated for the care of members of the veterans home, including chronic alcoholism,
7 drug addition, psychosis, or active tuberculosis.

8 **(3) ADMISSION PRIORITIES.** (a) Except in cases where there is an immediate need
9 for physical care or economic assistance, the department shall act on applications
10 based upon the date of receipt of the application by the veterans home. The
11 department may defer establishment of the priority date of the application to the
12 date that the veterans home is able to verify its ability to provide appropriate care
13 to the applicant or to assure that the appropriate care setting is available within the
14 home.

15 (b) Spouses, surviving spouses, and parents derive their eligibility from the
16 eligibility of the person under sub. (2) (a) 1. or 2. Surviving spouses and parents of
17 eligible persons under sub. (2) (a) 1. or 2. are eligible for admission only to a skilled
18 nursing facility at a veterans home.

19 (c) 1. The order of priority for admission to a veterans home shall be as follows:

20 a. Eligible persons under sub. (2) (a) 1. or 2. have 1st priority.

21 b. Spouses of eligible persons under sub. (2) (a) 1. or 2. have 2nd priority.

22 c. Surviving spouses of eligible persons under sub. (2) (a) 1. or 2. have 3rd
23 priority for admission.

24 d. Parents of eligible persons under sub. (2) (a) 1. or 2. have 4th priority for
25 admission.

1 2. The department may deviate from this sequence upon order of the board to
2 prevent the separation of a husband and wife.

3 **(4) ADDITIONAL ELIGIBILITY REQUIREMENTS OF A SPOUSE OF A VETERAN.** A spouse
4 of an eligible person under sub. (2) (a) 1. or 2. is eligible only if the spouse meets the
5 requirements of sub. (2) (b) 3. to 5. and if all of the following apply:

6 (a) The person under sub. (2) (a) 1. or 2. is a member, or if not a member is
7 institutionalized elsewhere because of physical or mental disability, and the spouse
8 had lived with the person for not less than 6 months immediately before making
9 application for membership.

10 (b) Separation from the spouse necessitated by reason of employment,
11 hospitalization, or because of a physical or mental disability of either spouse shall
12 not be taken to constitute an interruption of the 6-month period.

13 (c) A spouse of an eligible person under sub. (2) (a) 1. or 2. by virtue of a marriage
14 that was void when entered into but validated under s. 765.21 before applying for
15 admission shall, for the purpose of this subsection and sub. (6), be considered
16 married to the eligible person under sub. (2) (a) 1. or 2. from the date the marriage
17 was entered into.

18 **(5) ADDITIONAL ELIGIBILITY REQUIREMENTS OF A SURVIVING SPOUSE.** The surviving
19 spouse of a person under sub. (2) (a) 1. or 2. who was a resident of this state at the
20 time of the veteran's death is eligible if the surviving spouse meets the requirements
21 of sub. (2) (b) 3. to 5. and if the surviving spouse satisfies all of the following
22 conditions:

23 (a) 1. The surviving spouse satisfies any of the following conditions:

24 a. Was married to and living with the deceased person under sub. (2) (a) 1. or
25 2. not less than 6 months immediately prior to the death of the person.

1 b. Was married to the person under sub. (2) (a) 1. or 2. at the time the person
2 entered the service and who became a widow or widower by the death of the person
3 while in the service or as a result of physical disability of the person incurred during
4 the service.

5 c. The period during which the surviving spouse was married to and lived with
6 the deceased person under sub. (2) (a) 1. or 2. plus the period of widowhood or
7 widowerhood is 6 months or more.

8 d. Was married to and living with the person under sub. (2) (a) 1. or 2. less than
9 6 months and a child was born of the marriage.

10 (b) Has not remarried.

11 (c) Is 45 years of age or over on the date of application.

12 (d) Is physically disabled.

13 (e) Is unable adequately to care for himself or herself and lacks adequate means
14 of support.

15 (f) Has been a resident of this state for the 12 months immediately preceding
16 the date of application for membership.

17 **(6) ADDITIONAL ELIGIBILITY REQUIREMENTS OF PARENTS.** The parent of a person
18 under sub. (2) (a) 1. or 2. who was a resident of this state at the time of the person's
19 death or, the parent of a living person under sub. (2) (a) 1. or 2. who is eligible for
20 membership, is eligible if the parent meets the requirements of sub. (2) (b) 3. to 5.
21 and if the parent satisfies all of the following conditions:

22 (a) Has reached 60 years of age.

23 (b) Has been a resident of this state for the 12-months preceding the date of
24 application for membership.

1 (c) Is physically disabled, unable adequately to care for himself or herself, and
2 lacks adequate means of support.

3 **(7) MEMBER INCOME RETENTION AND PAYMENT.** (a) The board shall establish a pay
4 plan for compensation of members for services rendered to a veterans home under
5 its work therapy program.

6 (b) Members shall pay the amount due the state for care and maintenance of
7 the member within 30 days after the receipt of the veterans home's billing statement
8 by the member or by the member's personal representative. The department may
9 subject any bill not paid within 30 days after receipt of the billing statement to an
10 interest assessment of 1 percent per month or fraction of a month. If payment is not
11 made within 60 days after the receipt of the billing statement, the department may
12 discharge the member from the veterans home.

13 (c) Payment of amounts due the state for care and maintenance of a member
14 shall be made to the fullest extent possible from sources of income other than pension
15 or compensation paid by the U.S. department of veterans affairs.

16 (d) A member is not required to use income received from services rendered to
17 the veterans home under its work therapy program or from the sale of products or
18 services through the hobby shop as payment for the care or maintenance of the
19 member at the veterans home.

20 (e) The department shall supervise the operation of a veterans home exchange,
21 including the operation of the hobby shop for the sale of products made by all
22 members.

23 **(8) PERSONAL FUNDS OF MEMBER.** A member may, in writing, authorize a
24 veterans home to receive, hold, and account for his or her personal funds. Section
25 49.498 (8) applies to the funds of a member held by the veterans home under this

1 subsection. The department may transfer the personal funds of a member received
2 under this subsection to the Wisconsin veterans facilities members fund under s.
3 25.37. Upon request of the member, the department shall pay the member the
4 amount the member requests from his or her personal account.

5 **(9) MEDICAL ASSISTANCE PAYMENTS.** All moneys received under medical
6 assistance, as defined in s. 49.43 (8), for the care of members shall be transferred to
7 the appropriation under s. 20.485 (1) (gk).

8 **(10) CONVEYANCE OF PROPERTY; DESCENT.** (a) Except as otherwise provided in
9 this subsection, the application and admission of any applicant admitted under this
10 section shall constitute a valid and binding contract between a member and the
11 department. If a member dies leaving a relative that is entitled to an interest in the
12 property of the member under the rules of intestate succession or a will the existence
13 of which is made known to the commandant of the veterans home within 60 days of
14 the member's death, the member's property shall constitute a part of the member's
15 estate, except the commandant may distribute personal effects of nominal monetary
16 value of a deceased member who is not survived by a member spouse to surviving
17 relatives of the member who request the personal effects within a reasonable time
18 after the member's death.

19 (b) The department may manage, sell, lease, or transfer property passing to the
20 state pursuant to this section or conveyed to it by members, defend and prosecute all
21 actions concerning it, pay all just claims against it, and do all other things necessary
22 for the protection, preservation, and management of the property. All expenditures
23 necessary for the execution of functions under this paragraph or sub. (14) shall be
24 made from the appropriation in s. 20.485 (1) (h).

1 (c) A person who at the time of death is a member of a veterans home is a
2 resident of the county in which the veterans home is located for the probate of the
3 person's will, issuance of letters testamentary or other letters authorizing the
4 administration of the decedent's estate, and the administration of the estate.

5 **(11) DISPOSITION OF PROPERTY PASSING TO STATE.** If a member dies without a
6 relative who is entitled to an interest in the property of the member under the rules
7 of intestate succession and without leaving a will the existence of which is made
8 known to the commandant of the home within 60 days of the member's death, the
9 member's property shall be converted to cash, without administration. The
10 commandant of a veterans home shall submit that converted sum to the secretary
11 of administration to be paid into the appropriation under s. 20.485 (1) (h). The
12 amount paid to the secretary of administration is subject to refund within 6 years to
13 the estate of a member if it is subsequently discovered that the member left a will
14 or a relative that is entitled to an interest in the property of the member under the
15 rules of intestate succession or to any creditor of the member who establishes right
16 to the funds or property or any portion of the funds or property. The department of
17 administration, upon being satisfied that a claim out of the funds or property is legal
18 and valid, shall pay the claim out of the funds or property, except that payment of
19 claims for a member's funeral and burial expenses may not exceed a total of \$1,500
20 including any amount allowed by the United States for the member's funeral and
21 burial and the right for burial and interment provided in s. 45.61 (2).

22 **(12) POWERS OF COMMANDANT OVER PERSONAL FUNDS OF MEMBERS.** A commandant
23 may receive, disburse, and account for funds of members.

24 **(13) ADDITIONAL ELIGIBILITY REQUIREMENTS FOR SKILLED NURSING FACILITIES.** Any
25 person admitted to a skilled nursing facility at a veterans home shall meet the

1 eligibility requirements under ss. 49.45 and 49.46 and rules promulgated under
2 those sections during residence at the skilled nursing facility except if any of the
3 following apply:

4 (a) Persons with sufficient income and resources to meet the expenses of care
5 for one or more months may be admitted to the skilled nursing facility but shall apply
6 income and resources to costs to the extent required under ss. 49.45 and 49.46 and
7 rules promulgated under those sections.

8 (b) Persons who meet all the requirements of this section but whose degree of
9 physical disability does not meet the minimum requirements under ss. 49.45 and
10 49.46 and rules promulgated under those sections may be admitted to the skilled
11 nursing facility but shall apply income and resources to costs to the extent required
12 by ss. 49.45 and 49.46 and rules promulgated under those sections.

13 **(14)** ADDITIONAL ELIGIBILITY REQUIREMENT FOR OTHER CARE FACILITIES AT VETERANS
14 HOMES. An otherwise eligible person may be admitted to or remain in residency at
15 a community-based residential facility, as defined in s. 50.01 (1g) or a residential
16 care apartment complex, as defined in s. 50.01 (1d) at a veterans home only if the
17 person has sufficient income and resources, and applies the income and resources to
18 fully reimburse the department for the cost of providing care to the person.

19 SUBCHAPTER VI

20 FUNERALS, BURIALS, AND CEMETERIES

21 **45.60 Military funeral honors. (1) PROGRAM.** (a) The department shall
22 administer a program to coordinate the provision of military funeral honors to
23 deceased veterans.

24 (b) Military funeral honors may be provided by local units of member
25 organizations of the council on veterans programs, by local units of veterans

1 organizations certified by the department to provide military funeral honors, by
2 members of the Wisconsin national guard activated under s. 21.11 (3), or by staff of
3 the department.

****NOTE: Current law provides that local units of member organizations of the council on veterans programs, as well as members of the national guard, may provide military funeral honors. In practice, on occasion, DVA staff also provides those honors. Further, DVA has certified local units of some veterans organizations that are not members of the council on veterans programs to perform military funeral honors. To conform to current practice, this bill adds DVA staff and local units of certified nonmember organizations to the list of entities that may provide military funeral honors and permits DVA to reimburse those organizations for their service.

4 **(2) STIPENDS.** From the appropriation under s. 20.485 (2) (q), the department
5 shall reimburse a local unit of a member organization of the council on veterans
6 programs or a local unit of a veterans organization certified by the department to
7 provide military funeral honors for the costs of providing military funeral honors to
8 a deceased veteran. The reimbursement may not exceed \$50 for each funeral for
9 which military honors are provided.

10 **(3) TUITION VOUCHER.** (a) The department shall create a tuition voucher form
11 to be used by funeral directors under par. (b). The department shall distribute copies
12 of the tuition voucher form, plus an explanation of the form's use, to every operator
13 of a funeral establishment. The department may not charge a fee for the tuition
14 voucher form or for the distribution of the form.

15 (b) A funeral director may issue a tuition voucher in the amount of \$25 to an
16 individual who sounds "Taps" on a bugle, trumpet, or cornet during each funeral for
17 which military honors are held in this state for a deceased veteran and who is a
18 student in grades 6 to 12 or at an institution of higher education, as defined under
19 s. 895.515 (1) (b). The tuition voucher may be used at any time for the payment of
20 tuition and required program activity fees at a University of Wisconsin System
21 institution as provided under s. 36.27 (3r) or a technical college as provided under

1 s. 38.24 (6). The department shall encourage private institutions of higher education
2 to accept the vouchers. The vouchers are not transferable.

3 **45.61 Wisconsin veterans cemeteries. (1)** CONSTRUCTION AND OPERATION OF
4 CEMETERIES. Subject to authorization under ss. 13.48 (10) and 20.924 (1), the
5 department may construct and operate veterans cemeteries in central,
6 northwestern, and southeastern Wisconsin and may employ any personnel that are
7 necessary for the proper management of the cemeteries. The cemetery in central
8 Wisconsin is the Central Wisconsin Veterans Memorial Cemetery. The cemetery in
9 southeastern Wisconsin is the Southern Wisconsin Veterans Memorial Cemetery.
10 The cemetery in northwestern Wisconsin is the Northern Wisconsin Veterans
11 Memorial Cemetery. The department may acquire, by gift, purchase, or
12 condemnation, lands necessary for the purposes of the cemeteries. Title to the
13 properties shall be taken in the name of this state. Every deed of conveyance shall
14 be immediately recorded in the office of the proper register of deeds and thereafter
15 filed with the secretary of state. The department may accept for the state all gifts,
16 grants, and bequests for the purposes of maintenance, restoration, preservation, and
17 rehabilitation of the veterans cemeteries constructed under this subsection. All
18 cemeteries operated by the department are exempt from the requirements of ss.
19 157.061 to 157.70 and 440.90 to 440.95.

20 **(2) ELIGIBILITY.** The following persons are eligible for burial at a cemetery
21 constructed and operated under sub. (1):

22 (a) A person who died while on active duty or who was discharged or released
23 from active duty in the U.S. armed forces under honorable conditions and who was
24 a resident of this state at the time of his or her entry or reentry into active service
25 and his or her dependent child and surviving spouse.

1 (b) A person who was discharged or released from active duty in the U.S. armed
2 forces under honorable conditions and who was a resident of this state at the time
3 of his or her death and his or her dependent child and surviving spouse.

4 (c) The spouse or dependent child of a person who meets one of the following
5 conditions:

6 1. Is serving on active duty at the time of the spouse's or dependent child's death
7 if the person was a resident of this state at the time of his or her entry or reentry into
8 active service.

9 2. Was a resident of this state at the time of his or her entry or reentry into
10 active service and was discharged or released from active duty in the U.S. armed
11 forces under honorable conditions.

12 3. Was discharged or released from active duty in the U.S. armed forces under
13 honorable conditions if the person and spouse or dependent child were residents of
14 this state at the time of the spouse's or dependent child's death.

15 (d) A person who was a resident of this state at the time of his or her entry or
16 reentry into service in any national guard or a reserve component of the U.S. armed
17 forces or who was a resident of this state for at least 12 consecutive months
18 immediately preceding his or her death, and the person's spouse, surviving spouse,
19 and dependent children, if the person is eligible for burial in a national cemetery
20 under 38 USC 2402.

21 (e) A person who was discharged or released from active duty in the U.S. armed
22 forces under honorable conditions and who was a resident of this state for at least
23 12 consecutive months after entering or reentering service on active duty.

24 **(3) FEES AND COSTS.** The department may charge a fee for burials under this
25 section and may promulgate rules for the assessment of any fee. The cost of

1 preparing the grave and the erection of a marker for a person described under sub.
2 (2) (a), (b), (d), or (e) shall be paid from the appropriation under s. 20.485 (1) (gk).

3 **(4) APPLICATION.** Application for burial shall be made to the department. The
4 surviving spouse of the person described under sub. (2) (a), (b), (d), or (e), if that
5 person is interred at the Central Wisconsin Veterans Memorial Cemetery, shall have
6 the privilege of selecting a plot next to that person if available. The department shall
7 hold the plot for the surviving spouse for a period of one year from the date of granting
8 the privilege, but may extend the hold, on request, for additional one-year periods.

9 **(5) EXPENSES.** Expenses incident to the burial under this section shall be paid
10 from the estate of the decedent, except that if there is no estate or the estate is
11 insufficient, the expense of burial, or necessary part of the burial, shall be paid from
12 the appropriation under s. 20.485 (1) (gk), and the amount expended for those
13 expenses shall not exceed the amount established for funeral and burial expenses
14 under s. 49.785 (1) (b).

****NOTE: This bill specifies that DVA will hold a burial plot for the surviving spouse
of a person eligible for burial at the Central Wisconsin Cemetery for a year, with possible
extensions in one-year periods. Should this language be expanded to include the other
veterans cemeteries?

15 **45.62 Burial places compiled.** (1) The department may compile a record
16 of veteran's burial places located within the state that may, so far as practicable,
17 indicate all of the following information:

- 18 (a) The deceased veteran's name.
- 19 (b) The service in which the deceased veteran was engaged.
- 20 (c) The appropriate designation of the deceased veteran's armed forces unit.
- 21 (d) The deceased veteran's rank and period of service.
- 22 (e) The name and location of the cemetery or other place in which the deceased
23 veteran's body is interred.

1 (f) The location of the deceased veteran's grave in the cemetery or other place
2 of interment.

3 (g) The character of the headstone or other marker, if any, at the deceased
4 veteran's grave.

5 (2) The department may prepare blank forms for the transmission to the
6 department of the information required for the record under sub. (1). The
7 department may distribute the forms to county veterans service officers. A county
8 veterans service officer within whose county any cemetery or other burial place is
9 located in which deceased veteran's bodies are interred shall submit the facts
10 required for the record under sub. (1) to the department on the forms provided by the
11 department, if so requested by the department.

12 SUBCHAPTER VII

13 MEMORIALS

14 **45.70 Veterans memorials. (1) PERSIAN GULF MEMORIAL.** From the
15 appropriation under s. 20.485 (2) (d), the department shall provide funding to the
16 Wisconsin Vietnam Veterans Memorial Project, Inc., for the construction of a
17 memorial for the veterans of the Persian Gulf War. The memorial shall be
18 constructed at the veterans memorial site located at the Highground in Clark
19 County. The department may expend up to \$60,000 for the memorial for the veterans
20 of the Persian Gulf War.

21 (2) **CAMP RANDALL MEMORIAL.** (a) The board may approve, recommend, and veto
22 any proposed plans, modifications, and changes or policies with respect to
23 established state memorials, including the Camp Randall Memorial Park, Madison,
24 Wisconsin, as described in par. (c), and any future veterans state memorials, and
25 recommend the creation and establishment of veterans state memorials.

1 (b) No structures, other than memorials approved by the board, and no walks,
2 roads, or subterranean footings may be placed or erected upon Camp Randall
3 Memorial Park unless authorized by the legislature; nor shall the park be used for
4 any purpose other than a memorial park.

5 (c) Camp Randall Memorial Park, Madison, Wisconsin, is established and
6 described as follows: beginning on the west line of Randall Avenue 96.6 feet north
7 of the center line of Dayton Street extended; thence west at right angles to Randall
8 Avenue 370 feet; thence south parallel to Randall Avenue 722 feet; thence west at
9 right angles to Randall Avenue 235 feet; thence south parallel to Randall Avenue 205
10 feet to the north line of Monroe Street; thence north 50 degrees 14 minutes east along
11 the north line of Monroe Street approximately 780 feet to the west line of Randall
12 Avenue; thence north along the west line of Randall Avenue 429 feet to the place of
13 beginning.

14 **45.71 Catalog of memorials.** The department shall prepare a catalog of
15 memorials, describing each memorial and giving its location and condition. The
16 department shall periodically update that catalog.

17 **45.72 County and municipal memorials. (1)** In this section and s. 45.73,
18 “local unit of government” means a city, village, town, or county.

19 **(2)** Any local unit of government may by gift, purchase, contract, or
20 condemnation acquire property, real or personal, for the purpose of providing,
21 furnishing, constructing, erecting, repairing, maintaining, or conducting a suitable
22 memorial to the memory of former residents thereof who lost their lives in the
23 military or naval service of the state or of the United States, or to commemorate and
24 honor the deeds of persons, residents thereof, or of the state or United States, who
25 served the nation in any war, or other persons who rendered great state or national

1 service, or to the memory of any president of the United States, or for a combination
2 of any those purposes, which are declared to be public purposes.

3 (3) The local unit of government shall determine the character of the memorial,
4 and without limitation because of enumeration, the memorial may comprise a public
5 building, hospital, sanatorium, home for the aged or indigent, park, recreation
6 facility, community forest, or other suitable object having a public purpose.

7 (4) Any local unit of government may appropriate money and may levy a tax
8 to acquire, pay for, construct, erect, furnish, equip, operate, repair, maintain, or
9 reconstruct a suitable memorial for the purpose or purposes provided in this section.

10 (5) Any local unit of government may authorize the use of any public property
11 respectively of such city, village, town, or county as a site for a memorial, and any
12 county may authorize its public property to be so used by any city, village, or town
13 in the county.

14 (6) Any local unit of government may by ordinance or contract provide for the
15 management, control, or operation of any memorial. The local unit of government
16 may enter into a written lease, for a term not exceeding 25 years, with any duly
17 chartered and incorporated veterans organization established in the local unit of
18 government. The lease shall include the provisions for the amount of rental and such
19 conditions of public use as the local unit determines.

20 (7) Any local unit of government may contract with or make an appropriation,
21 or both, to any other local unit of government or to any nonprofit corporation without
22 capital stock organized expressly for any of the purposes of this section or to any duly
23 chartered and incorporated veterans organization established in the local unit of
24 government, and for the purpose of raising funds for memorial purposes or
25 contributions. The local unit of government may levy taxes upon the taxable

1 property located in the local unit of government, or borrow money and issue bonds
2 in the manner and under the regulations provided by ch. 67. The facilities of the
3 memorial shall be available to the residents of the local unit of government making
4 the appropriation to the extent that the governing body of the local unit of
5 government may require.

6 **45.73 Sites for veterans memorial halls. (1)** Any local unit of government
7 may donate to any organization specified in s. 70.11 (9) land upon which is to be
8 erected a memorial hall to contain the memorial tablet specified in s. 70.11 (9).

9 **(2)** The action of any local unit of government in granting veterans
10 organizations or any other civic, patriotic, educational, or historical society rooms
11 and space within public buildings for the establishment of memorial halls and
12 museums, and occupancy thereof by its members, is authorized and confirmed. The
13 local unit of government may permit the use and occupancy of the rooms and space
14 for such terms and subject to such conditions and provisions as the local unit of
15 government may impose. Any contract, lien, or agreement between the local unit of
16 government and any organization now in force shall continue in force according to
17 the terms of the contract, lien, or agreement.

18 **45.74 Memorial corporations organized under 1919 act. (1)** Any
19 commission or board of trustees that governs a corporation organized to construct a
20 memorial under s. 45.057 (5), statutes of 1919 to 1943 (created by chapter 598, laws
21 of 1919, and repealed by chapter 301, laws of 1945), shall have the following powers
22 in addition to those it now has:

23 (a) All powers vested in the members of the corporation by the articles of
24 incorporation or bylaws, including the power to amend the articles of incorporation.

1 (b) The powers set forth in s. 181.0302 and all other applicable provisions of ch.
2 181.

3 (c) The power to convey any property under its control to any municipality and
4 lease it back under terms agreed upon by the commission or board of trustees and
5 the municipality.

6 (d) The power to dissolve the corporation and dispose of the real and personal
7 property of the corporation in a manner that it deems will best serve the purposes
8 for which it was organized and the interests of the community.

9 (2) The commission or board of trustees shall have a membership composed of
10 5 residents of the city, village, or town in which the memorial is located, one
11 appointed by the common council, village board, or town board of the city, village, or
12 town, and 4 by the circuit judge of the county in which the memorial is located. The
13 commission or board may appoint 4 additional members who are residents of this
14 state. The terms of all members shall be 5 years. In order that terms of members
15 may expire at different times, not more than 2 members shall be appointed in any
16 one year in addition to appointments made to fill vacancies occurring by resignation
17 or death. Members shall hold office until their successors are appointed and qualify.

18 (3) Notwithstanding the repeal of s. 45.057, 1943 stats., by chapter 301, laws
19 of 1945, the continuing existence of all commissions, boards, and corporations
20 organized under s. 45.057 (5), statutes of 1919 to 1943, is affirmed, and the
21 continuing operation of such commissions, boards, and corporations is ratified as to
22 the past and authorized in the future.

23 **45.75 Memorials in populous counties. (1)** Any county having a population
24 of 500,000 or more may establish and maintain a memorial or memorials in the
25 county under s. 45.72 by agreement between the county board of the county and any

1 nonprofit private corporation without capital stock organized under the laws of this
2 state, except as provided in this section, expressly for any of the purposes of s. 45.72.

3 **(2)** The board of directors of the corporation shall be designated as the
4 “memorial board,” and its members shall be called “trustees.” The membership of
5 the memorial board may include special members, who need not be members of the
6 corporation.

7 **(3)** The memorial board shall consist of 15 members, of whom 8 may be special
8 members to be elected as provided in this section, and the remaining members shall
9 be elected from the membership of the corporation.

10 **(4)** Special members of the memorial board shall be elected by the county board
11 of such county and consist of the following:

12 (a) Four members from the county board.

13 (b) Four members elected from among the residents of the county.

14 **(5)** Terms of members of the memorial board shall be as follows:

15 (a) For special members:

16 1. Members elected from the county board shall be elected at the first meeting
17 of the county board following each county board general election and their terms
18 shall commence on that date. They shall hold office during their terms on the county
19 board and until their successors are elected and qualified.

20 2. Members elected from among the residents shall hold office for 4 years and
21 until their successors are elected, except that the first 4 such members shall be
22 chosen for 1, 2, 3, and 4 years, respectively.

23 3. Any vacancy in the special membership shall be filled by the county board
24 for the unexpired term, and until a successor is elected and qualified.

1 (b) For elected members from the corporate membership: the terms of the
2 trustees shall be for such numbers of years that those of an equal number, as nearly
3 as may be, shall expire in 2, 3, and 4 years, and successive terms of 4 years each
4 thereafter and until their successors are elected and qualified.

5 **(6)** The articles of incorporation of the corporation shall provide originally or
6 by amendment, in addition to other necessary provisions, and as permitted by this
7 section, for the classification of the members of the corporation, for the election of
8 trustees proportionately from and by those classifications, for the terms of the
9 members of the corporation and for the officers, their duties, and the terms thereof
10 to be elected from the membership.

11 **(7)** The war memorial may be constructed upon any land ceded before July 15,
12 1953, by this state to any municipality in this state notwithstanding any restrictions,
13 limitations, or conditions as to the nature of the use of any of the land contained in
14 the legislative act, granting the land to the municipality, and notwithstanding the
15 restrictions, limitations, or conditions incorporated in any subsequent conveyance
16 of the lands by the municipality.

17 **(8)** The war memorial may be constructed in any public park and the use of
18 those park lands as a location for a war memorial shall not be considered inconsistent
19 with the use of the same for park purposes. No war memorial shall be constructed
20 in a public park until the park commission, general manager appointed under s.
21 27.03 (2), or park board having jurisdiction of the park shall approve the
22 construction. The county board of any county may authorize the construction of a
23 war memorial at different intervals of time if the proposed memorial consists of more
24 than one building or structure and any county board subsequently elected shall carry
25 into effect any contract authorized by s. 45.72 entered into on behalf of the county

1 for the construction or maintenance of the war memorial. The construction,
2 maintenance, and operation of a war memorial in a county park shall be subject to
3 the jurisdiction of the county board and no part of those costs shall be charged against
4 the funds of the park commission, park system, or park board of the county.

5 SUBCHAPTER VIII

6 LOCAL RESPONSIBILITIES

7 **45.80 County veterans service officer. (1)** ELECTION OR APPOINTMENT. (a)
8 Except as provided under par. (b), the county board shall elect a county veterans
9 service officer who shall be a Wisconsin resident who served on active duty under
10 honorable conditions in the U.S. armed forces or in forces incorporated as part of the
11 U.S. armed forces and who meets at least one of the conditions listed in s. 45.01 (12)
12 (a) to (d) and at least one of the conditions listed in s. 45.02 (2).

13 (b) Except as provided under par. (c), the county board may appoint assistant
14 county veterans service officers who shall be Wisconsin residents who served on
15 active duty under honorable conditions in the U.S. armed forces or in forces
16 incorporated as part of the U.S. armed forces and who meet at least one of the
17 conditions listed in s. 45.01 (12) (a) to (d) and at least one of the conditions listed in
18 s. 45.02 (2).

19 (c) In counties with a county executive or county administrator, the county
20 executive or county administrator shall appoint and supervise a county veterans
21 service officer who shall have the qualifications prescribed under par. (a). The
22 appointment is subject to confirmation by the county board unless the county board,
23 by ordinance, elects to waive confirmation or unless the appointment is made under
24 a civil service system competitive examination procedure established under s. 59.52
25 (8) or ch. 63.

1 **(2) TERM.** A county veterans service officer elected under sub. (1) (a) shall serve
2 until the first Monday in January of the 2nd year subsequent to the year of his or her
3 election, and, if reelected, shall continue to serve unless removed under s. 17.10 (2).

4 **(3) SALARY.** The salary of the county veterans service officer shall be fixed by
5 the county board prior to or at the time of the service officer's election and annually
6 thereafter.

7 **(4) MILWAUKEE COUNTY.** In counties having a population of 500,000 or more the
8 officer shall be appointed subject to ss. 63.01 to 63.17.

9 **(5) DUTIES.** The county veterans service officer shall do all of the following:

10 (a) Advise persons living in the service officer's county who served in the U.S.
11 armed forces regarding any benefits to which they may be entitled or any complaint
12 or problem arising out of such service and render to them and their dependents all
13 possible assistance.

14 (b) Make such reports to the county board as the county board requires.

15 (c) Cooperate with federal and state agencies that serve or grant aids or
16 benefits to former military personnel and their dependents.

17 (d) Furnish information about veterans burial places within the county as
18 required by s. 45.62 (2).

19 (e) Perform the duties prescribed by law, including those duties under pars. (a)
20 to (d), separately and distinctly from any other county department.

21 **(6) PERMITTED ACTIVITIES.** The county veterans service officer may do any of the
22 following:

23 (a) Inform persons living in the service officer's county who are members of the
24 national guard or of a reserve unit of the U.S. armed forces or dependents of those
25 persons regarding potential benefits to which they may be or may become entitled

1 and regarding all necessary military points of contact and general deployment
2 information for activated and deployed members of the national guard or reserve
3 units of the U.S. armed forces.

4 (b) Cooperate with federal and state agencies that serve or grant aids or
5 benefits to members of the national guard or reserve units of the U.S. armed forces
6 and their dependents.

7 **(7) OFFICE SPACE AND ASSISTANTS.** (a) The county board shall provide the county
8 veterans service officer with office space, clerical assistance, and any other needs
9 that will enable the officer to perform the duties under sub. (5).

10 (b) Except as provided under par. (c), the county board may appoint assistant
11 county veterans service officers who shall be Wisconsin residents who served on
12 active duty under honorable conditions in the U.S. armed forces or in forces
13 incorporated as part of the U.S. armed forces for 2 consecutive years. An individual
14 who is discharged for reasons of hardship or a service-connected disability or
15 released due to a reduction in the U.S. armed forces or for the good of the service prior
16 to the completion of the required period of service is eligible for appointment to the
17 office, regardless of the actual time served.

18 (c) In any county with a county executive or county administrator, the county
19 veterans service officer may appoint assistant county veterans service officers who
20 shall have the qualifications prescribed under par. (b).

21 **(8) GRANTS TO COUNTIES AND TRIBES FOR IMPROVEMENT OF SERVICES.** (a) Each
22 county may annually apply to the department for a grant for the improvement of
23 service to former military personnel of the county through the county veterans
24 service office. A county may not allocate any portion of a grant for use by another
25 county department nor may the county reduce funding to a county veterans service

1 office based upon receipt of a grant. The county veterans service officer of any county
2 applying for the grant shall enter into an agreement with the department. The
3 agreement shall state the goals and objectives to be attained by the county veterans
4 service office during the remainder of the year covered by the grant application. The
5 department shall prepare the basic form of this agreement in consultation with the
6 county veterans service officers association and provide a copy and an explanation
7 of that agreement to each county veterans service officer. The department shall
8 develop reasonable budget and operating standards to assure improved services, but
9 full operating control of the county office shall be left to each county.

10 (b) The department shall award a grant annually to a county that meets the
11 standards developed under this subsection and employs a county veterans service
12 officer who, if chosen after August 9, 1989, is chosen from a list of candidates who
13 have taken a civil service examination for the position of county veterans service
14 officer developed and administered by the division of merit recruitment and selection
15 in the office of state employment relations, or is appointed under a civil service
16 competitive examination procedure under s. 59.52 (8) or ch. 63. The grant shall be
17 \$8,500 for a county with a population of less than 20,000, \$10,000 for a county with
18 a population of 20,000 to 45,499, \$11,500 for a county with a population of 45,500 to
19 74,999, and \$13,000 for a county with a population of 75,000 or more. The
20 department shall use the most recent Wisconsin official population estimates
21 prepared by the demographic services center when making grants under this
22 paragraph.

23 (c) Notwithstanding par. (b), an eligible county with a part-time county
24 veterans service officer shall be eligible for an annual grant not exceeding \$500.

1 (d) The department shall provide grants to the governing bodies of federally
2 recognized American Indian tribes and bands from the appropriation under s. 20.485
3 (2) (vz) if that governing body enters into an agreement with the department
4 regarding the creation, goals, and objectives of a tribal veterans service officer,
5 appoints a veteran to act as a tribal veterans service officer, and gives that veteran
6 duties similar to the duties described in sub. (5), except that the veteran shall report
7 to the governing body of the tribe or band. The department may make annual grants
8 of up to \$2,500 under this paragraph and shall promulgate rules to implement this
9 paragraph.

10 **(9) TRANSPORTATION SERVICES GRANTS TO COUNTIES.** (a) Annually, from the
11 appropriation under s. 20.485 (2) (s), the department shall award grants to counties
12 that are not served by transportation services provided by the Wisconsin department
13 of Disabled American Veterans to develop, maintain, and expand transportation
14 services for veterans. The grants may be used to support multicounty cooperative
15 transportation services.

16 (b) The department shall promulgate rules specifying the application
17 procedures and eligibility criteria for grants under this subsection.

18 (c) A county may not reduce funding to a county veterans service office based
19 upon receipt of a grant.

***NOTE: Under current law, this language provides that a county may not allocate any portion of a grant awarded for transportation services “for use by another county department” and “may not reduce funding to a county veterans service office based upon receipt of a grant.” The drafting committee considered the first phrase to be vague and eliminated it, concluding that retaining just the 2nd phrase was sufficient.

20 **(10) QUALIFICATIONS APPLICABILITY.** The qualifications necessary to be a county
21 veterans service officer or assistant county veterans service officer under subs. (1)
22 (a) and (7) (b) apply only to persons elected to serve as county veterans service officers

1 or assistant county veterans service officers on or after June 1, 1996, and who have
2 not served as county veterans service officers or assistant county veterans service
3 officers before June 1, 1996.

4 **45.81 County veterans service commission. (1)** There is created in each
5 county a county veterans service commission consisting of 3 residents of the county
6 who are veterans appointed for staggered 3-year terms by the county executive or
7 county board chairperson in a county that does not have a county executive.

8 **(2)** The commission shall be organized by the election of one of their number
9 as chairperson. The county executive or county board chairperson in a county that
10 does not have a county executive after the expiration of the terms of those first
11 appointed shall annually on or before the 2nd Monday in December appoint one
12 person as a member of the commission for the term of 3 years. The county executive
13 or county board chairperson shall require each member of the commission and the
14 county veterans service officer to execute to the county an individual surety bond,
15 with sufficient sureties to be approved by the county executive or county board
16 chairperson, each bond to be in an amount equal to the tax levied in the current year
17 for expenditure by the commission. Each bond shall be filed with the county clerk.

18 **(3) (a)** Except as provided under sub. (4), the commission may furnish aid to
19 any person described in s. 45.85 if the right of that person to aid is established to the
20 commission's satisfaction.

21 **(b)** The secretary of the commission shall maintain a list containing the name,
22 place of residence, and amount of aid furnished to each person under par. (a), which
23 shall be signed by the chairperson and secretary of the commission.

24 **(c)** The total disbursements made by the commission under this subsection may
25 not exceed the amount collected from the tax levied, except when specifically

1 authorized by the county board. The commission shall provide the county treasurer
2 with sufficient information to deliver the specified aid to the person entitled to that
3 aid.

4 (d) The commission may furnish aid in a different manner than by supplying
5 money. The commission may request the county treasurer to pay a purveyor of
6 services or commodities for the purchase of services or commodities, or the
7 commission may furnish supplies, as it considers appropriate.

8 (e) The commission shall make a detailed report to the county board annually
9 showing the amount expended under this subsection. The report may not include
10 any personal identifying information regarding the persons that received aid under
11 this subsection.

****NOTE: Under current law, a county veterans service commission (CVSO) is authorized to furnish aid to a needy veteran or specified family members. The commission secretary is required to provide a list of aid recipients and the amount of aid received to the county clerk, who then passes that information on to the county treasurer for disbursement of aid. The commission is required to make a detailed report to the county board showing the amount expended.

There seems to be reluctance on the part of CVSOs to make that list too widely available, due to privacy concerns of the needy veterans and their families. Therefore, this bill provides that the commission's list of aid recipients and amounts is to go directly to the county treasurer for disbursement of aid and that the report to the county board may not include any personal identifying information regarding aid recipients.

 ***NOTE: This provision relates to burial of indigent veterans at county expense.
 The bill retains current law which provides that the cost of interment is the county's
 responsibility, cannot exceed \$300, and is in addition to any federal burial allowance.
 However, committee member and CVSO Ken Brown has recommended alternative
 language for the full committee's consideration that would eliminate the specific dollar
 amount and instead provide that the cost of interment shall be "at a rate to be determined
 by the county."

16 **(2)** Before assuming the burial expense, the county veterans service officer
17 shall exercise due diligence in attempting to determine the financial condition
18 required by sub. (1). The county veterans service officer, in making the inquiry, may
19 use the facilities for investigation that are made available by the county board. The

****NOTE: Under current law, before assuming the burial expense, the CVSO must determine whether the veteran or family member has died with insufficient means to cover the expenses and report the results of that determination to the county clerk. In this bill, that report would be made to the “appropriate authorities designated by the county.”
