SUBJECT: Revenue Limits -- Declining Enrollment

The following memorandum discusses proposals to provide additional revenue limit authority for school districts with declining enrollment.

Current Law

Under revenue limits, the annual increase in a school district's per pupil revenue derived from general school aids, computer aid, and property taxes is restricted. Actual general aids, computer aid, and property tax revenues received in the prior school year are used to establish the base year amount in order to compute the allowable revenue increase for the current school year. A per pupil revenue limit increase, which is adjusted annually for inflation, is added to the base revenue per pupil for the current school year. In 2005-06, this per pupil increase was \$248.48. There are several adjustments that are made to the standard revenue limit calculation, such as the declining enrollment adjustment, carryover of unused revenue authority, and the transfer of service adjustment. These adjustments generally increase a district's limit, providing the district with more revenue authority within the calculated limit. A school district can also exceed its revenue limit by receiving voter approval at a referendum.

A three-year rolling average of a school district's pupil enrollment is used to determine the allowable revenue increase under the limit. Specifically, the number of pupils is based on the average of a school district's membership count taken on the third Friday in September for the current and two preceding school years. For example, for 2005-06 revenue limits, the average of the 2002, 2003, and 2004 September memberships was used to calculate the 2004-05 base year revenues per pupil. Then, the average of the 2003, 2004, and 2005 September memberships was used to determine the allowable revenue increase in 2005-06. School districts can also count 40% of the full-time equivalent (FTE) summer school enrollment in classes taught by licensed teachers

in the membership counts in each year of the three-year average.

Under the declining enrollment adjustment, if a school district's current year three-year rolling average pupil enrollment is less than the prior year three-year rolling average, the district receives a one-year nonrecurring adjustment to its revenue limit in a dollar amount equal to 75% of what the decline in the three-year rolling average memberships would have generated. In 2005-06, 265 districts were eligible for the declining enrollment adjustment, which provided those districts \$42.5 million in revenue limit authority. Attachment 1 shows the revenue limit for each school district in 2005-06, the declining enrollment adjustment received by the district if applicable, and the percent of the total revenue limit authority of the district represented by the declining enrollment adjustment.

Alternatives to Address Declining Enrollment

There are various modifications that could be made to revenue limits to provide additional revenue limit authority to declining enrollment districts. One alternative would be to modify the current law adjustment to provide additional revenue limit authority to those districts now eligible for the adjustment. One option would be to increase the adjustment from 75% to 100% of the allowable revenues that the decline would have generated. Had this option been in effect in 2005-06, districts currently eligible for the adjustment would have generated an additional \$14.1 million in revenue limit authority. This option would provide districts currently receiving assistance for declining enrollment additional revenue limit authority in the current one-year time frame to adjust their operations as a result of the decline.

Another option would be to restructure the current law adjustment to a multi-year adjustment. For example, in the first year of an enrollment decline, a district could receive 100% of the allowable revenues that the decline would have generated. In the year after the decline, the district could receive 50% of the allowable revenues that the initial enrollment decline would have generated (half of the first year adjustment). This option would provide districts with a slightly longer time frame in which to adjust their operations to address the enrollment decline. Compared to current law, had this option applied beginning in 2005-06, eligible districts would have generated an additional \$14.1 million in revenue limit authority in 2005-06 and additional \$28.3 million in revenue limit authority in 2006-07.

Some would argue that the current three-year rolling average does not accurately reflect the marginal cost associated with losing a student, and that, while the current 75% declining enrollment adjustment provides some temporary assistance each year, it is not enough of an adjustment to help districts in decline. Another option that has been proposed is to use a longer time frame, such as five years, for the calculation of revenue limits. A five-year rolling average would generally further lessen the impact on school district budgeting of relatively large annual changes in enrollment and allow school districts even more time to plan and react to changing enrollments.

Had a five-year rolling average been used for the calculation of revenue limits in 2005-06, an

additional \$12.1 million in revenue limit authority would have been generated statewide. A total of 271 districts would have had a higher revenue limit, with a total of \$22.3 million in additional revenue limit authority generated by those districts. A total of 153 districts would have had a lower revenue limit, with a total revenue limit reduction of \$10.2 million for those districts. Two districts would have had an unchanged limit. Attachment 2 shows the revenue limit calculation for each district using both a three-year and a five-year rolling average, as well as the change under the five-year calculation as compared to the three-year calculation.

The proposal could structured to ensure that no district would have their revenue limit reduced compared to current law. For example, in the 2005-07 biennial budget, the Governor recommended a provision under which a school district's revenue limit would be the greater of the limit calculated using the three-year or the five-year rolling average. However, this approach would add another set of calculations to a system that is sometimes criticized for its complexity.

While using a five-year rolling average for the revenue limit calculation would provide additional revenue limit authority to some districts, it does not necessarily target the additional authority to districts now eligible for the declining enrollment adjustment. Had the five-year rolling average been used in 2005-06, of the 271 districts that would have had a higher limit using the five-year average, 197 were eligible for the current law declining enrollment adjustment, while 74 were not. Of the 153 districts that would have had a higher limit using the three-year average, 66 were eligible for the current law declining enrollment adjustment, while 87 were not.

One can argue that the current law declining enrollment adjustment does not take into account the severity of the decline in a district's enrollment over time. Because the adjustment is nonrecurring, it does not provide a permanent increase in base revenues for districts experiencing rapid enrollment decline. Also, the adjustment is calculated the same for districts with relatively small declines as it is for districts with larger declines, even though districts with larger declines would likely have to react differently to their circumstances than would a district with a smaller decline.

One option to address the concerns of districts with relatively large declines in enrollment has been proposed by the Department of Public Instruction in the agency's 2007-09 biennial budget request. Under the DPI proposal for a base level revenue limit adjustment, if a district's revenue limit in the current year, after consideration of the per pupil adjustment and low-revenue ceiling, but prior to any other adjustments, is less than the district's base revenue from the prior year, the district's initial revenue limit would be set equal to the prior year's base revenue.

For most districts, the per pupil adjustment and the low-revenue ceiling result in an initial current year limit higher than the prior year's base revenue. Some districts, however, are experiencing such a relatively large decrease in enrollment (generally a 3% or greater decline in the three-year averages) that their initial current year limit is less than the prior year's base revenue amount. In 2005-06, 48 districts had an initial 2005-06 revenue limit that was lower than their 2004-05 base revenue. In total, the difference between these districts' 2004-05 base revenue and

2005-06 initial revenue limit was \$2.3 million. Attachment 3 lists those 48 districts and the amount of the base level revenue limit adjustment that would have applied in 2005-06.
