Dear Secretary Schooff, Senator Miller and Representative Pocan:

Pursuant to § 977.085, Stats, the Office of the State Public Defender (SPD) is submitting its fourth quarter report on the 2009-2010 private bar appropriation [§ 20.550(1)(d)].

Between July 1, 2009 and June 30, 2010, the SPD appointed counsel in 130,709 cases, including 53,579 that were assigned to private bar attorneys on a rotational or contract basis.

The 2009-2011 The biennial shortfall is currently projected to range between \$9.2 million and \$9.5 million, which would result in the appropriation likely being depleted in February 2011 if supplemental funding is not provided. The Department of Administration's approval of our transferring remaining FY10 staff salary and fringe benefit balances of \$882,145 did provide approximately two additional weeks of funding. We will continue to work with staff in the State Budget Office to identify additional ways to address the remaining shortfall to avoid ceasing payments to private bar attorneys from February to July.

State Public Defender collections are received in five categories: SPD initiated, DOA contract collections, juvenile recoupment by counties, commitment recoupment by counties and court ordered payments. Following is a summary of the collections received, by category, during fiscal year 2009-2010. In that period, the agency referred 70,857 client

accounts valued at \$22,686,087 to the DOA-contracted collection agency. In return, the SPD received a total of \$243,082 (collected from clients) from the collection agency during the same period.
