

General Notes on Wisconsin Instate Active Physicians:

- ✓ 19% of MDs Graduated from University of Wisconsin
- ✓ 16% of MDs Graduated from Medical College of Wisconsin
- ✓ 31% of MDs practice in Primary Care specialties
- ✓ 28% of MDs practice in Rural Areas
- ✓ 5% of Active Physicians are Osteopathic Physicians
- ✓ 57% of DOs practice in Primary Care specialties
- ✓ 38% of DOs practice in Rural Areas



Based upon the 2007 Census, the current number of Primary Care Physicians within the county was subtracted from the HRSA Requirement of 95/100,000 population to determine PC Need by county.

- Greater than 31 PC Physicians Needed





(551 Total Graduates)


- ✓ 107 (19%) are within 45 miles

□ County Boundaries


Graduates Practicing In Each State



Each symbol may represent one or more graduates




HRSA's Physician Requirements Model (PRM)

- PRM is a utilization-based approach created by HRSA in 2006 to help estimate physician requirements (using the 2000 Census and AMA masterfile)
- Physician ratios for 18 medical specialties are projected using current use patterns and expected trends in population, insurance coverage (prior to 2010 healthcare reform) and patterns of care delivery
- NCAHD used these ratios with updated census estimates (2006) and our 2008-2009 licensure data to better reflect current needs/surpluses due to mal-distribution of physician workforce

Primary Care includes general and family practice, general internal medicine, and pediatrics. Medical specialties includes cardiology and other internal medicine subspecialties. Surgery includes general surgery, obstetrics/gynecology, ophthalmology, orthopedic surgery, otolaryngology, urology and other surgical specialties. Other Care includes anesthesiology, emergency medicine, pathology, psychiatry, radiology, and other specialties.
