¹ The UW System Board of Regents and the Wisconsin technical college district boards may grant remissions to certain other students. These remissions are not listed as no funding is appropriated to support them.

² Wisconsin has made a payment to Minnesota under the agreement in each year beginning in 2001-02. Tuition in excess of the Wisconsin resident rate received by UW System institutions under the agreement is deposited into the general fund. In 2008-09, the most recent year for which data is available, \$8.9 million in excess tuition payments was collected and deposited in the general fund. The net effect of the program on the general fund (payments made to Minnesota less excess tuition payments) was \$2.3 million in that year.

³ Funded with \$488,700 PR tribal gaming revenues and \$250,000 SEG transferred from the critical access hospitals assessment fund.

⁴ The UW Board of Regents and the Wisconsin technical college district boards are required to provide a full remission of tuition and fees to eligible veterans and certain dependents. Under 2007 Act 20, an appropriation was created to partially reimburse the Board of Regents and each district board for these remissions. In past years, the Board of Regents and each district board has been reimbursed for between 20 and 25% of remissions. Under 2009 Act 28, the appropriation language was modified to allow payments to be made to veterans and dependents receiving benefits under the federal Post-9/11 G.I. Bill who would have received greater cash benefits under the federal Montgomery G.I. Bill.

⁵ According to UW System Administration, these funds are used for need-based grants on campuses that do not participate in the Perkins loan program.

⁶ The Talent Incentive Grant Program is funded with \$4,458,800 GPR and an estimated \$1,400,000 in federal matching funds.

⁷ Funded with \$6,400,000 GPR and \$1,900,000 PR transferred from the UW System's auxiliary appropriation.

⁸ Funding provided in the 2010-11 fiscal year will lapse to the general fund.
