<u>Scope</u>

The Committee is directed to study:

- Magnitude and areas of volunteer shortages
- Whether training and continuing education requirements contribute to the shortage
- Relationships between full-time and volunteer emergency response departments
- Whether the creation of organizations, particularly in rural areas, may help address the shortage



Terminology

- Volunteer
 - Composed of individuals who generally receive no compensation and donate services for civic or humanitarian reasons
- Career
 - Composed solely of paid firefighters and EMS personnel
- Combination



Terminology

Volunteers may receive a "nominal fee"

- Up to 20% of typical wages
- May be on a per-call basis
- Reasonable benefits are allowed insurance plans, pension plans, length of service awards
- Reimbursement for expenses is allowed meals and training tuition

Authorization to Provide EMS

- The following may provide EMS:
 - County, city, or village
 - Fire or police department
 - Hospital
 - Private ambulance provider
- Towns must provide, unless privately provided
- May only operate under an EMS plan approved by DHS







Recent Legislation

- 2015 Wis. Acts 25 and 83 Out-of-State EMS Licensees
- 2015 Wis. Act 113 EMS Staffing Requirements



Out-of-State EMS Licensees

Ambulance service providers, EMTs, and first responders licensed in another state may provide:

- Incidental service of 10 or fewer patient transports per year that originate and terminate in WI
- Any requested mutual aid if the transports originate from the home state

EMS Staffing Requirements

Reduced EMS staffing requirements apply to certain rural areas if:

- The primary service area has only municipalities with a population of less than 10,000
- The primary service area has municipalities with a population between 10,000 and 20,000 in the primary service area <u>and</u> DHS has granted a waiver

Aspects of Rural Areas in Wisconsin




U.S. Census 2010

- Wisconsin population 5,686,986

- 29.8% rural (1,697,348 residents)
- 96.5% of Wisconsin's land area identified as rural




2010 Census: Wisconsin Profile








This maps was created by overlaying several semi-transparent rural classification schemes, along with a map of Wisconsin's housing density in 2000.










Wisconsin Emergency Medical Service Providers





NHTSA EMS Workforce Assessment

- No quantitative data indicating a national shortage of EMTs or paramedics
- But interviews in the study consistently reported shortages in rural areas
- Data likely underestimates workforce demand, because labor statistics do not include volunteers
