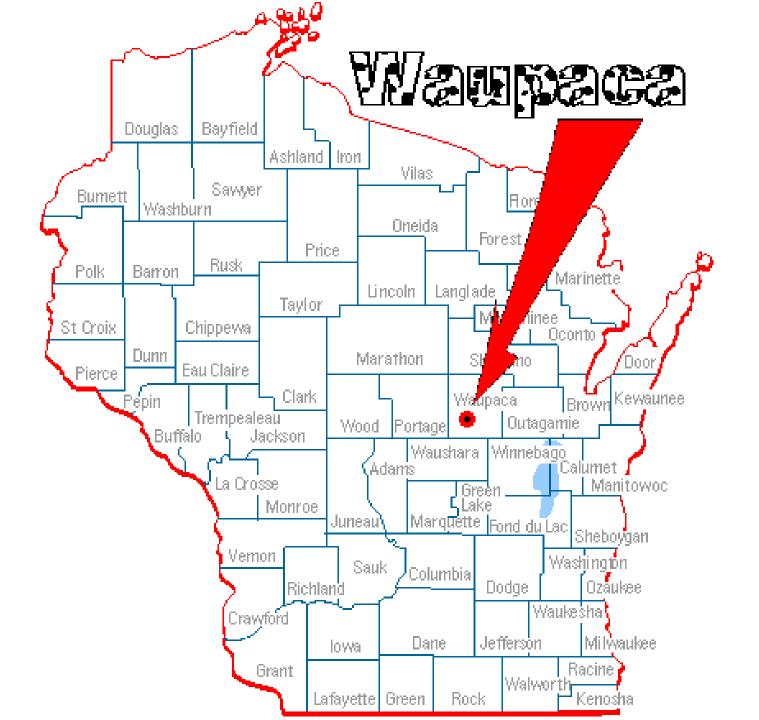




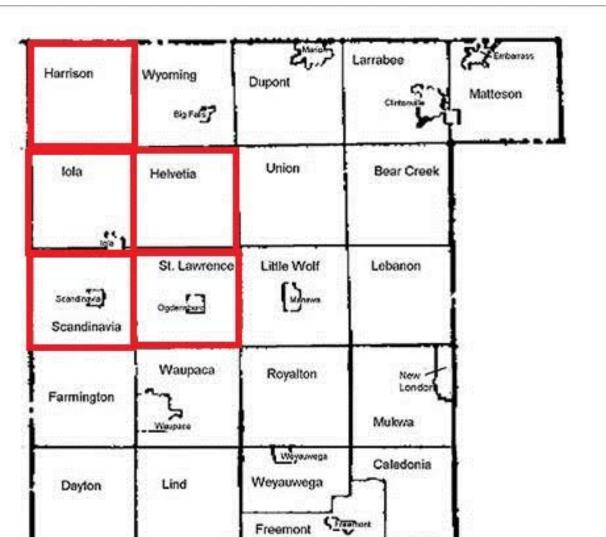
Jim Aanstad – Chief Iola Fire and Ambulance



- 32 Years on the department
- 12 years as an EMT Basic
- 2015 Became Asst. Chief/Ambulance
- 2015 Went back to school and got my EMT Basic training from Midstate Technical College (Wisconsin Rapids)
- 2016 became Chief of the department
- Work full time for Pierce Manufacturing

- We serve 7 Municipalities for EMS in Waupaca county
- Population base of 5500
- Serve an area of approximately 200 square miles
- Rural EMS





- We are owned and operated by the 7 Municipalities
- Non Profit 501(c)(3)
- Our Service is Licensed at an AEMT Level
- We currently have 28 EMT's 20 which are AEMT's
 - 16 of which take 95% of the call time
- 2 Ambulances
- Staffed with 1 crew of 2 at the AEMT level 24/7
- On Call schedule 12 hr. shifts or 6 hr. shifts. We keep things very flexible to accommodate our staff



Iola Fire and Ambulance

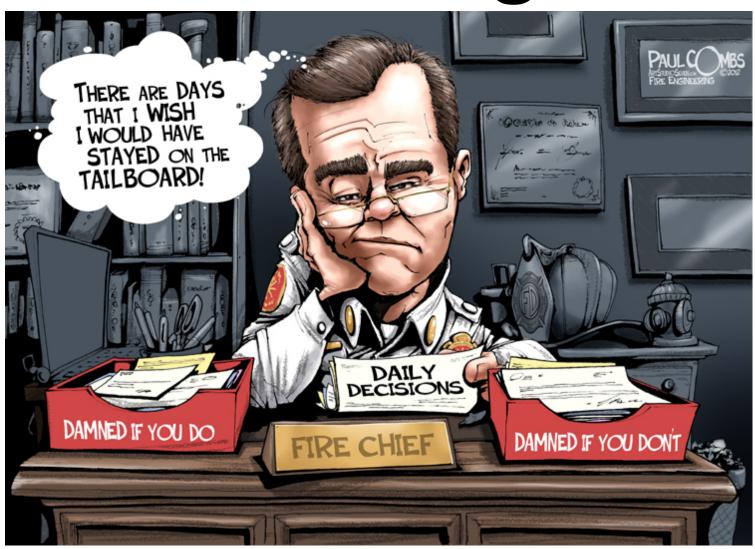


Run volume continues to increase

My Personal Experience with the EMT Basic

National Registry Testing Scores

• 2014 – 53% first time pass rate

- 2015 63% First time pass rate
- 2015 67% national first time pass rate

- 2015 79% third time pass rate
- 2015 78% national third time pass rate

National Registry Testing (Potential Strategies or Solutions)

- Consider replacing the National Registry Test
 - Wisconsin should develop its own test
- Alternative testing methods
 - Paper testing
 - Verbal testing
- Alter the curriculum to the EMT Basic class to meet the test
 - Teach the students how to take the test
 - But still teach the critical skills they will need in the field

Potential Strategies and Solutions to EMS Staffing in the Rural communities

- Give property or income tax breaks for someone who volunteers for a volunteer Fire or EMS dept.
- Business tax incentive for allowing employees to leave during working hours
- Make volunteers WRS (Wisconsin Retirement system) eligible
- College loan forgiveness for someone who volunteers for a volunteer Fire or EMS department.

Potential Strategies and Solutions to EMS Staffing in the Rural communities

State funding for EMS basic training and refresher classes

- Increased flexibility
 - More local control for EMS staffing decisions so that the level of service can adjust to staffing availability, currently if you are at a certain level of EMS, you can't adjust to a different level to prevent staff shortages.
